## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the transfer of certain state property from the Texas
- 3 Department of Criminal Justice to the City of Winnsboro.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. (a) Not later than October 31, 2007, the Texas
- 6 Department of Criminal Justice shall transfer to the City of
- 7 Winnsboro, for consideration to which the parties mutually agree,
- 8 the real property described by Subsection (d) of this section.
- 9 (b) Consideration for the transfer authorized by Subsection
- 10 (a) of this section may be in the form of an agreement between the
- 11 parties that requires the City of Winnsboro to use the property for
- 12 a purpose that benefits the public interest of the state. If the
- 13 consideration for the transfer is in the form of an agreement
- 14 described by this subsection:
- 15 (1) the City of Winnsboro may use the property
- 16 transferred under this Act only for a purpose that benefits the
- 17 public interest of the state; and
- 18 (2) ownership of the property automatically reverts to
- 19 the Texas Department of Criminal Justice if the City of Winnsboro no
- 20 longer uses the property for a purpose that benefits the public
- 21 interest of the state.
- (c) The Texas Department of Criminal Justice shall transfer
- 23 the property by an appropriate instrument of transfer. If the
- 24 consideration for the transfer is in the form of an agreement

- 1 described by Subsection (b) of this section, the instrument of
- 2 transfer must include a provision that:
- 3 (1) requires the City of Winnsboro to use the property
- 4 for a purpose that benefits the public interest of the state; and
- 5 (2) indicates that ownership of the property
- 6 automatically reverts to the Texas Department of Criminal Justice
- 7 if the City of Winnsboro no longer uses the property for a purpose
- 8 that benefits the public interest of the state.
- 9 (d) The real property to which Subsection (a) of this
- 10 section refers is described as follows:
- 11 Two parcels of land adjacent to the Winnsboro Municipal
- 12 Airport, located east of the improvements to the Johnston Unit and
- 13 east of Farm-to-Market Road 3530, consisting of two parcels, the
- 14 first of which comprises 2.30 acres, the second of which comprises
- 15 22.80 acres, totaling 25.10 acres out of the 365 acres in the
- 16 Johnston Unit.
- 17 SECTION 2. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2007.
