H.B. No. 3767

A BILL TO BE ENTITLED

AN ACT

relating to state fiscal matters.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Article 103.002, Code of Criminal Procedure, is amended to read as follows:

Art. 103.002. CERTAIN COSTS BARRED. (a) An officer may not impose a cost for a service not performed or for a service for which a cost is not expressly provided by law.

(b) If a person has paid a cost for a service that is not expressly provided by law, the money paid for the cost must first be applied to any unpaid statutory court costs that the person owes, then to other unpaid costs, fees, and fines imposed in the person's case that the person owes. Any remaining money must be refunded to the person making the payment. If the money cannot be refunded to the person making the payment, it must be remitted to the comptroller in accordance with Chapter 133, Local Government Code, for deposit in the general revenue fund.

SECTION 2. Chapter 103, Code of Criminal Procedure, is amended by adding Article 103.0021 to read as follows:

Art. 103.0021. ALLOCATION OF PARTIAL PAYMENTS. If the payment tendered by a person for court costs, fees, and fines in the person's criminal case is not adequate to cover the total amount of all obligations due, the payment shall be allocated to state court costs first and the remainder applied to other costs, fees, and

1 finest due in the case.

2 SECTION 3. Article 103.0031(e), Code of Criminal Procedure,
3 is amended to read as follows:

4 (e) If a county or municipality has entered into a contract
5 under Subsection (a) and a person pays an amount that is less than
6 the aggregate total to be collected under Subsections (a) and (b),
7 ~~[the allocation to the comptroller, the county or municipality,~~
8 ~~and]~~ the private attorney or vendor shall receive 30 percent of the
9 aggregate amount collected, not to exceed the amount added as the
10 collection fee, and the remainder of the amount collected shall be
11 allocated in accordance with Article 103.0021 ~~[be reduced~~
12 ~~proportionately]~~.

13 SECTION 4. Section 43.001(b), Education Code, as amended by
14 Chapters 201 and 328, Acts of the 78th Legislature, Regular
15 Session, 2003, is reenacted and amended to read as follows:

16 (b) The available school fund, which shall be apportioned
17 annually to each county according to its scholastic population,
18 consists of:

19 (1) the distributions to the fund from the permanent
20 school fund as provided by Section 5(a), Article VII, Texas
21 Constitution;

22 (2) ~~[one-fourth of all revenue derived from all state~~
23 ~~occupation taxes, exclusive of delinquencies and cost of~~
24 ~~collection,~~

25 ~~[(3)]~~ one-fourth of revenue derived from state
26 gasoline and special fuels excise taxes as provided by law; and

27 (3) ~~[(4)]~~ all other appropriations to the available

1 school fund made by the legislature for public school purposes.

2 SECTION 5. Section 43.002(a), Education Code, is amended to
3 read as follows:

4 (a) On the first working day of each month in a state fiscal
5 year, the agency [~~comptroller~~] shall transfer from the permanent
6 school fund to the available school fund an amount equal to
7 one-twelfth of the annual distribution from the permanent school
8 fund to the available school fund as provided by Section 5(a),
9 Article VII, Texas Constitution, for the fiscal year.

10 SECTION 6. Section 57.48(k)(1), Education Code, is amended
11 to read as follows:

12 (1) "Compensation" means base salary or wages,
13 longevity pay, hazardous duty pay, benefit replacement pay, a
14 retirement annuity, or an emolument provided in lieu of base salary
15 or wages.

16 SECTION 7. Section 63.202, Education Code, is amended by
17 amending Subsection (b) and adding Subsection (h) to read as
18 follows:

19 (b) Except as provided by Subsections (c), [and] (d), and
20 (h), money in the fund established under this subchapter may not be
21 used for any purpose.

22 (h) Expenses of managing and administering the assets of the
23 fund shall be paid from the fund.

24 SECTION 8. Section 63.302, Education Code, is amended by
25 amending Subsection (b) and adding Subsection (h) to read as
26 follows:

27 (b) Except as provided by Subsections (c), [and] (e), and

1 (h), money in the fund established under this subchapter may not be
2 used for any purpose.

3 (h) Expenses of managing and administering the assets of the
4 fund shall be paid from the fund.

5 SECTION 9. Sections 231.007(c) and (d), Family Code, are
6 amended to read as follows:

7 (c) The Title IV-D agency is the sole assignee of ~~[all]~~
8 payments, including payments of compensation, by the state to a
9 person indebted to the state under Subsection (a) if the
10 comptroller is not responsible for issuing warrants or initiating
11 electronic funds transfers to make those payments.

12 (d) On request of the Title IV-D agency, [+
13 ~~[(1) the comptroller shall make payable and deliver to~~
14 ~~the agency any payments for which the agency is the assignee under~~
15 ~~Subsection (c), if the comptroller is responsible for issuing~~
16 ~~warrants or initiating electronic funds transfers to make those~~
17 ~~payments, and~~

18 ~~[(2)]~~ a state agency shall make payable and deliver to
19 the Title IV-D agency any payments for which the Title IV-D agency
20 is the assignee under Subsection (c) ~~[if the comptroller is not~~
21 ~~responsible for issuing warrants or initiating electronic funds~~
22 ~~transfers to make those payments]~~.

23 SECTION 10. Sections 25.0015(b) and (c), Government Code,
24 are amended to read as follows:

25 (b) For a county that participates under Section 51.702(f)
26 under a resolution adopted and filed with the comptroller before
27 September 1, 2003, the amount shall be paid to the county's salary

1 fund in equal quarterly [~~monthly~~] installments, and of each \$35,000
2 paid a county, \$30,000 shall be paid from funds appropriated from
3 the judicial fund, and \$5,000 shall be paid from funds appropriated
4 from the general revenue fund.

5 (c) For a county that participates under Section 51.702(f)
6 under a resolution adopted or filed with the comptroller on or after
7 September 1, 2003, the amount shall be paid to the county's salary
8 fund in equal quarterly [~~monthly~~] installments from funds
9 appropriated from the judicial fund.

10 SECTION 11. Section 25.00211(b), Government Code, is
11 amended to read as follows:

12 (b) The amount shall be paid to the county treasury for
13 deposit in the contributions fund created under Section 25.00213 in
14 equal quarterly [~~monthly~~] installments from funds appropriated
15 from the judicial fund.

16 SECTION 12. Section 26.007(b), Government Code, is amended
17 to read as follows:

18 (b) The amount shall be paid to the county's salary fund in
19 equal quarterly [~~monthly~~] installments from funds appropriated
20 from the judicial fund.

21 SECTION 13. Section 74.061(d), Government Code, is amended
22 to read as follows:

23 (d) For services actually performed while assigned under
24 this chapter, a [~~retired or~~] former judge or justice shall receive
25 from county funds and money appropriated by the legislature the
26 same amount of salary, compensation, and expenses that the regular
27 judge is entitled to receive from the county and from the state for

1 those services. The presiding judge of the administrative region
2 shall certify to the county and the state the services rendered
3 under this chapter by a ~~[retired or]~~ former judge or justice and the
4 share to be paid by the state. The amount certified by the
5 presiding judge as the state's share shall be paid from an item in
6 the Judiciary Section, Comptroller's ~~[Judicial~~
7 ~~Section--Comptroller's]~~ Department of the General Appropriations
8 Act for the payment of salaries of district and criminal district
9 judges.

10 SECTION 14. Section 403.016(b), Government Code, is amended
11 to read as follows:

12 (b) The comptroller shall use the electronic funds transfer
13 system to pay an employee's net state salary and travel expense
14 reimbursements unless:

15 (1) the employee does not hold a classified position
16 under the state's position classification plan and the employee's
17 ~~[gross state]~~ salary is less than the minimum ~~[gross state]~~ salary
18 of [for a position classified to] group 8[~~7, step 1~~] of Salary
19 Schedule A of the General Appropriations Act ~~[state position~~
20 ~~classification plan]~~; or

21 (2) the employee holds a classified position under the
22 state's position classification plan and the position is allocated
23 to a group with a minimum salary of less than the minimum salary of
24 [that is classified below] group 8 of Salary Schedule A of the
25 General Appropriations Act.

26 SECTION 15. Section 403.055(1)(1), Government Code, is
27 amended to read as follows:

1 (1) "Compensation" means base salary or wages,
2 longevity pay, hazardous duty pay, benefit replacement pay, a
3 retirement annuity, or an emolument provided in lieu of base salary
4 or wages.

5 SECTION 16. Section 403.0551(d), Government Code, is
6 amended to read as follows:

7 (d) This section does not authorize the comptroller to
8 deduct the amount of a state employee's indebtedness to a state
9 agency from any amount of compensation owed by the agency to the
10 employee, the employee's successor, or the assignee of the employee
11 or successor. In this subsection: [τ]

12 (1) "compensation[τ]" has the meaning assigned by
13 Section 403.055; and

14 (2) "indebtedness," "state agency," "state employee,"
15 and "successor" have the meanings assigned by Section 666.001.

16 SECTION 17. Sections 403.071(g) and (h), Government Code,
17 are amended to read as follows:

18 (g) Notwithstanding Subsection (a), the comptroller [~~and a~~
19 ~~state agency~~] may [~~contract in writing for the comptroller to~~]
20 audit claims presented by a [~~the~~] state agency after the
21 comptroller prepares warrants or uses the electronic funds transfer
22 system to pay the claims. The [~~If the comptroller and a state~~
23 ~~agency execute a contract, the~~] comptroller may determine [~~decide~~]
24 the types of claims that will be audited after payment.

25 (h) [~~This subsection applies if the comptroller and a state~~
26 ~~agency have contracted in accordance with Subsection (g).~~] The
27 comptroller shall audit claims after payment under Subsection (g)

1 in the same manner [~~way~~] that the comptroller audits claims before
2 payment under Subsection (a). The comptroller may establish
3 requirements and adopt rules concerning the time that a state
4 agency must retain documentation in its files to enable a
5 postpayment audit. If a postpayment audit by the comptroller shows
6 that a claim presented by a state agency was invalid, the
7 comptroller may:

8 (1) implement procedures to ensure that similar
9 invalid claims from the state agency are not paid in the future;

10 (2) report to the governor, the lieutenant governor,
11 the speaker of the house of representatives, the state auditor, and
12 the Legislative Budget Board the results of the audit;

13 (3) require the state agency to obtain a refund of the
14 monies from the payee; and

15 (4) [~~cancel the contract with the state agency; and~~

16 [~~5~~] reduce the state agency's remaining
17 appropriations by the amount of the claim.

18 SECTION 18. Section 404.024, Government Code, is amended by
19 amending Subsections (b) and (l) and adding Subsections (m) and (n)
20 to read as follows:

21 (b) State funds not deposited in state depositories shall be
22 invested by the comptroller in:

23 (1) direct security repurchase agreements;

24 (2) reverse security repurchase agreements;

25 (3) direct obligations of or obligations the principal
26 and interest of which are guaranteed by the United States;

27 (4) direct obligations of or obligations guaranteed by

1 agencies or instrumentalities of the United States government;

2 (5) bankers' acceptances that:

3 (A) are eligible for purchase by the Federal
4 Reserve System;

5 (B) do not exceed 270 days to maturity; and

6 (C) are issued by a bank whose other comparable
7 short-term obligations are rated in [~~that has received~~] the highest
8 short-term [~~credit~~] rating category, within which there may be
9 subcategories or gradations indicating relative standing,
10 including such subcategories or gradations as "rating category" or
11 "rated," by a nationally recognized statistical rating
12 organization, as defined by Rule 2a-7 (17 C.F.R. Section 270.2a-7),
13 promulgated under the Investment Company Act of 1940 by the
14 Securities and Exchange Commission [~~investment rating firm~~];

15 (6) commercial paper that:

16 (A) does not exceed 270 days to maturity; and

17 (B) except as provided by Subsection (i), is
18 issued by an entity whose other comparable short-term obligations
19 are rated in [~~has received~~] the highest short-term [~~credit~~] rating
20 category by a nationally recognized statistical rating
21 organization [~~investment rating firm~~];

22 (7) contracts written by the treasury in which the
23 treasury grants the purchaser the right to purchase securities in
24 the treasury's marketable securities portfolio at a specified price
25 over a specified period and for which the treasury is paid a fee and
26 specifically prohibits naked-option or uncovered option trading;

27 (8) direct obligations of or obligations guaranteed by

1 the Inter-American Development Bank, the International Bank for
2 Reconstruction and Development (the World Bank), the African
3 Development Bank, the Asian Development Bank, and the International
4 Finance Corporation that have received the highest long-term
5 ~~[credit]~~ rating categories for debt obligations by a nationally
6 recognized statistical rating organization ~~[investment rating~~
7 ~~firm]~~;

8 (9) bonds issued, assumed, or guaranteed by the State
9 of Israel;

10 (10) obligations of a state or an agency, county,
11 city, or other political subdivision of a state;

12 (11) mutual funds secured by obligations that are
13 described by Subdivisions (1) through (6) or by obligations
14 consistent with Rule 2a-7 (17 C.F.R. Section 270.2a-7), promulgated
15 by the Securities and Exchange Commission, including pooled funds:

16 (A) established by the Texas Treasury
17 Safekeeping Trust Company;

18 (B) operated like a mutual fund; and

19 (C) with portfolios consisting only of
20 dollar-denominated securities; ~~and]~~

21 (12) foreign currency for the sole purpose of
22 facilitating investment by state agencies that have the authority
23 to invest in foreign securities;

24 (13) asset-backed securities, as defined by the
25 Securities and Exchange Commission in Rule 2a-7 (17 C.F.R. Section
26 270.2a-7), that are rated at least A or its equivalent by a
27 nationally recognized statistical rating organization and that

1 have a weighted-average maturity of five years or less; and

2 (14) corporate debt obligations that are rated at
3 least A or its equivalent by a nationally recognized statistical
4 rating organization and mature in five years or less from the date
5 on which the obligations were "acquired," as defined by the
6 Securities and Exchange Commission in Rule 2a-7 (17 C.F.R. Section
7 270.2a-7).

8 (1) The comptroller may lend securities under procedures
9 established by the comptroller. The procedures must be consistent
10 with industry practice and must include a requirement to fully
11 secure the loan with cash, obligations described by Subsections
12 (b)(1)-(6), or a combination of cash and the described obligations.
13 Notwithstanding any law to the contrary, cash may be reinvested in
14 the items permitted under Subsection (b) or mutual funds, as
15 defined by the Securities and Exchange Commission in Rule 2a-7 (17
16 C.F.R. Section 270.2a-7) [~~In this subsection, "obligation" means an~~
17 ~~item described by Subsections (b)(1)-(6)].~~

18 (m) In entering into a direct security repurchase agreement
19 or a reverse security repurchase agreement, the comptroller may
20 agree to accept cash on an overnight basis in lieu of the
21 securities, obligations, or participation certificates identified
22 in Section 404.001(3). Cash held by the state under this subsection
23 is not a deposit of state or public funds for purposes of any
24 statute, including this subchapter or Subchapter D, that requires a
25 deposit of state or public funds to be collateralized by eligible
26 securities.

27 (n) Notwithstanding any other law to the contrary, any

1 government investment pool created to function as a money market
2 mutual fund and managed by the comptroller or the Texas Treasury
3 Safekeeping Trust Company may invest the funds it receives in
4 investments that are "eligible securities," as defined by the
5 Securities and Exchange Commission in Rule 2a-7 (17 C.F.R. Section
6 270.2a-7), if it maintains a dollar-weighted average portfolio
7 maturity of 90 days or less, with the maturity of each portfolio
8 security calculated in accordance with Rule 2a-7 (17 C.F.R. Section
9 270.2a-7), and meets the diversification requirements of Rule 2a-7.

10 SECTION 19. The heading to Section 552.024, Government
11 Code, is amended to read as follows:

12 Sec. 552.024. ELECTING TO DISCLOSE ADDRESS, ~~AND~~ TELEPHONE
13 NUMBER, DATE OF BIRTH, SOCIAL SECURITY NUMBER, AND PERSONAL FAMILY
14 INFORMATION.

15 SECTION 20. Section 552.024(a), Government Code, is amended
16 to read as follows:

17 (a) Each employee or official of a governmental body and
18 each former employee or official of a governmental body shall
19 choose whether to allow public access to the information in the
20 custody of the governmental body that relates to the person's home
21 address, home telephone number, date of birth, or social security
22 number, or that reveals whether the person has family members.

23 SECTION 21. The heading to Section 552.117, Government
24 Code, is amended to read as follows:

25 Sec. 552.117. EXCEPTION: CERTAIN ADDRESSES, TELEPHONE
26 NUMBERS, DATES OF BIRTH, SOCIAL SECURITY NUMBERS, AND PERSONAL
27 FAMILY INFORMATION.

1 SECTION 22. Section 552.117(a), Government Code, is amended
2 to read as follows:

3 (a) Information is excepted from the requirements of
4 Section 552.021 if it is information that relates to the home
5 address, home telephone number, date of birth, or social security
6 number of the following person or that reveals whether the person
7 has family members:

8 (1) a current or former official or employee of a
9 governmental body, except as otherwise provided by Section 552.024;

10 (2) a peace officer as defined by Article 2.12, Code of
11 Criminal Procedure, or a security officer commissioned under
12 Section 51.212, Education Code, regardless of whether the officer
13 complies with Section 552.024 or 552.1175, as applicable;

14 (3) a current or former employee of the Texas
15 Department of Criminal Justice or of the predecessor in function of
16 the department or any division of the department, regardless of
17 whether the current or former employee complies with Section
18 552.1175;

19 (4) a peace officer as defined by Article 2.12, Code of
20 Criminal Procedure, or other law, a reserve law enforcement
21 officer, a commissioned deputy game warden, or a corrections
22 officer in a municipal, county, or state penal institution in this
23 state who was killed in the line of duty, regardless of whether the
24 deceased complied with Section 552.024 or 552.1175; or

25 (5) a commissioned security officer as defined by
26 Section 1702.002, Occupations Code, regardless of whether the
27 officer complies with Section 552.024 or 552.1175, as applicable.

1 SECTION 23. The heading to Section 552.1175, Government
2 Code, is amended to read as follows:

3 Sec. 552.1175. CONFIDENTIALITY OF ADDRESSES, TELEPHONE
4 NUMBERS, DATES OF BIRTH, SOCIAL SECURITY NUMBERS, AND PERSONAL
5 FAMILY INFORMATION OF PEACE OFFICERS, COUNTY JAILERS, SECURITY
6 OFFICERS, AND EMPLOYEES OF THE TEXAS DEPARTMENT OF CRIMINAL JUSTICE
7 OR A PROSECUTOR'S OFFICE.

8 SECTION 24. Section 552.1175(b), Government Code, is
9 amended to read as follows:

10 (b) Information that relates to the home address, home
11 telephone number, date of birth, or social security number of an
12 individual to whom this section applies, or that reveals whether
13 the individual has family members is confidential and may not be
14 disclosed to the public under this chapter if the individual to whom
15 the information relates:

16 (1) chooses to restrict public access to the
17 information; and

18 (2) notifies the governmental body of the individual's
19 choice on a form provided by the governmental body, accompanied by
20 evidence of the individual's status.

21 SECTION 25. Section 552.132(b), Government Code, is amended
22 to read as follows:

23 (b) A crime victim may elect whether to allow public access
24 to information held by the crime victim's compensation division of
25 the attorney general's office that relates to:

26 (1) the name, social security number, date of birth,
27 address, or telephone number of the crime victim; or

1 (2) any other information the disclosure of which
2 would identify or tend to identify the crime victim.

3 SECTION 26. Section 552.1325(b), Government Code, is
4 amended to read as follows:

5 (b) The following information that is held by a governmental
6 body or filed with a court and that is contained in a victim impact
7 statement or was submitted for purposes of preparing a victim
8 impact statement is confidential:

9 (1) the name, social security number, date of birth,
10 address, and telephone number of a crime victim; and

11 (2) any other information the disclosure of which
12 would identify or tend to identify the crime victim.

13 SECTION 27. Section 552.138(b), Government Code, is amended
14 to read as follows:

15 (b) Information maintained by a family violence shelter
16 center or sexual assault program is excepted from the requirements
17 of Section 552.021 if it is information that relates to:

18 (1) the home address, home telephone number, date of
19 birth, or social security number of an employee or a volunteer
20 worker of a family violence shelter center or a sexual assault
21 program, regardless of whether the employee or worker complies with
22 Section 552.024;

23 (2) the location or physical layout of a family
24 violence shelter center;

25 (3) the name, home address, home telephone number,
26 date of birth, or social security number or other numeric
27 identifier of a current or former client of a family violence

1 shelter center or sexual assault program;

2 (4) the provision of services, including counseling
3 and sheltering, to a current or former client of a family violence
4 shelter center or sexual assault program;

5 (5) the name, home address, [~~or~~] home telephone
6 number, date of birth, or social security number or other numeric
7 identifier of a private donor to a family violence shelter center or
8 sexual assault program; or

9 (6) the home address, [~~or~~] home telephone number, date
10 of birth, or social security number of a member of the board of
11 directors or the board of trustees of a family violence shelter
12 center or sexual assault program, regardless of whether the board
13 member complies with Section 552.024.

14 SECTION 28. Subchapter A, Chapter 659, Government Code, is
15 amended by adding Section 659.007 to read as follows:

16 Sec. 659.007. EARNINGS STATEMENTS. (a) In this section,
17 "state agency" has the meaning assigned by Section 403.013.

18 (b) A state agency may provide a written or electronic
19 earnings statement to an officer or employee of the agency.

20 (c) The comptroller may adopt rules and establish
21 procedures concerning the earnings statements provided by state
22 agencies that under Subchapter C, Chapter 2101, are required to use
23 the uniform statewide payroll system.

24 SECTION 29. Section 659.044(e), Government Code, is amended
25 to read as follows:

26 (e) This subsection applies only to an employee of the Texas
27 Youth Commission who is receiving less than the maximum amount of

1 hazardous duty pay that the commission may pay to the employee under
2 Section 659.303. The employee's monthly amount of longevity pay is
3 the sum of:

4 (1) \$20 [~~\$4~~] for every two years [~~each year~~] of
5 lifetime service credit, which may not include any period served in
6 a hazardous duty position; and

7 (2) the lesser of:

8 (A) \$20 [~~\$4~~] for every 24 months of lifetime
9 service credit accrued under Section 659.307(a) [~~each year served~~
10 ~~in a hazardous duty position~~]; or

11 (B) the difference between:

12 (i) \$10 [~~\$7~~] for each 12-month period of
13 lifetime service credit accrued under Section 659.307(a) [~~year~~
14 ~~served in a hazardous duty position~~]; and

15 (ii) the amount paid by the commission for
16 each 12-month period of lifetime service credit accrued under

18 SECTION 30. (a) Section 659.046, Government Code, is
19 amended by adding Subsection (g) to read as follows:

20 (g) For purposes of Subsection (a)(4), an employee's
21 service as an academic employee of a state institution of higher
22 education includes a summer semester or session during which the
23 employee is not required to provide services to the institution if:

24 (1) the employee provided services to the institution
25 throughout the immediately preceding spring and fall semesters; and

26 (2) the employee resumes providing services to the
27 institution at the beginning of the first fall semester occurring

1 after the summer semester or session.

2 (b) The changes in law made by Subsection (a) of this
3 section to Section 659.046, Government Code, apply beginning with
4 the first summer semester or session that occurs during calendar
5 year 2007.

6 SECTION 31. Section 659.255(a)(3), Government Code, is
7 amended to read as follows:

8 (3) "Merit salary increase" means an increase in
9 compensation to:

10 (A) a higher step rate in the same classified
11 salary group, if the classified employee is compensated under a
12 salary group that is divided into steps [~~Salary Schedule A of the~~
13 ~~General Appropriations Act~~]; or

14 (B) a higher rate within the range of the same
15 classified salary group, if the classified employee is compensated
16 under a salary group that is not divided into steps [~~Salary Schedule~~
17 ~~B of the General Appropriations Act~~].

18 SECTION 32. Sections 659.256(c) and (f), Government Code,
19 are amended to read as follows:

20 (c) When an employee is promoted within [~~to a position in a~~
21 ~~higher salary group in~~] Salary Schedule A of the General
22 Appropriations Act or from Salary Schedule B or C of the General
23 Appropriations Act to Salary Schedule A of the General
24 Appropriations Act, the employee shall receive a salary rate that
25 is at least 3.4 percent [~~one step~~] higher than the employee's salary
26 rate before promotion or the minimum rate of the new salary range,
27 whichever is higher, and may, at the discretion of the state agency

1 administrator, receive an annual salary rate up to and including

3 [~~\$100~~]. In the notice required by Section 74.201, the comptroller
4 is not required to publish information regarding an item having a
5 value that is less than \$200 [~~\$100~~] unless the comptroller
6 determines that publication of that information is in the public
7 interest.

8 SECTION 55. Section 74.101(a), Property Code, is amended to
9 read as follows:

10 (a) Each holder who on June 30 holds property that is
11 presumed abandoned under Chapter 72, 73, or 75 of this code or under
12 Chapter 154, Finance Code, shall file a report of that property on
13 or before the following November 1. The comptroller may require the
14 report to be in a particular format, including an electronic [a]
15 format that can be read by a computer. The comptroller may adopt
16 rules to establish threshold requirements for electronic filing by
17 holders.

18 SECTION 56. Section 74.301, Property Code, is amended by
19 adding Subsection (d) to read as follows:

20 (d) The comptroller may require holders to electronically
21 transmit money subject to delivery under Subsection (a). The
22 comptroller may adopt rules to establish the threshold requirement
23 for electronic transmission of money by holders.

24 SECTION 57. Section 74.401(a), Property Code, is amended to
25 read as follows:

26 (a) Except as provided by Subsection (c) or Section 74.404,
27 the comptroller shall sell at public sale all personal property,

1 other than money and [~~marketable~~] securities, delivered to the
2 comptroller in accordance with Section 74.301. The comptroller
3 shall conduct the sale in the city in this state that the
4 comptroller determines affords the most favorable market for the
5 particular property.

6 SECTION 58. Section 74.601, Property Code, is amended by
7 adding Subsection (g) to read as follows:

8 (g) If an owner does not assert a claim for unclaimed money
9 and the owner is reported to be the state or a state agency, the
10 comptroller may deposit the unclaimed money to the credit of the
11 general revenue fund. The comptroller may establish procedures and
12 adopt rules as necessary to implement this section.

13 SECTION 59. The following laws are repealed:

18 SECTION 60. (a) The changes in law made by this Act to

21 notations collected, made, assembled, or maintained on, before, or
22 after the effective date of this Act.

23 (b) The changes in law made by this Act to Sections 552.024,
24 552.117, 552.1175, 552.132, 552.1325, and 552.138, Government
25 Code, apply to a request for information that is received by a
26 governmental body on, before, or after the effective date of this
27 Act.

1 (c) In this section, "governmental body" has the meaning
2 assigned by Section 552.003, Government Code.

3 SECTION 61. A rule adopted by the comptroller of public
4 accounts before the effective date of the changes made by this Act
5 to Chapter 2115, Government Code, is not required to be readopted by
6 the comptroller if the rule is consistent with that chapter as
7 amended by this Act. This section applies only to a rule adopted to
8 administer that chapter.

9 SECTION 62. (a) Except as provided by Subsection (e) of
10 this section, this Act takes effect immediately if it receives a
11 vote of two-thirds of all the members elected to each house, as
12 provided by Section 39, Article III, Texas Constitution.

13 (b) If this Act does not receive the vote necessary for
14 immediate effect, the changes to or additions or repeal of the

27 (c) If this Act does not receive the vote necessary for

1 immediate effect, the changes to or additions of the following laws
2 made by this Act take effect September 1, 2007:

3 (1) Articles 103.002, 103.0021, and 103.0031, Code of
4 Criminal Procedure;

5 (2) Sections 63.202 and 63.302, Education Code;

6 (3) Sections 25.0015, 25.00211, 26.007, 403.071,
7 404.024, 659.007, 660.024, 660.027, and 660.028, Government Code;

8 (4) Section 117.002, Local Government Code; and

9 (5) Sections 74.101, 74.202, 74.301, 74.401, and
10 74.601, Property Code.

11 (d) If this Act does not receive the vote necessary for
12 immediate effect, all provisions of this Act not provided for in
13 Subsection (b) or (e) take effect September 1, 2007.

14 (e) The changes to or repeal of the following laws made by
15 this Act take effect September 1, 2007:

16 (1) Sections 43.001, 43.002, and 43.020, Education
17 Code; and
