9	This section applies only to an area:
10	(1) that is located in a county that has a population
11	of more than one million and in which more than 80 percent of the
12	population resides in a single municipality; and

14	(A) sewer service is provided by a municipality
15	or conservation and reclamation district that also provides water
16	service to other areas; and
17	(B) an entity other than the municipality or
18	district described by Paragraph (A) provides water service to the

20	(b) A municipality or conservation and reclamation district
21	may provide written notice to a person to whom the municipality's or
22	district's sewer service system provides service if the person has

The notice must 7 indicate the number of days the person has failed to pay for sewer service and the total amount past due. On receipt of the notice, 8

9 <u>the water service provider shall discontinue water service to the</u> 10 <u>person.</u>

(d) For each person the water service provider serves in an 11 area to which this section applies, the water service provider 12 shall provide the municipality or district with any relevant 13 14 customer information so that the municipality or district may bill 15 users of the sewer service directly and verify the water 16 consumption of users. Relevant customer information provided under 17 this section includes the name, address, and telephone number of the customer of the water service provider, the monthly meter 18 readings of the customer, monthly consumption information, 19 including any billing adjustments, and certain meter information, 20 21 such as brand, model, age, and location.

(e) The municipality or district shall reimburse the water service provider for its reasonable and actual incremental costs for providing services to the municipality or district under this section. Incremental costs are limited to only those costs that are in addition to the water service provider's costs in providing its services to its customers, and those costs must be consistent with
