5 SECTION 1. EXPANSION OF REDESIGNED INTEGRATED ELIGIBILITY

AND BENEFITS DETERMINATION SYSTEM LIMITED. (a) Subject to

- 4 SECTION 3. MODIFICATIONS. As soon possible as 5 September 1, 2007, the Health and Human Services Commission shall 6 consider the recommendations of the subcommittee of the House Human Services Committee established to study and make recommendations 7 8 regarding the redesigned integrated eligibility and benefits 9 determination system for health and human services, including the Texas Integrated Eligibility and Redesign System, and the Medicaid 10 Star + Plus program. The commission shall: 11
- 12 (1) implement those recommendations; or

- 13 (2) for each recommendation made by the subcommittee 14 that the commission does not implement, submit a detailed report to 15 the House Human Services Committee specifying the reasons the 16 recommendation was not implemented.
  - SECTION 4. TERMINATION. (a) On and after September 1, 2009, the Health and Human Services Commission shall cease using the redesigned integrated eligibility and benefits determination system for health and human services, including the Texas Integrated Eligibility and Redesign System, in any area of this state in which the system was implemented, except to the extent required by a contract entered into before September 1, 2007.
  - (b) On and after September 1, 2009, the Health and Human Services Commission shall cease operating the Medicaid Star + Plus program in any area of this state in which the program was implemented, except to the extent required by a contract entered

- 1 into before September 1, 2007.
- 2 SECTION 5. EFFECTIVE DATE. This Act takes effect
- 3 immediately if it receives a vote of two-thirds of all the members
- 4 elected to each house, as provided by Section 39, Article III, Texas
- 5 Constitution. If this Act does not receive the vote necessary for
- 6 immediate effect, this Act takes effect September 1, 2007.
