18	Sec. 8223.002. NATURE OF DISTRICT. Each district is a
19	municipal utility district in Collin County created under and
20	essential to accomplish the purposes of Section 59, Article XVI,
21	<u>Texas Constitution.</u>
22	Sec. 8223.003. CONFIRMATION ELECTION REQUIRED. If the
23	creation of a district is not confirmed at a confirmation election
24	held under Section 8223.024 before September 1, 2011:

1	(1) the district is dissolved September 1, 2011,
2	except that:
3	(A) any debts incurred shall be paid;
4	(B) any assets that remain after the payment of
5	debts shall be transferred to Collin County; and
6	(C) the organization of the district shall be

8	transferred; and
9	(2) this chapter expires September 1, 2014.
10	Sec. 8223.004. INITIAL DISTRICT TERRITORY. (a) Each
11	district is initially composed of the territory described by

26	Sec. 8223.021. TEMPORARY DIRECTORS. (a) On or after

2	temporary directors of that district the five persons listed in the
3	petition.
4	(b) The commission shall appoint as temporary directors the
5	persons listed in a petition received by the commission under
6	Subsection (a). If the commission receives more than one petition

8	in the first petition the commission receives.
9	(c) If a temporary director fails to qualify for office, the

24	Sec. 8223.023. CONSENT OF MUNICIPALITY REQUIRED. The
25	temporary directors of each district may not hold an election under
26	Section 8223.024 until each municipality in whose corporate limits
27	or extraterritorial jurisdiction a district is located, if any, has

1	adopted a resolution consenting to the creation of the district.
2	Sec. 8223.024. CONFIRMATION AND INITIAL DIRECTORS'
3	ELECTION. The temporary directors of each district shall hold an
4	election to confirm the creation of the district and to elect five
5	directors as provided by Section 49.102, Water Code.
6	Sec. 8223.025. INITIAL ELECTED DIRECTORS; TERMS. The
7	directors of each district elected under Section 8223.024 shall
8	draw lots to determine which two shall serve until the first
9	regularly scheduled election of directors under Section 8223.052
10	and which three shall serve until the second regularly scheduled
11	election of directors.
12	Sec. 8223.026. EXPIRATION OF SUBCHAPTER. This subchapter
13	expires September 1, 2014.
14	[Sections 8223.027-8223.050 reserved for expansion]
15	SUBCHAPTER B. BOARD OF DIRECTORS
16	Sec. 8223.051. DIRECTORS; TERMS. (a) Each district is
17	governed by a board of five directors.
18	(b) Directors serve staggered four-year terms.
19	Sec. 8223.052. ELECTION OF DIRECTORS. On the uniform
20	election date in May of each even-numbered year, the appropriate
21	number of directors of each district shall be elected.
22	[Sections 8223.053-8223.100 reserved for expansion]
23	SUBCHAPTER C. POWERS AND DUTIES
24	Sec. 8223.101. GENERAL POWERS. Each district has the
25	powers and duties provided by the general law of this state,
26	including Chapters 49 and 54, Water Code, applicable to municipal
27	utility districts created under Section 59, Article XVI, Texas

1 <u>Constitution</u>.

Sec. 8223.102. ROAD PROJECTS. (a) To the extent authorized
by Section 52, Article III, Texas Constitution, each district may
construct, acquire, improve, maintain, or operate macadamized,
graveled, or paved roads or turnpikes, or improvements in aid of
those roads or turnpikes, inside the district.

7 <u>(b) A road project must meet or exceed all applicable</u> 8 <u>construction standards, zoning and subdivision requirements, and</u> 9 <u>regulatory ordinances or orders of each municipality in whose</u> 10 <u>corporate limits or extraterritorial jurisdiction a district is</u> 11 <u>located.</u>

12 <u>(c) If a district is located outside the territorial</u> 13 jurisdiction of a municipality, a road project must meet all 14 applicable construction standards, zoning and subdivision 15 <u>requirements, and regulatory ordinances of each county in which the</u> 16 <u>district is located.</u>

17 (d) A district may not undertake a road project unless each 18 municipality in whose corporate limits or extraterritorial 19 jurisdiction the district is located consents by ordinance or 20 resolution.

21 <u>Sec. 8223.103. COMPLIANCE WITH MUNICIPAL CONSENT</u> 22 <u>ORDINANCES OR RESOLUTIONS. Each district shall comply with all</u> 23 <u>applicable requirements of any ordinance or resolution adopted by</u> 24 <u>the city council of the City of McKinney.</u>

25 <u>Sec. 8223.104. DIVISION OF DISTRICT. (a) A district may be</u> 26 <u>divided into two new districts only if the district:</u> 27 (1) has no outstanding bonded debt; and

1	(2) is not imposing ad valorem taxes.
2	(b) The division procedure is prescribed by Sections 53.030
3	through 53.041, Water Code.
4	(c) Any new district created by the division of a district
5	has all the powers and duties of a district.
6	(d) A new district, at the time it is created by the division
7	of a district, may not contain land outside the area described by
8	Section 2 of the Act creating this chapter.

10	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
11	Sec. 8223.151. TAX TO REPAY BONDS. Each district may impose
12	a tax to pay the principal of or interest on bonds issued under
13	Section 8223.201.
14	[Sections 8223.152-8223.200 reserved for expansion]
15	SUBCHAPTER E. BONDS
16	Sec. 8223.201. AUTHORITY TO ISSUE BONDS AND OTHER
17	OBLIGATIONS. (a) Each district may issue bonds or other
18	obligations as provided by Chapters 49 and 54, Water Code, to
19	finance the construction, maintenance, or operation of projects
20	under Sections 8223.101 and 8223.102.
21	(b) A district may not issue bonds to finance projects
22	authorized by Section 8223.102 unless the issuance is approved by a
23	vote of a two-thirds majority of the voters of the district voting
24	at an election called for that purpose.
25	(c) Bonds or other obligations issued or incurred to finance
26	projects authorized by Section 8223.102 may not exceed one-fourth
27	of the assessed value of the real property in the district.

7 (b) The governor, one of the required recipients, has 8 submitted the notice and Act to the Texas Commission on 9 Environmental Quality.

The Texas Commission on Environmental Quality has filed 10 (c) its recommendations relating to this Act with the governor, the 11 12 lieutenant governor, and the speaker of the house of representatives within the required time. 13
