## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Harris County Municipal Utility
3	District No. 438; providing authority to impose a tax and issue
4	bonds; granting the power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8234 to read as follows:
8	CHAPTER 8234. HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 438
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 8234.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "Director" means a board member.
13	(3) "District" means the Harris County Municipal
14	Utility District No. 438.
15	Sec. 8234.002. NATURE OF DISTRICT. (a) The district is a
16	municipal utility district created under and essential to
17	accomplish the purposes of Section 59, Article XVI, Texas
18	Constitution.
19	(b) The district, to the extent authorized by Section
20	8234.103 and Section 52, Article III, Texas Constitution, has road
21	powers.
22	Sec. 8234.003. CONFIRMATION ELECTION REQUIRED. The board
23	shall hold an election to confirm the creation of the district as

provided by Section 49.102, Water Code.

1	Sec. 8234.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. All
2	land and other property in the district will benefit from the
3	improvements and services to be provided by the district.
4	Sec. 8234.005. INITIAL DISTRICT TERRITORY. (a) The
5	district is initially composed of the territory described by
6	Section 2 of the Act creating this chapter.
7	(b) The boundaries and field notes contained in Section 2 of
8	the Act creating this chapter form a closure. A mistake in the
9	field notes or in copying the field notes in the legislative process
10	<pre>does not affect the district's:</pre>
11	(1) organization, existence, or validity;
12	(2) right to issue any type of bond for a purpose for
13	which the district is created or to pay the principal of and
14	interest on the bond;
15	(3) right to impose an assessment or tax; or
16	(4) legality or operation.
17	[Sections 8234.006-8234.050 reserved for expansion]
18	SUBCHAPTER B. BOARD OF DIRECTORS
19	Sec. 8234.051. GOVERNING BODY; TERMS. (a) The district is
20	governed by a board of five elected directors.
21	(b) Directors serve staggered four-year terms.
22	Sec. 8234.052. INITIAL DIRECTORS. (a) The initial board
23	<pre>consists of:</pre>
24	(1) Shanna Martinez;
25	(2) Amelia Culwell;
26	(3) Gavin Cunningham;
27	(4) Howard F. Barrett-Smith; and

1	(5) Linda Brown.
2	(b) Unless the initial board agrees otherwise, the initial
3	directors shall draw lots to determine which two shall serve until
4	the first regularly scheduled election of directors and which three
5	shall serve until the second regularly scheduled election of
6	directors.
7	(c) This section expires September 1, 2014.
8	[Sections 8234.053-8234.100 reserved for expansion]
9	SUBCHAPTER C. POWERS AND DUTIES
10	Sec. 8234.101. GENERAL POWERS AND DUTIES. The district has
11	the powers and duties necessary to accomplish the purposes for
12	which the district is created.
13	Sec. 8234.102. MUNICIPAL UTILITY DISTRICT POWERS AND
14	DUTIES. The district has the powers and duties provided by the
15	general law of this state, including Chapters 49 and 54, Water Code,
16	applicable to municipal utility districts created under Section 59,
17	Article XVI, Texas Constitution.
18	Sec. 8234.103. ROAD PROJECTS. (a) Under Section 52,
19	Article III, Texas Constitution, the district may finance,
20	construct, or acquire a road project as provided by this section.
21	(b) The district shall employ or contract with a licensed
22	engineer to certify whether a proposed road project meets the
23	criteria for a thoroughfare, arterial, or collector road of:
24	(1) a county in whose jurisdiction the proposed road
25	project is located; or
26	(2) a municipality in whose corporate limits or
27	extraterritorial jurisdiction the proposed road project is

1 located. 2 (c) The district may finance, construct, or acquire a road that has been certified by the licensed engineer as a thoroughfare, 3 4 arterial, or collector road, or any improvements in aid of the 5 certified road. 6 (d) A road project must meet all applicable standards, 7 regulations, ordinances, or orders of: 8 (1) each municipality in whose corporate limits or 9 extraterritorial jurisdiction the road project is located; and (2) if the road project is not located in the corporate 10 limits of a municipality, each county in which the road project is 11 12 located. (e) The district may, with the consent of the municipality 13 14 or county, convey a completed road project to: 15 (1) a municipality in whose corporate limits or 16 extraterritorial jurisdiction the road project is located; or 17 (2) a county in which the road project is located. Sec. 8234.104. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE 18 OR RESOLUTION. The district shall comply with all applicable 19 requirements of any ordinance or resolution, adopted by the 20 21 governing body of a municipality under Section 54.016, Water Code, that consents to the creation of the district or to the inclusion of 22 land in the district. 23 24 [Sections 8234.105-8234.150 reserved for expansion] 25 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS 26 Sec. 8234.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The

district may issue, without an election, bonds and other

- 1 obligations secured by revenue or contract payments from a source
- 2 other than ad valorem taxation.
- 3 (b) The district must hold an election in the manner
- 4 provided by Chapters 49 and 54, Water Code, to obtain voter approval
- 5 before the district may impose an ad valorem tax or issue bonds
- 6 payable from ad valorem taxes.
- 7 (c) The district may not issue bonds payable from ad valorem
- 8 taxes to finance a road project unless the issuance is approved by a
- 9 vote of a two-thirds majority of district voters voting at an
- 10 <u>election held for that purpose.</u>
- 11 Sec. 8234.152. OPERATION AND MAINTENANCE TAX. (a) If
- 12 authorized at an election held under Section 8234.151, the district
- 13 may impose an operation and maintenance tax on taxable property in
- 14 the district as provided by Section 49.107, Water Code.
- 15 (b) The board shall determine the tax rate. The rate may not
- 16 <u>exceed the rate approved at the election.</u>
- 17 [Sections 8234.153-8234.200 reserved for expansion]
- 18 SUBCHAPTER E. BONDS
- 19 Sec. 8234.201. AUTHORITY TO ISSUE BONDS AND OTHER
- 20 OBLIGATIONS. The district may issue bonds or other obligations
- 21 payable wholly or partly from ad valorem taxes, impact fees,
- 22 revenue, grants, or other district money, or any combination of
- those sources, to pay for any authorized district purpose.
- Sec. 8234.202. BONDS FOR ROAD PROJECTS. At the time of
- 25 issuance, the total principal amount of a bond, note, or other
- 26 obligation issued or incurred to finance a road project may not
- 27 exceed one-fourth of the assessed value of real property in the

- 1 district according to the most recent certified tax appraisal roll
- 2 for Harris County.
- 3 Sec. 8234.203. TAXES FOR BONDS AND OTHER OBLIGATIONS. At
- 4 the time bonds or other obligations payable wholly or partly from ad
- 5 valorem taxes are issued:
- 6 (1) the board shall impose a continuing direct annual
- 7 ad valorem tax, without limit as to rate or amount, for each year
- 8 that all or part of the bonds are outstanding; and
- 9 (2) the district annually shall impose an ad valorem
- 10 tax on all taxable property in the district in an amount sufficient
- 11 to:
- 12 (A) pay the interest on the bonds or other
- obligations as the interest becomes due;
- 14 (B) create a sinking fund for the payment of the
- 15 principal of the bonds or other obligations when due or the
- 16 redemption price at any earlier required redemption date; and
- 17 (C) pay the expenses of imposing the taxes.
- 18 SECTION 2. The Harris County Municipal Utility District No.
- 19 438 initially includes all the territory contained in the following
- 20 area:
- 21 Being 643.03 acres of land located in the J. A. Arnold Survey,
- 22 Section 28, Abstract No. 1378, Harris County, Texas and being a
- 23 portion of that land described in a conveyance to Margaret Rogers

- 22 SECTION 3. (a) The legal notice of the intention to

- 24 Act, has been published as provided by law, and the notice and a
- 25 copy of this Act have been furnished to all persons, agencies,
- officials, or entities to which they are required to be furnished
- 27 under Section 59, Article XVI, Texas Constitution, and Chapter 313,

- 1 Government Code.
- 2 (b) The governor, one of the required recipients, has
- 3 submitted the notice and Act to the Texas Commission on
- 4 Environmental Quality.
- 5 (c) The Texas Commission on Environmental Quality has filed
- 6 its recommendations relating to this Act with the governor, the
- 7 lieutenant governor, and the speaker of the house of
- 8 representatives within the required time.
- 9 (d) All requirements of the constitution and laws of this
- 10 state and the rules and procedures of the legislature with respect
- 11 to the notice, introduction, and passage of this Act are fulfilled
- 12 and accomplished.
- 13 SECTION 4. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2007.
