## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Rolling V Ranch Water Control and
3	Improvement District No. 1 of Wise County; providing authority to
4	impose a tax and issue bonds; granting the power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle I, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 9021 to read as follows:
8	CHAPTER 9021. ROLLING V RANCH WATER CONTROL AND IMPROVEMENT
9	DISTRICT NO. 1 OF WISE COUNTY
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 9021.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the district's board of directors.
13	(2) "Director" means a board member.
14	(3) "District" means the Rolling V Ranch Water Control
15	and Improvement District No. 1 of Wise County.
16	Sec. 9021.002. NATURE OF DISTRICT. The district is a water
17	control and improvement district in Wise County created under and
18	essential to accomplish the purposes of Section 59, Article XVI,
19	and Section 52, Article III, Texas Constitution.
20	Sec. 9021.003. CONFIRMATION ELECTION REQUIRED. If the
21	creation of the district is not confirmed at a confirmation
22	election held under Section 9021.024 before November 4, 2009:
23	(1) the district is dissolved November 4, 2009, except
24	that the district shall:

1	(A) pay any debts incurred;
2	(B) transfer to Wise County any assets that
3	remain after the payment of debts; and
4	(C) maintain the organization of the district
5	until all debts are paid and remaining assets are transferred; and
6	(2) this chapter expires September 1, 2014.
7	Sec. 9021.004. INITIAL DISTRICT TERRITORY. (a) The
8	district is initially composed of the territory described by
9	Section 2 of the Act creating this chapter.
10	(b) The boundaries and field notes contained in Section 2 of
11	the Act creating this chapter form a closure. A mistake made in the
12	field notes or in copying the field notes in the legislative process
13	does not affect:
14	(1) the organization, existence, or validity of the
15	district;
16	(2) the right of the district to impose taxes;
17	(3) the validity of the district's bonds, notes, or
18	indebtedness; or
19	(4) the legality or operation of the district or the
20	board.

22	SUBCHAPTER A-1. TEMPORARY PROVISIONS
23	Sec. 9021.021. TEMPORARY DIRECTORS. (a) The temporary
24	board consists of:

1 (4) Robert Stennett; and 2 (5) Craig Wade. 3 (b) If a temporary director fails to qualify for office, the 4 temporary directors who have qualified shall appoint a person to fill the vacancy. If at any time there are fewer than three 5 6 qualified temporary directors, the Texas Commission on 7 Environmental Quality shall appoint the necessary number of persons to fill all vacancies on the board. 8 (c) Temporary directors serve until the earlier of: 9 10 (1) the date directors are elected under Section 9021.024; or 11 12 (2) the date this chapter expires under Section 13 9021.003. Sec. 9021.022. ORGANIZATIONAL MEETING OF TEMPORARY 14 15 DIRECTORS. As soon as practicable after all the temporary 16 directors have qualified under Section 49.055, Water Code, the temporary directors shall meet at a location in the district 17 agreeable to a majority of the directors. If a location cannot be 18 agreed upon, the directors shall meet at the Wise County 19 Courthouse. At the meeting, the temporary directors shall elect 20 21 officers from among the temporary directors and conduct any other district business. 22 Sec. 9021.023. CONSENT OF MUNICIPALITY REQUIRED. 23 The 24 temporary directors may not hold an election under Section 9021.024 until each municipality in whose corporate limits or 25 26 extraterritorial jurisdiction the district is located has: 27 (1) adopted a resolution consenting to the creation of

3	owners of real property in the district.
4	Sec. 9021.024. CONFIRMATION AND INITIAL DIRECTORS'
5	ELECTION. The temporary directors shall hold an election to
6	confirm the creation of the district and to elect five directors as
7	provided by Section 49.102, Water Code.
8	Sec. 9021.025. INITIAL ELECTED DIRECTORS; TERMS. The
9	directors elected under Section 9021.024 shall draw lots to
LO	determine which two shall serve until the first regularly scheduled
L1	election of directors and which three shall serve until the second
L2	regularly scheduled election of directors.
L3	Sec. 9021.026. EXPIRATION OF SUBCHAPTER. This subchapter
L4	expires November 4, 2012.
L5	[Sections 9021.027-9021.050 reserved for expansion]
L6	SUBCHAPTER B. BOARD OF DIRECTORS
L7	Sec. 9021.051. GOVERNING BODY; TERMS. (a) The district is
L8	governed by a board of five directors.
L9	(b) Directors serve staggered four-year terms.

21	SUBCHAPTER C. POWERS AND DUTIES
22	Sec. 9021.101. WATER CONTROL AND IMPROVEMENT DISTRICT
23	POWERS AND DUTIES. The district has the powers and duties provided
24	by the general law of this state, including Chapters 49 and 51,
25	Water Code, applicable to water control and improvement districts
26	created under Section 59, Article XVI, Texas Constitution.
27	Sec. 9021.102. ROAD PROJECTS. To the extent authorized by

1 the district; and

- 1 Section 52, Article III, Texas Constitution, the district may
- 2 construct, acquire, improve, maintain, or operate macadamized,
- 3 graveled, or paved roads or turnpikes, or improvements in aid of
- 4 those roads or turnpikes, inside the district.
- 5 Sec. 9021.103. AUTHORITY TO CONTRACT WITH OWNERS OF REAL
- 6 PROPERTY IN DISTRICT. The board may contract with an owner of real
- 7 property in the district to construct, acquire, finance, own,
- 8 maintain, or operate a work, project, service, or commodity
- 9 necessary for a project authorized by Section 9021.102.
- Sec. 9021.104. DIVISION OF DISTRICT. (a) The district may
- 11 be divided into two new districts only if the district:
- 12 (1) has no outstanding bonded debt; and
- 13 (2) is not imposing ad valorem taxes.
- 14 (b) The division procedure is prescribed by Sections 53.030
- through 53.041, Water Code. Sections 51.748 through 51.753, Water
- 16 Code, do not apply to the district.
- 17 (c) Any new district created by the division of the district
- 18 has all the powers and duties of the district.
- 19 (d) Any new district created by the division of the district
- 20 <u>may not, at the time the new district is created, contain any land</u>

- Sec. 9021.201. AUTHORITY TO ISSUE BONDS AND OTHER
- OBLIGATIONS. (a) The district may issue bonds or other obligations
- 13 as provided by Chapters 49 and 51, Water Code, to finance the
- 14 construction, maintenance, or operation of a project under Section
- 15 <u>9021.101 or 9021.102.</u>
- 16 (b) The district may not issue bonds or other obligations to
- finance projects authorized by Section 9021.102 unless the issuance
- 18 is approved by a vote of a two-thirds majority of the district
- 19 voters voting at an election called for that purpose.
- 20 (c) Bonds or other obligations issued or incurred to finance
- 21 projects authorized by Section 9021.102 may not exceed one-fourth
- of the assessed value of the real property in the district.
