- SECTION 2. Section 25.1863(b), Government Code, is amended

- 15 (b) A county court at law has concurrent jurisdiction with
- 16 the district court over contested probate matters. Notwithstanding
- 17 the requirement in Subsection (b), Section 5, Texas Probate Code,
- 18 that the judge of the constitutional county court transfer a
- 19 contested probate proceeding to the district court, the judge of
- 20 the constitutional county court shall transfer the proceeding under
- 21 that section to either a county court at law in [the County Court at
- 22 Law of Parker County or a [the] district court in Parker County. A
- 23 [The] county court at law has the jurisdiction, powers, and duties
- that a district court has under Subsection (b), Section 5, Texas

- 1 Probate Code, for the transferred proceeding, and the county clerk
- 2 acts as clerk for the proceeding. The contested proceeding may be
- 3 transferred between <u>a</u> [the] county court at law <u>in Parker County</u> and
- 4 <u>a</u> [the] district court <u>in Parker County</u> as provided by local rules
- 5 of administration.
- 6 SECTION 3. Section 25.1862(e), Government Code, is
- 7 repealed.
- 8 SECTION 4. (a) A reference in law to the County Court at Law
- 9 of Parker County means the County Court at Law No. 1 of Parker
- 10 County.
- 11 (b) The judge of the County Court at Law of Parker County,
- 12 unless otherwise removed as provided by law, continues to serve as
- 13 judge of the County Court at Law No. 1 of Parker County for the
- 14 remainder of the term to which the judge was elected or appointed,
- 15 notwithstanding the change made by this Act to the name of the
- 16 court.
- 17 SECTION 5. This Act takes effect October 1, 2007.
