1	AN ACT
2	relating to the creation of a commission to investigate and prevent
3	wrongful convictions.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 43, Code of Criminal Procedure, is
6	amended by adding Article 43.27 to read as follows:
7	Art. 43.27. TEXAS INNOCENCE COMMISSION
8	Sec. 1. CREATION. The Texas Innocence Commission is
9	created.
10	Sec. 2. COMPOSITION. (a) The commission is composed of
11	nine members. The governor shall appoint two members, one of whom
12	must be a dean of a law school and one of whom must be a law
13	enforcement officer. The attorney general shall appoint one
14	member, who must be an attorney who represents the state in the
15	prosecution of felonies. The chair of the criminal justice
16	committee of the senate shall appoint one member, who may be a
17	member of the legislature. The chair of the criminal jurisprudence
18	committee of the house of representatives shall appoint one member,
19	who may be a member of the legislature. The chief justice of the
20	supreme court shall appoint one member, who must be a member of the
21	judiciary. The chancellor of The University of Texas System shall
22	appoint two members, one of whom must be a law professor and one of
23	whom must work in the forensic science field. The Texas Criminal
24	Defense Lawyers Association shall appoint one member, who must be a

1 criminal defense lawyer. 2 (b) Each member serves a two-year term. 3 (c) The governor shall designate a member to serve as 4 presiding officer. 5 Sec. 3. DUTIES. (a) The commission shall investigate 6 thoroughly: 7 (1) all postconviction exonerations, including 8 convictions vacated based on a plea to time served, to: 9 (A) ascertain errors and defects in the criminal procedure used to prosecute the defendant's case at issue; 10 (B) identify errors and defects in the criminal 11 12 justice process in this state generally; (C) develop solutions and methods to correct the 13 14 identified errors and defects; and 15 (D) identify procedures and programs to prevent 16 future wrongful convictions; and 17 (2) all colorable allegations that an innocent person has been executed. 18 (b) The commission may enter into contracts for research 19 services as considered necessary to complete the investigation of a 20 21 particular case, including forensic testing and autopsies. (c) The commission may administer oaths and issue 22 subpoenas, signed by the presiding officer, to compel the 23 24 production of documents and the attendance of witnesses as considered necessary to conduct a thorough investigation. A 25 26 subpoena of the commission shall be served by a peace officer in the

manner in which district court subpoenas are served.

application of the commission, a district court of Travis County 1 2 shall compel compliance with the subpoena in the same manner as for 3 district court subpoenas. 4 Sec. 4. REPORT. (a) The commission shall compile a detailed annual report of its findings and recommendations, 5 6 including any proposed legislation to implement procedures and 7 programs to prevent future wrongful convictions or executions. (b) The report shall be made available to the public on 8 9 request. The findings and recommendations contained in the 10 (c) report may not be used as binding evidence in a subsequent civil or 11 12 criminal proceeding. Sec. 5. SUBMISSION. The commission shall submit the report 13 described by Section 4 to the governor, the lieutenant governor, 14 15 and the speaker of the house of representatives not later than 16 December 1 of each even-numbered year. 17 Sec. 6. RESPONSE. Not later than the 60th day after the date of receipt of the report required by this article, the 18 governor, lieutenant governor, and speaker of the house of 19 representatives shall, singly or jointly, issue a formal written 20 21 response to the findings and recommendations of the commission. Sec. 7. REIMBURSEMENT. A member of the commission is not 22 entitled to compensation but is entitled to reimbursement for the 23 24 member's travel expenses as provided by Chapter 660, Government 25 Code, and the General Appropriations Act. 26 Sec. 8. ASSISTANCE. The Texas Legislative Council, the Legislative Budget Board, and The University of Texas at Austin 27

2	Sec. 9. OTHER LAW. The commission is not subject to Chapter
3	2110, Government Code.
4	SECTION 2. The appointments to the Texas Innocence
5	Commission as required by Article 43.27, Code of Criminal
6	Procedure, as added by this Act, shall be made not later than the
7	60th day after the effective date of this Act.
8	SECTION 3. This Act takes effect September 1, 2007.
