1 AN ACT 2 relating to the creation of Booth Ranch Municipal Utility District 3 of Fort Bend County, Texas; providing authority to impose taxes and issue bonds; granting the power of eminent domain. 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8242 to read as follows: 7 8 CHAPTER 8242. BOOTH RANCH MUNICIPAL UTILITY 9 DISTRICT OF FORT BEND COUNTY, TEXAS SUBCHAPTER A. GENERAL PROVISIONS 10 Sec. 8242.001. DEFINITIONS. In this chapter: 11 12 (1) "Board" means the board of directors of the 13 district. 14 (2) "Commission" means the Texas Commission on Environmental Quality or its successors. 15 16 (3) "Director" means a member of the board. (4) "District" means Booth Ranch Municipal Utility 17 18 District of Fort Bend County, Texas. Sec. 8242.002. NATURE OF DISTRICT. Booth Ranch Municipal 19 Utility District of Fort Bend County, Texas is created as a 20 21 municipal utility district created under and essential to accomplish the purposes of Section 59, Article XVI, Texas 22 23 Constitution. 24 Sec. 8242.003. CONFIRMATION ELECTION REQUIRED. The board

1	shall hold an election to confirm the creation of the district as
2	provided by Section 49.102, Water Code.
3	Sec. 8242.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
4	(a) All land and other property included in the district will
5	benefit from the improvements and services to be provided by the
6	district.
7	(b) The district is created to accomplish the purposes of a
8	municipal utility district as provided by general law.
9	Sec. 8242.005. INITIAL DISTRICT TERRITORY. (a) The
10	district is initially composed of territory described by Section 2
11	of the Act creating this chapter.
12	(b) The boundaries and field notes of the district form a
13	closure. A mistake in the field notes or in copying the field notes
14	in the legislative process does not in any way affect the
15	district's:
16	(1) organization, existence, or validity;
17	(2) right to issue any type of bond for the purposes
18	for which the district is created or to pay the principal of and
19	interest on a bond;
20	(3) right to impose or collect an assessment or tax; or
21	(4) legality or operation.

23	SUBCHAPTER B. BOARD OF DIRECTORS
24	Sec. 8242.051. BOARD OF DIRECTORS; TERMS. (a) The

1	Sec. 8242.052. ELECTION OF DIRECTORS. On the uniform
2	election date in May of each even-numbered year, the appropriate
3	number of directors shall be elected.
4	Sec. 8242.053. INITIAL DIRECTORS. (a) The initial board
5	shall be appointed by the commission upon petition of any landowner
6	in the district.
7	(b) Unless otherwise agreed, the directors shall decide the
8	initial terms of office by lot, with a simple majority of directors
9	serving until the second succeeding directors election and the
10	remaining directors serving until the next directors election.

12	SUBCHAPTER C. POWERS AND DUTIES

14	the powers and duties necessary to accomplish the purposes for

17	DUTIES. The district has the powers and duties provided by the
18	general law of this state, including Chapters 49 and 54, Water Code,
19	applicable to municipal utility districts created under Section 59,

21	Sec. 8242.103. MUNICIPAL CONSENT ORDINANCES OR
22	RESOLUTIONS. (a) Subject to the limitations of Section 54.016,
23	Water Code, the district shall comply with all applicable
24	requirements of any ordinance or resolution adopted by the
25	governing body of the municipality that consents to the creation of
26	the district or to the inclusion of lands within the district.
27	(b) Notwithstanding Section 54.016(e), Water Code, the

governing body of a municipality which includes within its 1 2 corporate limits all or a portion of the district may include restrictions in or conditions to its consent to the creation of the 3 district in addition to those set forth in that subsection, 4 including the condition that, at the time such consent is granted, 5 no lands within the district may be within the corporate limits or 6 7 extraterritorial jurisdiction of any other municipality. 8 [Sections 8242.104-8242.150 reserved for expansion] SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS 9 Sec. 8242.151. ELECTIONS REGARDING TAXES 10 OR BONDS. (a) The district may issue, without an election, bonds and other 11 12 obligations secured by revenues or contract payments from any lawful sources other than ad valorem taxation. 13 (b) The district must hold an election in the manner 14 15 provided by Chapters 49 and 54, Water Code, to obtain voter approval before the district may impose an operation and maintenance tax or 16 17 issue bonds payable from ad valorem taxes. Sec. 8242.152. OPERATION AND MAINTENANCE TAX. (a) If 18 authorized at an election held in accordance with Section 8242.151, 19 the district may impose an operation and maintenance tax on taxable 20 21 property in the district in accordance with the provisions of Chapter 49.107, Water Code. 22 (b) The board shall determine the tax rate. The rate may not 23 24 exceed the rate approved at the election. 25 [Sections 8242.153-8242.200 reserved for expansion] SUBCHAPTER E. BONDS OR OTHER OBLIGATIONS 26

No. 4006 notes, or other obligations payable in whole or in part from ad 1 2 valorem taxes, impact fees, revenues, grants, or other district money, or any combination of those sources, to pay for any 3 authorized district purpose. 4 Sec. 8242.202. TAXES FOR BONDS. At the time bonds payable 5 6 in whole or in part from ad valorem taxes are issued: 7 (1) the board shall impose a continuing direct annual 8 ad valorem tax, without limit as to rate or amount, for each year 9 that all or part of the bonds are outstanding; and (2) the district annually shall impose an ad valorem 10 tax on all taxable property in the district in an amount sufficient 11 12 to: 13 (A) pay the interest on the bonds as the interest 14 becomes due; 15 (B) create a sinking fund for the payment of the principal of the bonds when due or the redemption price at any 16 17 earlier required redemption date; and (C) pay the expenses of imposing the taxes. 18 19 SECTION 2. - 26 SECTION 3. The legislature finds that:
- 27

(1) proper and legal notice of the intention to

introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished by the constitution and laws of this state, including the governor, who has submitted the notice and Act to the Texas Commission on Environmental Quality;

8 (2) the Texas Commission on Environmental Quality has 9 filed its recommendations relating to this Act with the governor, 10 the lieutenant governor, and the speaker of the house of 11 representatives within the required time;

12 (3) the general law relating to consent by political 13 subdivisions to the creation of districts with conservation and 14 reclamation powers and the inclusion of land in those districts has 15 been complied with; and

16 (4) all requirements of the constitution and laws of 17 this state and the rules and procedures of the legislature with 18 respect to the notice, introduction, and passage of this Act have 19 been fulfilled and accomplished.

SECTION 4. The legislature finds and declares that the 20 21 Booth Ranch Municipal Utility District of Fort Bend County, Texas, will not be officially created until passage of a confirmation 22 election, and that securing consent by political subdivisions to 23 24 the creation of the district prior to the introduction or passage of this Act is impractical due to the uncertainties of the legislative 25 process, and that the constitutional requirement for compliance by 26 27 the district with the provisions of the general laws now in effect

relating to the consent by political subdivisions to the creation and inclusion of land within the district will be met and satisfied if such consent is secured prior to the date and hour of canvassing the returns and declaring the results of such confirmation election.

6 SECTION 5. This Act takes effect immediately if it receives 7 a vote of two-thirds of all the members elected to each house, as 8 provided by Section 39, Article III, Texas Constitution. If this 9 Act does not receive the vote necessary for immediate effect, this 10 Act takes effect September 1, 2007.
