## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Collin County Fresh Water Supply
3	District No. 2 and the dissolution of the Collin County Municipal
4	Utility District No. 1; providing authority to impose a tax and
5	issue bonds; granting the power of eminent domain.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle B, Title 6, Special District Local Laws
8	Code, is amended by adding Chapter 6907 to read as follows:
9	CHAPTER 6907. COLLIN COUNTY FRESH WATER SUPPLY
10	DISTRICT NO. 2
11	SUBCHAPTER A. GENERAL PROVISIONS
12	Sec. 6907.001. DEFINITIONS. In this chapter:
13	(1) "Board" means the board of directors of the
14	district.
15	(2) "Director" means a member of the board.
16	(3) "District" means the Collin County Fresh Water
17	Supply District No. 2.
18	Sec. 6907.002. NATURE OF DISTRICT. The district is a fresh
19	water supply district in Collin County created under and essential
20	to accomplish the purposes of Section 59, Article XVI, Texas
21	Constitution. The district is created to serve a public use and
22	benefit.
23	Sec. 6907.003. CONFIRMATION ELECTION REQUIRED. If the
24	creation of the district is not confirmed at a confirmation

1	election held under Section 6907.023 before September 1, 2009:
2	(1) the district is dissolved September 1, 2009,
3	except that the district shall:
4	(A) pay any debts incurred;
5	(B) transfer to Collin County any assets that
6	remain after the payment of debts; and
7	(C) maintain the organization of the district
8	until all debts are paid and remaining assets are transferred; and
9	(2) this chapter expires September 1, 2012.
10	Sec. 6907.004. INITIAL DISTRICT TERRITORY. (a) The
11	district is initially composed of the territory described by
12	Section 2 of the Act creating this chapter.
13	(b) The boundaries and field notes contained in Section 2 of
14	the Act creating this chapter form a closure. A mistake made in the
15	field notes or in copying the field notes in the legislative process
16	<pre>does not affect:</pre>
17	(1) the organization, existence, or validity of the
18	<pre>district;</pre>
19	(2) the right of the district to impose taxes; or
20	(3) the legality or operation of the board.

As soon as practicable after all the temporary 16 directors have qualified under Section 49.055, Water Code, the 17 temporary board shall convene the organizational meeting of the district at a location in the district agreeable to a majority of 18 the directors. If a location cannot be agreed upon, the 19 organizational meeting shall be at the Collin County Courthouse. 20 21 Sec. 6907.023. CONFIRMATION AND INITIAL DIRECTORS' ELECTION. The temporary board shall hold an election to confirm the 22 creation of the district and to elect five directors as provided by 23 24 Section 49.102, Water Code. Sec. 6907.024. INITIAL ELECTED DIRECTORS; TERMS. The 25 directors elected under Section 6907.023 shall draw lots to 26

- 16 59, Article XVI, Texas Constitution.
- 17 Sec. 6907.102. DRAINAGE PROJECTS. The district may
- 18 purchase, construct, acquire, own, operate, maintain, repair, or
- 19 improve all works, improvements, facilities, plants, equipment,
- 20 and appliances necessary to gather, conduct, divert, and control
- 21 local stormwater or other local harmful excesses of water in a
- 22 district.
- Sec. 6907.103. CONTRACT WITH POLITICAL SUBDIVISION FOR
- 24 WATER OR SEWER SERVICES. (a) The district may contract to allow a
- 25 political subdivision to provide retail water or sewer service in
- 26 the district. The contract may contain terms the board considers
- 27 desirable, fair, and advantageous to the district.

- 1 (b) The contract may require the district to construct or 2 acquire and convey or lease to the political subdivision a water
- 3 supply or treatment system, a water distribution system, or a
- 4 sanitary sewage collection or treatment system, as necessary to
- 5 provide water or sewer service in the district.
- 6 (c) The district may use bond proceeds or other available
- 7 <u>district money to pay for its obligations and for services and</u>
- 8 facilities provided under the contract.
- 9 (d) If the contract requires the district to make payments
- 10 from taxes other than operation and maintenance taxes, the contract
- is subject to Section 49.108, Water Code.
