5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws

9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 8219.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the board of directors of the
12	district.
13	(2) "Director" means a member of the board.
14	(3) "District" means the Harris County Municipal
15	Utility District No. 508.
16	Sec. 8219.002. NATURE OF DISTRICT. The district is a
17	municipal utility district in Harris County created under and
18	essential to accomplish the purposes of Section 59, Article XVI,
19	Texas Constitution.
20	Sec. 8219.003. CONFIRMATION ELECTION REQUIRED. If the
21	creation of the district is not confirmed at a confirmation
22	election held under Section 8219.024 before September 1, 2011:

(1) the district is dissolved September 1, 2011,

1	(A) any debts incurred shall be paid;
2	(B) any assets that remain after the payment of
3	debts shall be transferred to Harris County; and
4	(C) the organization of the district shall be
5	maintained until all debts are paid and remaining assets are

7	(2) this chapter expires September 1, 2014.
8	Sec. 8219.004. INITIAL DISTRICT TERRITORY. (a) The
9	district is initially composed of the territory described by
10	Section 2 of the Act creating this chapter.
11	(b) The boundaries and field notes contained in Section 2 of
12	the Act creating this chapter form a closure. A mistake made in the
13	field notes or in copying the field notes in the legislative process
14	<pre>does not affect:</pre>
15	(1) the organization, existence, or validity of the
16	<pre>district;</pre>
17	(2) the right of the district to impose taxes;
18	(3) the validity of the district's bonds, notes, or
19	indebtedness; or
20	(4) the legality or operation of the district or the
21	board.

23	SUBCHAPTER A1. TEMPORARY PROVISIONS
24	Sec. 8219.021. TEMPORARY DIRECTORS. (a) On or after
25	September 1, 2007, a person who owns land in the district may submit

27	requesting that the commission appoint as temporary directors the

- 2 (b) The commission shall appoint as temporary directors the
- 3 five persons named in the first petition received by the commission

- 16 agreeable to a majority of the directors. At the meeting, the
- 17 temporary directors shall elect officers from among the temporary
- 18 directors and conduct any other district business.
- 19 Sec. 8219.023. CONSENT OF MUNICIPALITY REQUIRED. The
- temporary directors may not hold an election under Section 8219.024
- 21 until each municipality in whose corporate limits or
- 22 extraterritorial jurisdiction the district is located, if any, has
- 23 adopted a resolution consenting to the creation of the district.
- Sec. 8219.024. CONFIRMATION AND INITIAL DIRECTORS'
- 25 ELECTION. The temporary directors shall hold an election to
- 26 confirm the creation of the district and to elect five directors as
- 27 provided by Section 49.102, Water Code.

Sec. 8219.025. INITIAL ELECTED DIRECTORS; TERMS. The 1 2 directors elected under Section 8219.024 shall draw lots to determine which two shall serve until the first regularly scheduled 3 4 election of directors under Section 8219.052 and which three shall 5 serve until the second regularly scheduled election of directors. 6 Sec. 8219.026. EXPIRATION OF SUBCHAPTER. This subchapter 7 expires September 1, 2014. 8 [Sections 8219.027-8219.050 reserved for expansion] 9 SUBCHAPTER B. BOARD OF DIRECTORS Sec. 8219.051. DIRECTORS; TERMS. (a) The district is 10 governed by a board of five directors. 11 12 (b) Directors serve staggered four-year terms. Sec. 8219.052. ELECTION OF DIRECTORS. On the uniform 13 14 election date in May of each even-numbered year, the appropriate 15 number of directors shall be elected. 16 [Sections 8219.053-8219.100 reserved for expansion] SUBCHAPTER C. POWERS AND DUTIES 17 Sec. 8219.101. MUNICIPAL UTILITY DISTRICT POWERS 18 DUTIES. The district has the powers and duties provided by the 19 general law of this state, including Chapters 49 and 54, Water Code, 20 21 applicable to municipal utility districts created under Section 59, 22 Article XVI, Texas Constitution. Sec. 8219.102. ROAD PROJECTS. (a) To the extent authorized 23 24 by Section 52, Article III, Texas Constitution, the district may

construct, acquire, improve, maintain, or operate macadamized,

graveled, or paved roads or turnpikes, or improvements in aid of

those roads or turnpikes, inside the district.

- (b) A road project must meet all applicable construction 1 2 standards, zoning and subdivision requirements, and regulatory 3 ordinances or orders of each municipality in whose corporate limits 4 or extraterritorial jurisdiction the district is located. If the 5 district is located outside the extraterritorial jurisdiction of a 6 municipality, a road project must meet all applicable construction 7 standards, zoning and subdivision requirements, and regulatory 8 ordinances of each county in which the district is located.
- 9 <u>(c) The district may not undertake a road project unless</u>
 10 <u>each municipality in whose corporate limits or extraterritorial</u>
 11 <u>jurisdiction the district is located consents by ordinance or</u>
 12 resolution.
- Sec. 8219.103. DIVISION OF DISTRICT. (a) The district may
 be divided into two new districts only if the district:
- 15 (1) has no outstanding bonded debt; and
- 16 (2) is not imposing ad valorem taxes.
- 17 (b) The division procedure is prescribed by Sections 53.030 18 through 53.041, Water Code.
- (c) Any new district created by the division of the district
 has all the powers and duties of the district.
- 21 (d) At the time of creation, any new district created by the 22 division of the district may not contain any land outside the area 23 described by Section 2 of the Act creating this chapter.
- 24 <u>Sec. 8219.104. COMPLIANCE WITH MUNICIPAL CONSENT</u>
 25 <u>ORDINANCES OR RESOLUTIONS. The district shall comply with all</u>
 26 applicable requirements of any ordinance or resolution adopted by
- 27 the city council of the City of Baytown.

The district may impose 3 a tax to pay the principal of or interest on bonds or other 4 5 obligations issued under Section 8219.201. 6 [Sections 8219.152-8219.200 reserved for expansion] SUBCHAPTER E. BONDS 7 Sec. 8219.201. AUTHORITY TO ISSUE BONDS AND OTHER 8 OBLIGATIONS. (a) The district may issue bonds or other obligations 9 as provided by Chapters 49 and 54, Water Code, to finance the 10 construction, maintenance, or operation of a project under Section 11 12 8219.101 or 8219.102. (b) The district may not issue bonds or other obligations to 13 14 finance projects authorized by Section 8219.102 unless the issuance 15 is approved by a vote of a two-thirds majority of the district voters voting at an election called for that purpose. 16 17 (c) Bonds or other obligations issued or incurred to finance projects authorized by Section 8219.102 may not exceed one-fourth 18 of the assessed value of the real property in the district. 19 SECTION 2.
