H.B. No. 4033

A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Ledbetter Utility District No. 1 of Kaufman and Rockwall Counties; providing authority to impose a tax and issue bonds; granting the power of eminent domain.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8220 to read as follows:

CHAPTER 8220. LEDBETTER UTILITY DISTRICT NO. 1 OF KAUFMAN AND ROCKWALL COUNTIES

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 8220.001. DEFINITIONS. In this chapter:

(1) "Board" means the district's board of directors.

(2) "Director" means a board member.

(3) "District" means the Ledbetter Utility District No. 1 of Kaufman and Rockwall Counties.

Sec. 8220.002. NATURE OF DISTRICT. The district is a municipal utility district in Kaufman and Rockwall Counties created under and essential to accomplish the purposes of Section 52, Article III, and Section 59, Article XVI, Texas Constitution.

Sec. 8220.003. CONFIRMATION ELECTION REQUIRED. If the creation of the district is not confirmed at a confirmation election held under Section 8220.024 before September 1, 2011:

(1) the district is dissolved September 1, 2011, except that the district shall:

1 (A) pay any debts incurred;

2 (B) transfer equally to Kaufman and Rockwall
3 Counties any assets that remain after the payment of debts; and

4 (C) maintain the organization of the district
5 until all debts are paid and remaining assets are transferred; and

6 (2) this chapter expires September 1, 2014.

7 Sec. 8220.004. INITIAL DISTRICT TERRITORY. (a) The
8 district is initially composed of the territory described by
9 Section 2 of the Act creating this chapter.

10 (b) The boundaries and field notes contained in Section 2 of
11 the Act creating this chapter form a closure. A mistake made in the
12 field notes or in copying the field notes in the legislative process
13 does not affect:

14 (1) the organization, existence, or validity of the
15 district;

16 (2) the right of the district to impose taxes;

17 (3) the validity of the district's bonds, notes, or
18 indebtedness; or

19 (4) the legality or operation of the district or the
20 board.

22 SUBCHAPTER A-1. TEMPORARY PROVISIONS

23 Sec. 8220.021. TEMPORARY DIRECTORS. (a) On or after
24 September 1, 2007, a person who owns land in the district may submit
25 a petition to the Texas Commission on Environmental Quality
26 requesting that the commission appoint as temporary directors the
27 five persons named in the petition.

1 (b) The commission shall appoint as temporary directors the
2 five persons named in the first petition received by the commission
3 under Subsection (a).

4 (c) If a temporary director fails to qualify for office, the
5 commission shall appoint a person to fill the vacancy.

6 (d) Temporary directors serve until the earlier of:

7 (1) the date directors are elected under Section
8 8220.024; or

9 (2) the date this chapter expires under Section
10 8220.003.

11 Sec. 8220.022. ORGANIZATIONAL MEETING OF TEMPORARY
12 DIRECTORS. As soon as practicable after all the temporary
13 directors have qualified under Section 49.055, Water Code, the
14 temporary directors shall meet at a location in the district
15 agreeable to a majority of the directors. At the meeting, the
16 temporary directors shall elect officers from among the temporary
17 directors and conduct any other district business.

18 Sec. 8220.023. CONSENT OF MUNICIPALITY REQUIRED. The
19 temporary directors may not hold an election under Section 8220.024
20 until each municipality in whose corporate limits or
21 extraterritorial jurisdiction the district is located has adopted a
22 resolution consenting to the creation of the district.

23 Sec. 8220.024. CONFIRMATION AND INITIAL DIRECTORS'
24 ELECTION. The temporary directors shall hold an election to
25 confirm the creation of the district and to elect five directors as
26 provided by Section 49.102, Water Code.

27 Sec. 8220.025. INITIAL ELECTED DIRECTORS; TERMS. The

1 directors elected under Section 8220.024 shall draw lots to
2 determine which two shall serve until the first regularly scheduled
3 election of directors and which three shall serve until the second
4 regularly scheduled election of directors.

5 Sec. 8220.026. EXPIRATION OF SUBCHAPTER. This subchapter
6 expires September 1, 2014.

7 [Sections 8220.027-8220.050 reserved for expansion]

8 SUBCHAPTER B. BOARD OF DIRECTORS

9 Sec. 8220.051. GOVERNING BODY; TERMS. (a) The district is
10 governed by a board of five directors.

11 (b) Directors serve staggered four-year terms.

12 [Sections 8220.052-8220.100 reserved for expansion]

13 SUBCHAPTER C. POWERS AND DUTIES

14 Sec. 8220.101. MUNICIPAL UTILITY DISTRICT POWERS AND
15 DUTIES. The district has the powers and duties provided by the
16 general law of this state, including Chapters 49 and 54, Water Code,
17 applicable to municipal utility districts created under Section 59,
18 Article XVI, Texas Constitution.

19 Sec. 8220.102. ROAD PROJECTS. (a) To the extent authorized
20 by Section 52, Article III, Texas Constitution, the district may
21 construct, acquire, improve, maintain, or operate macadamized,
22 graveled, or paved roads or turnpikes, or improvements in aid of
23 those roads or turnpikes, inside the district.

24 (b) A road project must meet all applicable construction
25 standards, zoning and subdivision requirements, and regulations of
26 each municipality in whose corporate limits or extraterritorial
27 jurisdiction the district is located.

1 (c) The district may not undertake a road project unless
2 each municipality in whose corporate limits or extraterritorial
3 jurisdiction the district is located consents by ordinance or
4 resolution.

5 Sec. 8220.103. DIVISION OF DISTRICT. (a) The district may
6 be divided into two new districts only if the district:

7 (1) has no outstanding bonded debt; and

8 (2) is not imposing ad valorem taxes.

9 (b) The division procedure is prescribed by Sections 53.030
10 through 53.041, Water Code.

11 (c) Any new district created by the division of the district
12 has all the powers and duties of the district.

13 (d) Any new district created by the division of the district
14 may not, at the time the new district is created, contain any land
15 outside the area described by Section 2 of the Act creating this
16 chapter.

17 [Sections 8220.104-8220.150 reserved for expansion]

18 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

19 Sec. 8220.151. TAX TO REPAY BONDS. The district may impose
20 a tax to pay the principal of or interest on bonds or other
21 obligations issued under Section 8220.201.

22 Sec. 8220.152. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
23 ASSESSMENTS. The district may not impose an impact fee or
24 assessment on the property, including the equipment,
25 rights-of-way, facilities, or improvements, of:

26 (1) an electric utility or a power generation company
27 as defined by Section 31.002, Utilities Code;

1 (2) a gas utility as defined by Section 101.003 or
2 121.001, Utilities Code;

3 (3) a telecommunications provider as defined by
4 Section 51.002, Utilities Code; or

5 (4) a person who provides to the public cable
6 television or advanced telecommunications services.

7 [Sections 8220.153-8220.200 reserved for expansion]

8 SUBCHAPTER E. BONDS

9 Sec. 8220.201. AUTHORITY TO ISSUE BONDS AND OTHER
10 OBLIGATIONS. (a) The district may issue bonds or other obligations
11 as provided by Chapters 49 and 54, Water Code, to finance the
12 construction, maintenance, or operation of a project under Section
13 8220.101 or 8220.102.

14 (b) The district may not issue bonds or other obligations to
15 finance projects authorized by Section 8220.102 unless the issuance
16 is approved by a vote of a two-thirds majority of the district
17 voters voting at an election called for that purpose.

18 (c) Bonds or other obligations issued or incurred to finance
19 projects authorized by Section 8220.102 may not exceed one-fourth
20 of the assessed value of the real property in the district.

21 SECTION 2. The Ledbetter Utility District No. 1 of Kaufman
22 and Rockwall Counties includes all the territory contained in the

16 SECTION 3. (a) The legal notice of the intention to
17 introduce this Act, setting forth the general substance of this
18 Act, has been published as provided by law, and the notice and a
19 copy of this Act have been furnished to all persons, agencies,
20 officials, or entities to which they are required to be furnished
21 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
22 Government Code.

23 (b) The governor, one of the required recipients, has
24 submitted the notice and Act to the Texas Commission on
25 Environmental Quality.

26 (c) The Texas Commission on Environmental Quality has filed
27 its recommendations relating to this Act with the governor, the

1 lieutenant governor, and the speaker of the house of
2 representatives within the required time.

3 (d) All requirements of the constitution and laws of this
4 state and the rules and procedures of the legislature with respect
5 to the notice, introduction, and passage of this Act are fulfilled
6 and accomplished.

7 SECTION 4. This Act takes effect September 1, 2007.
