2	relating to the creation of the Ledbetter Utility District No. 2 of
3	Kaufman and Rockwall Counties; providing authority to impose a tax
4	and issue bonds; granting the power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8246 to read as follows:
8	CHAPTER 8246. LEDBETTER UTILITY DISTRICT NO. 2 OF KAUFMAN AND
9	ROCKWALL COUNTIES
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8246.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the district's board of directors.
13	(2) "Director" means a board member.
14	(3) "District" means the Ledbetter Utility District
15	No. 2 of Kaufman and Rockwall Counties.
16	Sec. 8246.002. NATURE OF DISTRICT. The district is a
17	municipal utility district in Kaufman and Rockwall Counties created
18	under and essential to accomplish the purposes of Section 52,
19	Article III, and Section 59, Article XVI, Texas Constitution.
20	Sec. 8246.003. CONFIRMATION ELECTION REQUIRED. If the
21	creation of the district is not confirmed at a confirmation
22	election held under Section 8246.024 before September 1, 2011:
23	(1) the district is dissolved September 1, 2011,
24	except that the district shall:

1	(A) pay any debts incurred;
2	(B) transfer equally to Kaufman and Rockwall
3	Counties any assets that remain after the payment of debts; and
4	(C) maintain the organization of the district
5	until all debts are paid and remaining assets are transferred; and
6	(2) this chapter expires September 1, 2014.
7	Sec. 8246.004. INITIAL DISTRICT TERRITORY. (a) The
8	district is initially composed of the territory described by
9	Section 2 of the Act creating this chapter.
10	(b) The boundaries and field notes contained in Section 2 of
11	the Act creating this chapter form a closure. A mistake made in the
12	field notes or in copying the field notes in the legislative process
13	<pre>does not affect:</pre>
14	(1) the organization, existence, or validity of the
15	district;
16	(2) the right of the district to impose taxes;
17	(3) the validity of the district's bonds, notes, or
18	indebtedness; or
19	(4) the legality or operation of the district or the
20	board.

22	SUBCHAPTER A-1. TEMPORARY PROVISIONS
23	Sec. 8246.021. TEMPORARY DIRECTORS. (a) On or after
24	September 1, 2007, a person who owns land in the district may submit
25	a petition to the Texas Commission on Environmental Quality
26	requesting that the commission appoint as temporary directors the
27	five persons named in the petition.

- 1 (b) The commission shall appoint as temporary directors the
- 2 five persons named in the first petition received by the commission
- 3 under Subsection (a).
- 4 (c) If a temporary director fails to qualify for office, the
- 5 commission shall appoint a person to fill the vacancy.
- 6 (d) Temporary directors serve until the earlier of:
- 7 (1) the date directors are elected under Section
- 8 8246.024; or
- 9 (2) the date this chapter expires under Section
- 10 8246.003.
- 11 Sec. 8246.022. ORGANIZATIONAL MEETING OF TEMPORARY
- 12 DIRECTORS. As soon as practicable after all the temporary
- 13 directors have qualified under Section 49.055, Water Code, the
- 14 temporary directors shall meet at a location in the district
- 15 agreeable to a majority of the directors. At the meeting, the
- 16 temporary directors shall elect officers from among the temporary
- 17 directors and conduct any other district business.
- 18 Sec. 8246.023. CONSENT OF MUNICIPALITY REQUIRED. The
- temporary directors may not hold an election under Section 8246.024
- 20 until each municipality in whose corporate limits or
- 21 extraterritorial jurisdiction the district is located has adopted a
- 22 resolution consenting to the creation of the district.
- Sec. 8246.024. CONFIRMATION AND INITIAL DIRECTORS'
- 24 ELECTION. The temporary directors shall hold an election to
- 25 confirm the creation of the district and to elect five directors as
- 26 provided by Section 49.102, Water Code.
- Sec. 8246.025. INITIAL ELECTED DIRECTORS; TERMS. The

- 1 directors elected under Section 8246.024 shall draw lots to
- 2 determine which two shall serve until the first regularly scheduled
- 3 election of directors and which three shall serve until the second
- 4 regularly scheduled election of directors.
- 5 Sec. 8246.026. EXPIRATION OF SUBCHAPTER. This subchapter
- 6 expires September 1, 2014.
- 7 [Sections 8246.027-8246.050 reserved for expansion]
- 8 SUBCHAPTER B. BOARD OF DIRECTORS
- 9 Sec. 8246.051. GOVERNING BODY; TERMS. (a) The district is
- 10 governed by a board of five directors.
- 11 (b) Directors serve staggered four-year terms.
- 12 [Sections 8246.052-8246.100 reserved for expansion]
- SUBCHAPTER C. POWERS AND DUTIES
- 14 Sec. 8246.101. MUNICIPAL UTILITY DISTRICT POWERS AND
- 15 DUTIES. The district has the powers and duties provided by the
- 16 general law of this state, including Chapters 49 and 54, Water Code,
- applicable to municipal utility districts created under Section 59,
- 18 Article XVI, Texas Constitution.
- 19 Sec. 8246.102. ROAD PROJECTS. (a) To the extent authorized
- 20 by Section 52, Article III, Texas Constitution, the district may
- 21 construct, acquire, improve, maintain, or operate macadamized,
- 22 graveled, or paved roads or turnpikes, or improvements in aid of
- those roads or turnpikes, inside the district.
- 24 (b) A road project must meet all applicable construction
- 25 standards, zoning and subdivision requirements, and regulations of
- 26 each municipality in whose corporate limits or extraterritorial
- 27 jurisdiction the district is located.

- 1 (c) The district may not undertake a road project unless
- 2 each municipality in whose corporate limits or extraterritorial
- 3 jurisdiction the district is located consents by ordinance or
- 4 resolution.
- 5 Sec. 8246.103. DIVISION OF DISTRICT. (a) The district may
- 6 be divided into two new districts only if the district:
- 7 (1) has no outstanding bonded debt; and
- 8 (2) is not imposing ad valorem taxes.
- 9 (b) The division procedure is prescribed by Sections 53.030
- through 53.041, Water Code.
- 11 (c) Any new district created by the division of the district
- 12 has all the powers and duties of the district.
- 13 (d) Any new district created by the division of the district
- 14 may not, at the time the new district is created, contain any land
- outside the area described by Section 2 of the Act creating this
- 16 <u>chapter.</u>

- 18 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

- 26 (1) an electric utility or a power generation company
- 27 as defined by Section 31.002, Utilities Code;

- 8 SUBCHAPTER E. BONDS
- 9 Sec. 8246.201. AUTHORITY TO ISSUE BONDS AND OTHER
- OBLIGATIONS. (a) The district may issue bonds or other obligations
- 11 as provided by Chapters 49 and 54, Water Code, to finance the
- 12 construction, maintenance, or operation of a project under Section
- 13 8246.101 or 8246.102.
- 14 (b) The district may not issue bonds or other obligations to
- finance projects authorized by Section 8246.102 unless the issuance
- 16 <u>is approved by a vote of a two-thirds majority of the district</u>
- 17 voters voting at an election called for that purpose.
- 18 (c) Bonds or other obligations issued or incurred to finance
- 19 projects authorized by Section 8246.102 may not exceed one-fourth
- of the assessed value of the real property in the district.
