In this chapter: 11 12 (1) "Board" means the board of directors of the 13 district. 14 (2) "District" means the Galveston Grand Beach 15 Management District. 16 Sec. 3856.002. GALVESTON GRAND BEACH MANAGEMENT DISTRICT. The district is a special district created under Section 59, 17 18 Article XVI, Texas Constitution. Sec. 3856.003. PURPOSE; DECLARATION OF INTENT. (a) The 19 creation of the district is essential to accomplish the purposes of 20 21 Sections 52 and 52-a, Article III, and Section 59, Article XVI, Texas Constitution, and other public purposes stated in this 22 23 chapter. By creating the district and in authorizing the City of Galveston, Galveston County, and other political subdivisions to 24

No. 4053 contract with the district, the legislature has established a 1 2 program to accomplish the public purposes set out in Section 52-a, Article III, <u>Texas Constitution</u>. 3 4 (b) The creation of the district is necessary to promote, develop, encourage, and maintain employment, commerce, 5 6 transportation, housing, tourism, recreation, the arts, 7 entertainment, economic development, safety, and the public welfare in the <u>district</u>. 8 9 (c) This chapter and the creation of the district may not be interpreted to relieve the City of Galveston or Galveston County 10 from providing the level of services provided as of the effective 11 12 date of the Act enacting this chapter to the area in the district. The district is created to supplement and not to supplant the county 13 14 or city services provided in the area in the district. 15 Sec. 3856.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a) 16 The district is created to serve a public use and benefit. 17 (b) All land and other property included in the district will benefit from the improvements and services to be provided by 18 the district under powers conferred by Sections 52 and 52-a, 19 Article III, and Section 59, Article XVI, Texas Constitution, and 20 21 other powers granted under this chapter. (c) The creation of the district is in the public interest 22 23 and is essential to: 24 (1) further the public purposes of developing and 25 diversifying the economy of the state; 26 (2) eliminate unemployment and underemployment; and 27 (3) develop or expand transportation and commerce.

1	(d) The district will:
2	(1) promote the health, safety, and general welfare of

CONFLICTS OF INTEREST; ONE-TIME AFFIDAVIT. 8 (a) Except as provided by this section: 9 (1) a director may participate in all board votes and 10 decisions; and (2) Chapter 171, Local Government Code, governs 11 12 conflicts of interest for directors. (b) Section 171.004, Local Government Code, does not apply 13 to the district. A director who has a substantial interest in a 14 15 business or charitable entity that will receive a pecuniary benefit 16 from a board action shall file a one-time affidavit declaring the 17 interest. An additional affidavit is not required if the director's interest changes. Sec. 3856.105. COMPETITIVE BIDDING. Section 375.221, Local 13 Government Code, applies to the district only for a contract that 14 15 has a value greater than \$25,000. Sec. 3856.106. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. In addition to the authority to 8 9 annex territory under Subchapter C, Chapter 375, Local Government Code, the district may annex territory in a reinvestment zone 10 created by the City of Galveston under Chapter 311, Tax Code, if the 11 12 city's governing body consents to the annexation. Sec. 3856.109. NO EMINENT DOMAIN. The district may not 13 14 exercise the power of eminent domain. [Sections 3856.110-3856.150 reserved for expansion] 15 16 SUBCHAPTER D. The dissolution is effective when all debts 3 have bee<u>n discharged.</u> 4 5 (b) Section 375.264, Local Government Code, does not apply 6 to the district. SECTION 2. BOUNDARIES. As of the effective date of this 7 8 Act, the Galveston Grand Beach Management District encompasses 9 approximately 456 acres and includes all territory contained in the 10 following described area: BEGINNING at the intersection of the Northeasterly corner of the 11 Southerly right-of-way line of East Seawall Blvd. and the Northerly 12 right-of-way line of Apfell Park Dr.; 13 14 THENCE proceeding in a Northeasterly direction along the 15 Southeasterly right-of-way line of East Seawall Blvd. to a point representing the Westerly projection of a certain 5.9620 acre shown 16 17 in the deed records as the West Part of Reserve C (3-2) Grand Beach; THENCE in an Easterly direction along said projection to a point at 18 the intersection of the Westerly right-of-way line of Apffel Park 19 Dr.; 20 21 THENCE in an Northeasterly direction along said right-of-way to the Northwesterly corner of a certain 33.5829 acre tract shown in the 22 deed records as Reserve F Grand Beach; 23 24 THENCE in an Easterly direction along the Northerly property line 25 of said tract to the intersection of the Westerly right-of-way line 26 of Apffel Park Dr.; THENCE in an Easterly direction along the Northern right-of-way 27

line of Apffel Park Dr. to a point representing the Easterly projection of said right-of-way and its intersection with the Northeasterly projection of the property line of a certain 20 acre tract shown in the deed records as Reserve G (7-2) Grand Beach;

5 THENCE in a Southwesterly direction to a point at the Southwesterly 6 corner of a certain 24.6649 acre tract shown in the deed records as 7 Part of Reserve I (9-1) Grand Beach;

8 THENCE in a Northwesterly direction to a point at the intersection 9 of Southerly right of way line of East Seawall Blvd.;

10 THENCE in a North Easterly direction along the Southerly 11 right-of-way line of East Seawall Blvd. to the POINT OF BEGINNING.

PROVIDED; HOWEVER, that such boundaries shall specifically exclude those properties currently known as the Islander East Condominiums and the Galvestonian unless such property is later annexed pursuant to the provisions of this Act.

16 SECTION 3. LEGISLATIVE FINDINGS. The legislature finds 17 that:

(1) proper and legal notice of the intention to 18 introduce this Act, setting forth the general substance of this 19 Act, has been published as provided by law, and the notice and a 20 21 copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished by 22 the constitution and laws of this state, including the governor, 23 24 who has submitted the notice and Act to the Texas Commission on 25 Environmental Quality;

(2) the Texas Commission on Environmental Quality has
filed its recommendations relating to this Act with the governor,

C.S.H.B. No. 4053 1 lieutenant governor, and speaker of the house of representatives 2 within the required time;

3 (3) the general law relating to consent by political 4 subdivisions to the creation of districts with conservation, 5 reclamation, and road powers and the inclusion of land in those 6 districts has been complied with; and

7 (4) all requirements of the constitution and laws of 8 this state and the rules and procedures of the legislature with 9 respect to the notice, introduction, and passage of this Act have 10 been fulfilled and accomplished.

11 SECTION 4. EFFECTIVE DATE. This Act takes effect 12 immediately if it receives a vote of two-thirds of all the members 13 elected to each house, as provided by Section 39, Article III, Texas 14 Constitution. If this Act does not receive the vote necessary for 15 immediate effect, this Act takes effect September 1, 2007.
