- Sec. 8247.003. CONFIRMATION ELECTION REQUIRED. The board 19
- shall hold an election to confirm the creation of the district as 20
- 21 provided by Section 49.102, Water Code.
- Sec. 8247.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a) 22
- 23 All land and other property included in the district will benefit
- 24 from the improvements and services to be provided by the district.

1	(b) The district is created to accomplish:
2	(1) the purposes of a municipal utility district as
3	provided by general law; and
4	(2) to the extent authorized by Section 52, Article
5	III, Texas Constitution, the construction, acquisition,
6	improvement, maintenance, or operation of macadamized, graveled,
7	or paved roads, or improvements in aid of those roads.
8	Sec. 8247.005. INITIAL DISTRICT TERRITORY. (a) The

- 17 state and the rules and procedures of the legislature with respect
- 18 to the notice, introduction, and passage of this Act are fulfilled
- 19 and accomplished.
- 20 SECTION 4. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2007.
