| 10 | Sec. 8190.001. DEFINITIONS. In this chapter: |
| 11 | (1) "Board" means the district's board of directors. |
| 12 | (2) "Director" means a board member. |
| 13 | (3) "District" means the Denton County Municipal |
| 14 | Utility District No. 7. |
| 15 | Sec. 8190.002. NATURE OF DISTRICT. The district is a |
| 16 | municipal utility district in Denton County created under and |
| 17 | essential to accomplish the purposes of Section 52, Article III, |
| 18 | and Section 59, Article XVI, Texas Constitution. |
| 19 | Sec. 8190.003. FINDING OF PUBLIC USE AND BENEFIT. The |
| 20 | district is created to serve a public use and benefit. |
| 21 | Sec. 8190.004. CONFIRMATION ELECTION REQUIRED. If the |
| 22 | creation of the district is not confirmed at a confirmation |
| 23 | election held under Section 8190.023 before September 1, 2011: |
| 24 | (1) the district is dissolved September 1. 2011. |

| 8 | Sec. 8190.005. INITIAL DISTRICT TERRITORY. (a) The |
| 9 | district is initially composed of the territory described by |
| 10 | Section 2 of the Act creating this chapter. |
| 11 | (b) The boundaries and field notes contained in Section 2 of |
| 12 | the Act creating this chapter form a closure. A mistake made in the |
| 13 | field notes or in copying the field notes in the legislative process |
| 14 | does not affect: |
| 15 | (1) the organization, existence, or validity of the |
| 16 | district; |
| 17 | (2) the right of the district to impose taxes; or |
| 18 | (3) the legality or operation of the board. |

| 20 | SUBCHAPTER A-1. TEMPORARY PROVISIONS |

- 13 temporary directors shall convene the organizational meeting of the
- 14 district at a location in the district agreeable to a majority of
- 15 the directors. If a location cannot be agreed upon, the
- organizational meeting shall be at the Denton County Courthouse.
- 17 Sec. 8190.023. CONFIRMATION AND INITIAL DIRECTORS'
- 18 ELECTION. The temporary directors shall hold an election to
- 19 confirm the creation of the district and to elect five directors as
- 20 provided by Section 49.102, Water Code.
- 21 Sec. 8190.024. INITIAL ELECTED DIRECTORS; TERMS. The
- 22 <u>directors elected under Section 8190</u>.023 shall draw lots to
- 23 <u>determine which two shall serve until the first regularly scheduled</u>

- 25 regularly scheduled election of directors.

| 16 | (b) A road project must meet all applicable construction |
| 17 | standards, zoning and subdivision requirements, and regulations of |
| 18 | each municipality in whose corporate limits or extraterritorial |
| 19 | jurisdiction the district is located. If the district is not |

- under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 13 Government Code.
- 14 (b) The governor, one of the required recipients, has
- 15 submitted the notice and Act to the Texas Commission on
- 16 Environmental Quality.
- 17 (c) The Texas Commission on Environmental Quality has filed
- 18 its recommendations relating to this Act with the governor, the
- 19 lieutenant governor, and the speaker of the house of
- 20 representatives within the required time.
- 21 (d) All requirements of the constitution and laws of this
