H.B. No. 4073

A BILL TO BE ENTITLED

AN ACT

1
2 relating to the creation of the Montgomery County Municipal Utility
3 District No. 103; providing authority to impose taxes and issue
4 bonds.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Subtitle F, Title 6, Special District Local Laws
7 Code, is amended by adding Chapter 8262 to read as follows:

8 CHAPTER 8262. MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO. 103

9 SUBCHAPTER A. GENERAL PROVISIONS

10 Sec. 8262.001. DEFINITIONS. In this chapter:

11 (1) "Board" means the board of directors of the
12 district.

13 (2) "Director" means a member of the board.

14 (3) "District" means the Montgomery County Municipal
15 Utility District No. 103.

16 Sec. 8262.002. NATURE OF DISTRICT. The district is a
17 municipal utility district in Montgomery County created under and
18 essential to accomplish the purposes of Section 59, Article XVI,
19 Texas Constitution.

20 Sec. 8262.003. CONFIRMATION ELECTION REQUIRED. If the
21 creation of the district is not confirmed at a confirmation
22 election held under Section 8262.023 before September 1, 2015:

23 (1) the district is dissolved September 1, 2015,
24 except that the district shall:

1 (A) pay any debts incurred;

2 (B) transfer to Montgomery County any assets that
3 remain after the payment of debts; and

4 (C) maintain the organization of the district
5 until all debts are paid and remaining assets are transferred; and

6 (2) this chapter expires September 1, 2016.

7 Sec. 8262.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)

8 All land and other property included in the district will benefit
9 from the improvements and services to be provided by the district.

10 (b) The district is created to accomplish:

11 (1) the purposes of a municipal utility district as
12 provided by general law; and

13 (2) to the extent authorized by Section 52, Article
14 III, Texas Constitution, the construction, acquisition,
15 improvement, maintenance, or operation of arterial or main feeder
16 roads or improvements in aid of those roads.

17 Sec. 8262.005. INITIAL DISTRICT TERRITORY. (a) The
18 district is initially composed of the territory described by
19 Section 2 of the Act creating this chapter.

20 (b) The boundaries and field notes contained in Section 2 of
21 the Act creating this chapter form a closure. A mistake made in the
22 field notes or in copying the field notes in the legislative process
23 does not affect the district's:

24 (1) organization, existence, or validity;

25 (2) right to issue any type of bond for the purposes
26 for which the district is created or to pay the principal of and
27 interest on a bond;

1 (3) right to impose or collect an assessment or tax; or

2 (4) legality or operation.

4 SUBCHAPTER A-1. TEMPORARY PROVISIONS

5 Sec. 8262.021. TEMPORARY DIRECTORS. (a) The temporary
6 board consists of:

7 (1) Chris Corbin;

8 (2) Julie Collette;

9 (3) Michael Friedman;

10 (4) Gregg Esses; and

11 (5) Hance V. Myers III.

12 (b) Temporary directors serve until the earlier of:

13 (1) the date initial directors are elected under
14 Section 8262.023; or

15 (2) the date this subchapter expires under Section
16 8262.025.

17 Sec. 8262.022. ORGANIZATIONAL MEETING OF TEMPORARY
18 DIRECTORS. As soon as practicable after all the temporary
19 directors have qualified under Section 49.055, Water Code, the
20 temporary directors shall meet at a location in the district
21 agreeable to a majority of the directors. At the meeting, the
22 temporary directors shall elect officers from among the temporary
23 directors and conduct any other district business.

24 Sec. 8262.023. CONFIRMATION AND INITIAL DIRECTORS'
25 ELECTION. Not later than the second anniversary of the
26 organizational meeting held under Section 8262.022, the temporary
27 directors shall hold an election to confirm the creation of the

1 district and to elect five initial directors as provided by Section
2 49.102, Water Code.

3 Sec. 8262.024. INITIAL ELECTED DIRECTORS; TERMS. Unless
4 the initial board otherwise agrees, the directors elected under
5 Section 8262.023 shall draw lots to determine which two shall serve
6 until the first regularly scheduled election of directors under
7 Section 8262.052 and which three shall serve until the second
8 regularly scheduled election of directors.

9 Sec. 8262.025. EXPIRATION OF SUBCHAPTER. This subchapter
10 expires September 1, 2015.

11 [Sections 8262.026-8262.050 reserved for expansion]

12 SUBCHAPTER B. BOARD OF DIRECTORS

13 Sec. 8262.051. DIRECTORS; TERMS. (a) The district is
14 governed by a board of five directors.

15 (b) Except for temporary or initial directors, directors
16 serve staggered four-year terms.

17 Sec. 8262.052. ELECTION OF DIRECTORS. On the uniform
18 election date in May of each even-numbered year, the appropriate
19 number of directors shall be elected.

20 [Sections 8262.053-8262.100 reserved for expansion]

21 SUBCHAPTER C. POWERS AND DUTIES

22 Sec. 8262.101. MUNICIPAL UTILITY DISTRICT POWERS AND
23 DUTIES. (a) The district has the powers and duties provided by the
24 general law of this state, including Chapters 49 and 54, Water Code,
25 applicable to municipal utility districts created under Section 59,
26 Article XVI, Texas Constitution.

27 (b) The district has the powers and duties necessary to

1 accomplish the purposes for which the district is created.

2 Sec. 8262.102. ROAD PROJECTS. (a) To the extent authorized
3 by Section 52, Article III, Texas Constitution, the district may
4 acquire, construct, or finance a road that meets the criteria or
5 requirements for a thoroughfare, arterial, or collector road of the
6 county in which the road is located or the municipality in whose
7 corporate limits or extraterritorial jurisdiction the road is
8 located or improvements in aid of that road.

9 (b) A road project must meet all applicable standards,
10 regulations, and ordinances of the municipality or county in whose
11 jurisdiction the district is located.

12 Sec. 8262.103. RECREATIONAL FACILITIES; LIMIT ON EMINENT
13 DOMAIN POWER. (a) In this section, "recreational facilities" and
14 "develop and maintain" have the meanings assigned by Section
15 49.462, Water Code.

16 (b) The district may develop and maintain recreational
17 facilities.

18 (c) The district may not, for the development or maintenance
19 of a recreational facility, acquire by condemnation land, an
20 easement, or other property inside or outside the district.

21 Sec. 8262.104. COMPLIANCE WITH MUNICIPAL CONSENT
22 ORDINANCES OR RESOLUTIONS. Subject to the limitations of Section
23 54.016, Water Code, the district shall comply with all applicable
24 requirements of any ordinance or resolution adopted by the
25 governing body of the municipality that consents to the creation of
26 the district or to the inclusion of lands within the district.

1 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

2 Sec. 8262.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
3 district may issue, without an election, bonds and other
4 obligations secured by revenue or contract payments from any source
5 other than ad valorem taxation.

6 (b) The district must hold an election in the manner
7 provided by Chapters 49 and 54, Water Code, to obtain voter approval
8 before the district may impose an operation and maintenance tax or
9 issue bonds payable from ad valorem taxes.

10 Sec. 8262.152. OPERATION AND MAINTENANCE TAX. (a) If
11 authorized at an election held under Section 8262.151, the district
12 may impose an operation and maintenance tax on taxable property in
13 the district in accordance with Section 49.107, Water Code.

14 (b) The board shall determine the tax rate. The rate may not
15 exceed the rate approved at the election.

16 [Sections 8262.153-8262.200 reserved for expansion]

17 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

18 Sec. 8262.201. AUTHORITY TO ISSUE BONDS AND OTHER
19 OBLIGATIONS. The district may issue bonds or other obligations
20 payable wholly or partly from ad valorem taxes, impact fees,
21 revenue, grants, or other district money, or any combination of
22 those sources, to pay for any authorized district purpose.

23 Sec. 8262.202. BONDS FOR ROAD PROJECTS. (a) The district
24 may not issue bonds to finance projects authorized by Section
25 8262.102 unless the issuance is approved by a vote of a two-thirds
26 majority of the voters of the district voting at an election called
27 for that purpose.

1 (b) Bonds or other obligations issued or incurred to finance
2 projects authorized by Section 8262.102 may not exceed one-fourth
3 of the assessed value of the real property in the district.

4 Sec. 8262.203. BONDS FOR RECREATIONAL FACILITIES. If
5 authorized at an election under Section 8262.151, the district may
6 issue bonds payable from ad valorem taxes to pay for the development
7 and maintenance of recreational facilities.

8 Sec. 8262.204. TAXES FOR BONDS. At the time bonds payable
9 wholly or partly from ad valorem taxes are issued:

10 (1) the board shall impose a continuing direct annual
11 ad valorem tax, without limit as to rate or amount, for each year
12 that all or part of the bonds are outstanding; and

13 (2) the district annually shall impose an ad valorem
14 tax on all taxable property in the district in an amount sufficient
15 to:

16 (A) pay the interest on the bonds as the interest
17 becomes due;

18 (B) create a sinking fund for the payment of the
19 principal of the bonds when due or the redemption price at any
20 earlier required redemption date; and

21 (C) pay the expenses of imposing the taxes.

22 SECTION 2. The Montgomery County Municipal Utility District
23 No. 103 initially includes all the territory contained in the
24 following area:

27 land situated in the Joseph A. Parker Survey, Abstract Number 418,

1 in Montgomery County, Texas, and being a portion of that certain
2 call 1,554.570 acre tract described in a Warranty Deed to Pacific
3 Indio Properties, Inc. recorded in Clerk's File Number 2006-013955
4 of the Official Public Records of Real Property at Montgomery
5 County Texas (O.P.R.R.P.M.C.T.), and a portion of that certain call
6 877.775 acre tract described in a Warranty Deed to Pacific Indio
7 Properties, Inc. recorded in Clerk's File Number 2005-116796 of the
8 O.P.R.R.P.M.C.T., said 757.744 acre tract being more particularly
9 described by metes and bounds as follows: (All bearings are
10 referenced to the Texas State Plane Coordinate System, South
11 Central Zone)

12 BEGINNING at a 3/4 inch iron pipe found in the recognized north line
13 of said Joseph A. Parker Survey for the southeast corner of that
14 certain call 2,883.06 acre tract described in a Deed to LGI LAND,
15 L.L.C. in County Clerk's File Number 2004-114162 of the
16 O.P.R.R.P.M.C.T., an interior corner of said 1,554.570 acre tract,
17 and the southwest corner of the herein described tract, and from
18 which a 100D nail found for reference bears North 35 Degrees 02
19 Minutes 54 Seconds East, a distance of 12.69 feet, and from which a
20 "PK" nail found in a 4 inch wooden post bears South 51 Degrees 13
21 Minutes 29 Seconds West, a distance of 8.04 feet;

22 THENCE, through and across said 1554.570 acre tract and with the
23 recognized north line of said Joseph A. Parker Survey, North 50
24 Degrees 32 Minutes 13 Seconds East, a distance of 889.47 feet to an
25 angle point;

26 THENCE, departing the recognized north line of said Joseph A.
27 Parker Survey, and continuing through and across said 1554.570 acre

1 tract, South 87 Degrees 41 Minutes 21 Seconds East, a distance of
2 797.17 feet to a point in the proposed westerly right-of-way
3 (R.O.W.) line of Townsen Road (100 feet wide) for the northeast
4 corner of the herein described tract;

5 THENCE, continuing through and across said 1,554.570 acre tract,
6 through and across said 877.775 acre tract, respectively, and with
7 the westerly R.O.W. line of said proposed Townsen Road, the

20 the right having a radius of 1,950.00 feet, a central
21 angle of 42 Degrees 40 Minutes 43 Seconds, and a chord
22 that bears North 69 Degrees 20 Minutes 55 Seconds East,
23 a distance of 1,419.17 feet;

24 3) South 89 Degrees 18 Minutes 44 Seconds East, a
25 distance of 818.57 feet to the intersection of the
26 southerly line of said proposed 100 wide R.O.W. with the
27 westerly R.O.W. line of said proposed Townsen Road;

1 THENCE, continuing through and across said 877.775 acre tract and
2 with the westerly R.O.W. line of said proposed Townsen Road, the
3 following four (4) courses:

4 1) South 00 Degrees 41 Minutes 16 Seconds West, a
5 distance of 200.00 feet to the beginning of a curve to
6 the left;

7 2) 1,319.07 feet along the arc of said curve to
8 the left having a radius of 2,050.00 feet, a central
9 angle of 36 Degrees 52 Minutes 01 Second, and a chord
10 that bears South 17 Degrees 44 Minutes 44 Seconds East,
11 a distance of 1,296.43 feet;

12 3) South 36 Degrees 10 Minutes 45 Seconds East, a
13 distance of 425.92 feet to the beginning of a curve to
14 the right;

15 4) 84.00 feet along the arc of said curve to the
16 right having a radius of 1,950.00 feet, a central angle
17 of 02 Degrees 28 Minutes 05 Seconds, and a chord that
18 bears South 34 Degrees 56 Minutes 42 Seconds East, a
19 distance of 84.00 feet to the POINT OF BEGINNING and
20 containing 313.559 acres (13,658,610 square feet) of
21 land.

22 SECTION 3. (a) The legal notice of the intention to
23 introduce this Act, setting forth the general substance of this
24 Act, has been published as provided by law, and the notice and a
25 copy of this Act have been furnished to all persons, agencies,
26 officials, or entities to which they are required to be furnished
27 under Section 59, Article XVI, Texas Constitution, and Chapter 313,

1 Government Code.

2 (b) The governor, one of the required recipients, has
3 submitted the notice and Act to the Texas Commission on
4 Environmental Quality.

5 (c) The Texas Commission on Environmental Quality has filed
6 its recommendations relating to this Act with the governor, the
7 lieutenant governor, and the speaker of the house of
8 representatives within the required time.

9 (d) All requirements of the constitution and laws of this
10 state and the rules and procedures of the legislature with respect
11 to the notice, introduction, and passage of this Act are fulfilled
12 and accomplished.

13 SECTION 4. The legislature finds that:

14 (1) the Montgomery County Municipal Utility District
15 No. 103, as created by Chapter 8262, Special District Local Laws
16 Code, as added by this Act, is not officially created until
17 confirmed by a majority of the voters of the district voting at an
18 election held for that purpose;

19 (2) securing the consent of political subdivisions to
20 the creation of the district before the introduction or passage of
21 this Act may be impractical because of the uncertainties of the
22 legislative process; and

23 (3) the constitutional requirement for the district's
24 compliance with the provisions of the general laws relating to the
25 consent of political subdivisions to the creation of the district
26 and the inclusion of land within the district is satisfied if that
27 consent is secured before the date and hour of canvassing the

1 returns and declaring the results of the confirmation election.

2 SECTION 5. This Act takes effect immediately if it receives
3 a vote of two-thirds of all the members elected to each house, as
4 provided by Section 39, Article III, Texas Constitution. If this
5 Act does not receive the vote necessary for immediate effect, this
6 Act takes effect September 1, 2007.
