1-7 A BILL TO BE ENTITLED
1-8 AN ACT

1-9 relating to the creation of the Montgomery County Municipal Utility
1-10 District No. 117; providing authority to impose taxes and issue
1-11 bonds.

1-12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-13 SECTION 1. Subtitle F, Title 6, Special District Local Laws
1-14 Code, is amended by adding Chapter 8268 to read as follows:

1-15 CHAPTER 8268. MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO. 117

1-16 SUBCHAPTER A. GENERAL PROVISIONS

1-17 Sec. 8268.001. DEFINITIONS. In this chapter:

1-18 (1) "Board" means the board of directors of the
1-19 district.

1-20 (2) "Director" means a member of the board.

1-21 (3) "District" means the Montgomery County Municipal
1-22 Utility District No. 117.

1-23 Sec. 8268.002. NATURE OF DISTRICT. The district is a
1-24 municipal utility district in Montgomery County created under and
1-25 essential to accomplish the purposes of Section 59, Article XVI,
1-26 Texas Constitution.

1-27 Sec. 8268.003. CONFIRMATION ELECTION REQUIRED. If the
1-28 creation of the district is not confirmed at a confirmation
1-29 election held under Section 8268.023 before September 1, 2015:

1-30 (1) the district is dissolved September 1, 2015,
1-31 except that the district shall:

1-32 (A) pay any debts incurred;

1-33 (B) transfer to Montgomery County any assets that
1-34 remain after the payment of debts; and

1-35 (C) maintain the organization of the district
1-36 until all debts are paid and remaining assets are transferred; and

1-37 (2) this chapter expires September 1, 2016.

1-38 Sec. 8268.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)
1-39 All land and other property included in the district will benefit
1-40 from the improvements and services to be provided by the district.

1-41 (b) The district is created to accomplish:

1-42 (1) the purposes of a municipal utility district as
1-43 provided by general law; and

1-44 (2) to the extent authorized by Section 52, Article
1-45 III, Texas Constitution, the construction, acquisition,
1-46 improvement, maintenance, or operation of arterial or main feeder
1-47 roads or improvements in aid of those roads.

1-48 Sec. 8268.005. INITIAL DISTRICT TERRITORY. (a) The
1-49 district is initially composed of the territory described by
1-50 Section 2 of the Act creating this chapter.

1-51 (b) The boundaries and field notes contained in Section 2 of
1-52 the Act creating this chapter form a closure. A mistake made in the
1-53 field notes or in copying the field notes in the legislative process
1-54 does not affect the district's:

1-55 (1) organization, existence, or validity;

1-56 (2) right to issue any type of bond for the purposes
1-57 for which the district is created or to pay the principal of and
1-58 interest on a bond;

1-59 (3) right to impose or collect an assessment or tax; or

1-60 (4) legality or operation.

1-61 [Sections 8268.006-8268.020 reserved for expansion]

1-62 SUBCHAPTER A-1. TEMPORARY PROVISIONS

1-63 Sec. 8268.021. TEMPORARY DIRECTORS. (a) The temporary
1-64 board consists of:

- (1) Arthur J. Sullivan, III;
- (2) Linda Grant Jones;
- (3) James H. Pouns;
- (4) Lee Luper; and
- (5) Thomas Vann.

(b) Temporary directors serve until the earlier of:
(1) the date initial directors are elected under
Section 8268.023; or
(2) the date this subchapter expires under Section
8268.025.

Sec. 8268.022. ORGANIZATIONAL MEETING OF TEMPORARY
DIRECTORS. As soon as practicable after all the temporary
directors have qualified under Section 49.055, Water Code, the
temporary directors shall meet at a location in the district
agreeable to a majority of the directors. At the meeting, the
temporary directors shall elect officers from among the temporary
directors and conduct any other district business.

Sec. 8268.023. CONFIRMATION AND INITIAL DIRECTORS'
ELECTION. Not later than the second anniversary of the
organizational meeting held under Section 8268.022, the temporary
directors shall hold an election to confirm the creation of the
district and to elect five initial directors as provided by Section
49.102, Water Code.

Sec. 8268.024. INITIAL ELECTED DIRECTORS; TERMS. Unless
the initial board otherwise agrees, the directors elected under
Section 8268.023 shall draw lots to determine which two shall serve
until the first regularly scheduled election of directors under
Section 8268.052 and which three shall serve until the second
regularly scheduled election of directors.

Sec. 8268.025. EXPIRATION OF SUBCHAPTER. This subchapter
expires September 1, 2015.

SUBCHAPTER B. BOARD OF DIRECTORS

Sec. 8268.051. DIRECTORS; TERMS. (a) The district is
governed by a board of five directors.

(b) Except for temporary or initial directors, directors
serve staggered four-year terms.

Sec. 8268.052. ELECTION OF DIRECTORS. On the uniform
election date in May of each even-numbered year, the appropriate
number of directors shall be elected.

SUBCHAPTER C. POWERS AND DUTIES

Sec. 8268.101. MUNICIPAL UTILITY DISTRICT POWERS AND
DUTIES. (a) The district has the powers and duties provided by the
general law of this state, including Chapters 49 and 54, Water Code,
applicable to municipal utility districts created under Section 59,
Article XVI, Texas Constitution.

(b) The district has the powers and duties necessary to
accomplish the purposes for which the district is created.

Sec. 8268.102. ROAD PROJECTS. (a) To the extent authorized
by Section 52, Article III, Texas Constitution, the district may
acquire, construct, or finance a road that meets the criteria or
requirements for a thoroughfare, arterial, or collector road of the
county in which the road is located or the municipality in whose
corporate limits or extraterritorial jurisdiction the road is
located or improvements in aid of that road.

(b) A road project must meet all applicable standards,
regulations, and ordinances of the municipality or county in whose
jurisdiction the district is located.

Sec. 8268.103. RECREATIONAL FACILITIES; LIMIT ON EMINENT
DOMAIN POWER. (a) In this section, "recreational facilities" and
"develop and maintain" have the meanings assigned by Section
49.462, Water Code.

(b) The district may develop and maintain recreational
facilities.

(c) The district may not, for the development or maintenance
of a recreational facility, acquire by condemnation land, an
easement, or other property inside or outside the district.

Sec. 8268.104. COMPLIANCE WITH MUNICIPAL CONSENT

3-1 ORDINANCES OR RESOLUTIONS. Subject to the limitations of Section
3-2 54.016, Water Code, the district shall comply with all applicable
3-3 requirements of any ordinance or resolution adopted by the
3-4 governing body of the municipality that consents to the creation of
3-5 the district or to the inclusion of lands within the district.

3-6 [Sections 8268.105-8268.150 reserved for expansion]

3-7 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

3-8 Sec. 8268.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
3-9 district may issue, without an election, bonds and other
3-10 obligations secured by revenue or contract payments from any source
3-11 other than ad valorem taxation.

3-12 (b) The district must hold an election in the manner
3-13 provided by Chapters 49 and 54, Water Code, to obtain voter approval
3-14 before the district may impose an operation and maintenance tax or
3-15 issue bonds payable from ad valorem taxes.

3-16 Sec. 8268.152. OPERATION AND MAINTENANCE TAX. (a) If
3-17 authorized at an election held under Section 8268.151, the district
3-18 may impose an operation and maintenance tax on taxable property in
3-19 the district in accordance with Section 49.107, Water Code.

3-20 (b) The board shall determine the tax rate. The rate may not
3-21 exceed the rate approved at the election.

3-22 [Sections 8268.153-8268.200 reserved for expansion]

3-23 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

3-24 Sec. 8268.201. AUTHORITY TO ISSUE BONDS AND OTHER
3-25 OBLIGATIONS. The district may issue bonds or other obligations
3-26 payable wholly or partly from ad valorem taxes, impact fees,
3-27 revenue, grants, or other district money, or any combination of
3-28 those sources, to pay for any authorized district purpose.

3-29 Sec. 8268.202. BONDS FOR ROAD PROJECTS. (a) The district
3-30 may not issue bonds to finance projects authorized by Section
3-31 8268.102 unless the issuance is approved by a vote of a two-thirds
3-32 majority of the voters of the district voting at an election called
3-33 for that purpose.

3-34 (b) Bonds or other obligations issued or incurred to finance
3-35 projects authorized by Section 8268.102 may not exceed one-fourth
3-36 of the assessed value of the real property in the district.

3-37 Sec. 8268.203. BONDS FOR RECREATIONAL FACILITIES. If
3-38 authorized at an election under Section 8268.151, the district may
3-39 issue bonds payable from ad valorem taxes to pay for the development
3-40 and maintenance of recreational facilities.

3-41 Sec. 8268.204. TAXES FOR BONDS. At the time bonds payable
3-42 wholly or partly from ad valorem taxes are issued:

3-43 (1) the board shall impose a continuing direct annual
3-44 ad valorem tax, without limit as to rate or amount, for each year
3-45 that all or part of the bonds are outstanding; and

3-46 (2) the district annually shall impose an ad valorem
3-47 tax on all taxable property in the district in an amount sufficient
3-48 to:

3-49 (A) pay the interest on the bonds as the interest
3-50 becomes due;

3-51 (B) create a sinking fund for the payment of the
3-52 principal of the bonds when due or the redemption price at any
3-53 earlier required redemption date; and

3-54 (C) pay the expenses of imposing the taxes.

3-55 SECTION 2. The Montgomery County Municipal Utility District
3-56 No. 117 initially includes all the territory contained in the
3-57 following area:

10-48 officials, or entities to which they are required to be furnished
10-49 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
10-50 Government Code.

10-51 (b) The governor, one of the required recipients, has
10-52 submitted the notice and Act to the Texas Commission on
10-53 Environmental Quality.

10-54 (c) The Texas Commission on Environmental Quality has filed
10-55 its recommendations relating to this Act with the governor, the
10-56 lieutenant governor, and the speaker of the house of
10-57 representatives within the required time.

10-58 (d) All requirements of the constitution and laws of this
10-59 state and the rules and procedures of the legislature with respect
10-60 to the notice, introduction, and passage of this Act are fulfilled
10-61 and accomplished.

10-62 SECTION 4. The legislature finds that:

10-63 (1) the Montgomery County Municipal Utility District
10-64 No. 117, as created by Chapter 8268, Special District Local Laws
10-65 Code, as added by this Act, is not officially created until
10-66 confirmed by a majority of the voters of the district voting at an
10-67 election held for that purpose;

10-68 (2) securing the consent of political subdivisions to
10-69 the creation of the district before the introduction or passage of

11-1 this Act may be impractical because of the uncertainties of the
11-2 legislative process; and

11-3 (3) the constitutional requirement for the district's
11-4 compliance with the provisions of the general laws relating to the
11-5 consent of political subdivisions to the creation of the district
11-6 and the inclusion of land within the district is satisfied if that
11-7 consent is secured before the date and hour of canvassing the
11-8 returns and declaring the results of the confirmation election.

11-9 SECTION 5. This Act takes effect immediately if it receives
11-10 a vote of two-thirds of all the members elected to each house, as
11-11 provided by Section 39, Article III, Texas Constitution. If this
11-12 Act does not receive the vote necessary for immediate effect, this
11-13 Act takes effect September 1, 2007.
