## A BILL TO BE ENTITLED

AN ACT

2	relating to the creation, administration, powers, duties,
3	functions, operations, and financing of the Gastonia-Scurry
4	Special Utility District.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle C, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 720X to read as follows:
8	CHAPTER 720X. GASTONIA-SCURRY SPECIAL UTILITY DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 720X.001. DEFINITION. In this chapter, "district"
11	means the Gastonia-Scurry Special Utility District.
12	Sec. 720X.002. NATURE OF DISTRICT. The district is a
13	special utility district in Kaufman County created under and
14	essential to accomplish the purposes of Section 59, Article XVI,
15	Texas Constitution. The district is created to serve a public use
16	and benefit.
17	Sec. 720X.003. CONFIRMATION ELECTION REQUIRED. If the
18	creation of the district is not confirmed at a confirmation and
19	initial directors' election held before September 1, 2009:
20	(1) the district is dissolved on September 1, 2009,
21	<pre>except that:</pre>
22	(A) any debts of the district incurred shall be
23	<pre>paid;</pre>
2.4	(B) any assets of the district that remain after

- 1 the payment of debts shall be transferred to Kaufman County as
- 2 appropriate; and
- 3 (C) the organization of the district shall be
- 4 maintained until all debts are paid and remaining assets are
- 5 <u>transferred; and</u>
- 6 (2) this chapter expires September 1, 2012.
- 7 Sec. 720X.004. APPLICABILITY OF OTHER SPECIAL UTILITY
- 8 DISTRICT LAW. Except as otherwise provided by this chapter,
- 9 Chapters 49 and 65, Water Code, apply to the district.
- 10 Sec. 720X.005. INITIAL DISTRICT TERRITORY. (a) The
- 11 district is initially composed of the territory described by
- 12 Section 2 of the Act creating this chapter.
- 13 (b) The boundaries and field notes contained in Section 2 of
- 14 the Act creating this chapter form a closure. A mistake made in the
- 15 <u>field notes or in copying the field notes in the legislative process</u>
- 16 does not affect:
- 17 (1) the organization, existence, or validity of the
- 18 district;
- 19 (2) the right of the district to issue any type of
- 20 bond, including a refunding bond, for a purpose for which the
- 21 district is created or to pay the principal of and interest on a
- 22 bond; or
- 23 (3) the legality or operation of the district or the
- 24 board of directors of the district.
- 25 [Sections 720X.006-720X.020 reserved for expansion]
- SUBCHAPTER A-1. TEMPORARY PROVISIONS
- Sec. 720X.021. <u>TEMPORARY DIRECTORS</u>. (a) The temporary

board of directors of the district is composed of: 1 2 (1) Roger Roberts; 3 (2) Thomas Kintz; 4 (3) Rhonda Davenport; 5 (4) Carole Giddings; 6 (5) Angel McKinnon; 7 (6) Roger Brock; and 8 (7) Michael Reese. 9 (b) Each temporary director shall qualify for office as provided by Section 49.055, Water Code. 10 (c) If a temporary director fails to qualify for office, the 11 12 temporary directors who have qualified shall appoint a person to fill the vacancy. If at any time there are fewer than four 13 qualified temporary directors, the Texas Commission 14 on 15 Environmental Quality shall appoint the necessary number of directors to fill all vacancies on the board. 16 17 (d) Temporary directors serve until initial directors are elected under Section 720X.022. 18 (e) ORGANIZATIONAL MEETING OF TEMPORARY DIRECTORS. As soon 19 as practicable after all the temporary directors have qualified 20 21 under Section 49.055, Water Code, the temporary directors shall 22 meet and elect officers from their membership. Sec. 720X.022. CONFIRMATION AND INITIAL DIRECTORS' 23 ELECTION. (a) The temporary directors shall hold an election to 24 confirm the creation of the district and to elect seven initial 25 26 directors in accordance with Chapters 49 and 65, Water Code, on or

before September 1, 2009.

- 1 (b) The temporary board of directors shall determine the
- 2 method for determining the initial term of each person on the
- 3 initial board of directors. The terms must be clearly stated on the
- 4 ballot for the confirmation and directors' election.
- 5 (c) Section 41.001(a), Election Code, does not apply to a
- 6 confirmation election held as provided by this section.
- 7 (d) Initial directors serve until the first regularly
- 8 scheduled election of directors under Subchapter C, Chapter 65,
- 9 Water Code.
- 10 Sec. 720X.023. TRANSFER OF ASSETS; DISSOLUTION. (a) If
- 11 the district's creation is confirmed under Section 720X.022, the
- 12 Gastonia-Scurry Water Supply Corporation shall transfer the
- 13 assets, debts, and contractual rights and obligations of the
- 14 corporation to the district.
- (b) Not later than the 30th day after the date of the
- 16 transfer under Subsection (a), the board of directors of the
- 17 Gastonia-Scurry Water Supply Corporation shall commence
- 18 dissolution proceedings of the corporation.
- 19 (c) On dissolution of the Gastonia-Scurry Water Supply
- 20 Corporation, Certificate of Convenience and Necessity No. 10837 is
- 21 <u>considered to be held by the district.</u>
- 22 (d) The board of directors of the Gastonia-Scurry Water
- 23 Supply Corporation shall notify the Texas Commission on
- 24 Environmental Quality of the dissolution of the corporation and of
- 25 the transfer of Certificate of Convenience and Necessity No. 10837
- 26 to the district.
- (e) On receipt of notice under Subsection (d), the Texas

- Commission on Environmental Quality shall note in its records that 1
- 2 Certificate of Convenience and Necessity No. 10837 is held by the
- district and shall reissue the certificate in the name of the 3
- 4 district without further application, notice or hearing. A person,
- 5 party, or entity does not have any right of protest, objection or
- 6 administrative review of the transfer prescribed by this section.
- 7 Sec. 720X.024. EXPIRATION OF SUBCHAPTER. This subchapter expires September 1, 2012.
- 8

- SUBCHAPTER B. BOARD OF DIRECTORS 10
- Sec. 720X.051. DIRECTORS. The district is governed by a 11
- 12 board of not fewer than five and not more than 11 directors.
- [Sections 720X.052-720X.100 reserved for expansion] 13
- SUBCHAPTER C. POWERS AND DUTIES 14
- 15 Sec. 720X.101. GENERAL POWERS. Except as otherwise
- provided by this subchapter, the district has all of the rights, 16
- 17 powers, privileges, authority, functions, and duties provided by
- the general law of this state, including Chapters 49 and 65, Water 18
- Code, applicable to special utility districts created under Section 19
- 59, Article XVI, Texas Constitution. 20
- 21 Sec. 720X.102. WATER SERVICE IMPACT FEE. (a) The district
- may charge a water service impact fee that is not more than the 22
- equity buy-in fee charged by the Gastonia-Scurry Water Supply 23
- 24 Corporation on December 31, 2006, under that corporation's tariff.
- 25 (b) Chapter 395, Local Government Code, does not apply to
- 26 the initial water service impact fee set under this section.
- 27 (c) The district may increase the water service impact fee

- 1 only as provided by Chapter 395, Local Government Code, or as
- 2 approved by the Texas Commission on Environmental Quality.

- 1 BEGINNING.
- 2 SECTION 3. (a) The legal notice of the intention to
- 3 introduce this Act, setting forth the general substance of this
- 4 Act, has been published as provided by law, and the notice and a
- 5 copy of this Act have been furnished to all persons, agencies,
- 6 officials, or entities to which they are required to be furnished
- 7 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 8 Government Code.
- 9 (b) The governor has submitted the notice and Act to the
- 10 Texas Commission on Environmental Quality.
- 11 (c) The Texas Commission on Environmental Quality has filed
- 12 its recommendations relating to this Act with the governor,
- 13 lieutenant governor, and speaker of the house of representatives
- 14 within the required time.
- 15 (d) The general law relating to consent by political
- 16 subdivisions to the creation of a conservation and reclamation
- district and the inclusion of land in the district has been complied
- 18 with. All requirements of the constitution and laws of this state
- 19 and the rules and procedures of the legislature with respect to the
- 20 notice, introduction, and passage of this Act are fulfilled and
- 21 accomplished.
- 22 SECTION 4. This Act takes effect immediately if it receives
- 23 a vote of two-thirds of all the members elected to each house, as
- 24 provided by Section 39, Article III, Texas Constitution. If this
- 25 Act does not receive the vote necessary for immediate effect, this
- 26 Act takes effect September 1, 2007.
