Subtitle I, Title 6, Special District Local Laws 6 Code, is amended by adding Chapter 9017 to read as follows: 7 CHAPTER 9017. CANYON FALLS WATER CONTROL AND IMPROVEMENT DISTRICT 8 9 NO. 2 OF DENTON COUNTY SUBCHAPTER A. GENERAL PROVISIONS 10 Sec. 9017.001. DEFINITIONS. In this chapter: 11 12 (1) "Board" means the district's board of directors. 13 (2) "Director" means a board member. (3) "District" means the Canyon Falls Water Control 14 and Improvement District No. 2 of Denton County. 15 Sec. 9017.002. NATURE OF DISTRICT. The district is a water 16 control and improvement district in Denton County created under and 17 18 essential to accomplish the purposes of Section 59, Article XVI, Texas Constitution. 19 Sec. 9017.003. CONFIRMATION ELECTION REQUIRED. If the 20 21 creation of the district is not confirmed at a confirmation 22 election held under Section 9017.023 before September 1, 2011: 23 (1) the district is dissolved September 1, 2011, 24 except that the district shall:

by the general law of this state, including Chapters 49 and 51, 1 2 Water Code, applicable to water control and improvement districts created under Section 59, Article XVI, Texas Constitution. 3 4 Sec. 9017.102. ROAD PROJECTS. (a) To the extent authorized by Section 52, Article III, Texas Constitution, the district may 5 6 construct, acquire, improve, maintain, or operate macadamized, 7 graveled, or paved roads, or improvements in aid of those roads, 8 inside the district. 9 (b) A road project must meet all applicable construction standards, subdivision requirements, and regulatory ordinances or 10 orders of each municipality in whose corporate limits or 11 12 extraterritorial jurisdiction the district is located. [Sections 9017.103-9017.150 reserved for expansion] 13 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS 14 15 Sec. 9017.151. TAX TO REPAY BONDS. The district may impose a tax to pay the principal of or interest on bonds or other 16 17 obligations issued under Section 9017.201. [Sections 9017.152-9017.200 reserved for expansion] 18 19 SUBCHAPTER E. BONDS Sec. 9017.201. AUTHORITY TO ISSUE BONDS AND OTHER 20 21 OBLIGATIONS. (a) The district may issue bonds or other obligations as provided by Chapters 49 and 51, Water Code, to finance the 22 construction, maintenance, or operation of a project under Section 23 24 9017.101 or 9017.102. 25 (b) The district may not issue bonds or other obligations to 26 finance projects authorized by Section 9017.102 unless the issuance 27 is approved by a vote of a two-thirds majority of the district

1 voters voting at an election called for that purpose. 2 (c) Bonds or other obligations issued or incurred to finance projects authorized by Section 9017.102 may not exceed one-fourth 3 of the assessed value of the real property in the district. 4 5 SECTION 2. 10 (d) All requirements of the constitution and laws of this 11 state and the rules and procedures of the legislature with respect 12 to the notice, introduction, and passage of this Act are fulfilled 13 and accomplished.
