A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Sangani Ranch Municipal Utility
3	District No. 3 of Grayson County; providing authority to impose a
4	tax and issue bonds; granting the power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8260 to read as follows:
8	CHAPTER 8260. SANGANI RANCH MUNICIPAL UTILITY DISTRICT NO. 3 OF
9	GRAYSON COUNTY
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8260.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the district's board of directors.
13	(2) "Director" means a board member.
14	(3) "District" means the Sangani Ranch Municipal
15	Utility District No. 3 of Grayson County.
16	Sec. 8260.002. NATURE OF DISTRICT. The district is a
17	municipal utility district in Grayson County created under and
18	essential to accomplish the purposes of Section 52, Article III,
19	and Section 59, Article XVI, Texas Constitution.
20	Sec. 8260.003. CONFIRMATION ELECTION REQUIRED. If the
21	creation of the district is not confirmed at a confirmation
22	election held under Section 8260.023 before September 1, 2009:
23	(1) the district is dissolved September 1, 2009,
24	except that the district shall:

1	(A) pay any debts incurred;
2	(B) transfer to Grayson County any assets that
3	remain after the payment of debts; and
4	(C) maintain the organization of the district
5	until all debts are paid and remaining assets are transferred; and
6	(2) this chapter expires September 1, 2012.
7	Sec. 8260.004. INITIAL DISTRICT TERRITORY. (a) The
8	district is initially composed of the territory described by
9	Section 2 of the Act creating this chapter.
10	(b) The boundaries and field notes contained in Section 2 of
11	the Act creating this chapter form a closure. A mistake made in the
12	field notes or in copying the field notes in the legislative process
13	<pre>does not affect:</pre>
14	(1) the organization, existence, or validity of the
15	district;
16	(2) the right of the district to impose taxes;
17	(3) the validity of the district's bonds, notes, or
18	indebtedness; or
19	(4) the legality or operation of the district or the
20	board.
21	[Sections 8260.005-8260.020 reserved for expansion]
22	SUBCHAPTER A-1. TEMPORARY PROVISIONS
23	Sec. 8260.021. TEMPORARY DIRECTORS. (a) On or after
24	September 1, 2007, a person who owns land in the district may submit
25	a petition to the Texas Commission on Environmental Quality
26	requesting that the commission appoint as temporary directors the
27	five persons named in the petition.

- 1 (b) The commission shall appoint as temporary directors the
- 2 five persons named in the first petition received by the commission
- 3 under Subsection (a).
- (c) If a temporary director fails to qualify for office, the
- 5 commission shall appoint a person to fill the vacancy.
- 6 (d) Temporary directors serve until the earlier of:
- 7 (1) the date directors are elected under Section
- 8 8260.023; or
- 9 (2) the date this chapter expires under Section
- 10 8260.003.
- 11 Sec. 8260.022. ORGANIZATIONAL MEETING OF TEMPORARY
- 12 DIRECTORS. As soon as practicable after all the temporary
- 13 directors have qualified under Section 49.055, Water Code, the
- 14 temporary directors shall meet at a location in the district
- 15 agreeable to a majority of the directors. At the meeting, the
- 16 temporary directors shall elect officers from among the temporary
- 17 directors and conduct any other district business.
- 18 Sec. 8260.023. CONFIRMATION AND INITIAL DIRECTORS'
- 19 ELECTION; ANNEXATION BY CITY. (a) The temporary directors shall
- 20 hold an election to confirm the creation of the district and to
- 21 elect five directors as provided by Section 49.102, Water Code.
- 22 (b) The temporary directors may not hold the election until
- 23 the City of Gunter has annexed into its corporate limits all
- territory described by Section 2 of the Act creating this chapter.
- Sec. 8260.024. INITIAL ELECTED DIRECTORS; TERMS. The
- 26 directors elected under Section 8260.023 shall draw lots to
- 27 determine which two shall serve until the first regularly scheduled

- 1 election of directors and which three shall serve until the second
- 2 regularly scheduled election of directors.
- 3 Sec. 8260.025. EXPIRATION OF SUBCHAPTER. This subchapter
- 4 expires September 1, 2014.
- 5 [Sections 8260.026-8260.050 reserved for expansion]
- 6 SUBCHAPTER B. BOARD OF DIRECTORS
- 7 Sec. 8260.051. GOVERNING BODY; TERMS. (a) The district is
- 8 governed by a board of five directors.
- 9 (b) Directors serve staggered four-year terms.
- [Sections 8260.052-8260.100 reserved for expansion]
- SUBCHAPTER C. POWERS AND DUTIES
- 12 Sec. 8260.101. MUNICIPAL UTILITY DISTRICT POWERS AND
- 13 DUTIES. The district has the powers and duties provided by the
- 14 general law of this state, including Chapters 49 and 54, Water Code,
- applicable to municipal utility districts created under Section 59,
- 16 Article XVI, Texas Constitution.
- 17 Sec. 8260.102. WATER AND WASTEWATER FACILITIES AND
- 18 SERVICES. (a) The district shall make available any district
- 19 water or wastewater facility to each person that holds a
- 20 certificate of convenience and necessity for land in the district.
- 21 (b) The district may not provide retail water or wastewater
- 22 services.
- Sec. 8260.103. ROAD PROJECTS. (a) To the extent authorized
- 24 by Section 52, Article III, Texas Constitution, the district may
- 25 construct, acquire, improve, maintain, or operate macadamized,
- 26 graveled, or paved roads or turnpikes, or improvements in aid of
- 27 those roads or turnpikes, inside the district.

- 1 (b) A road project must meet all applicable construction
- 2 standards, subdivision requirements, and regulations of each
- 3 municipality in whose corporate limits or extraterritorial
- 4 jurisdiction the district is located.
- 5 Sec. 8260.104. MAINTENANCE AND REPAIR OF ROADS IN TERRITORY
- 6 EXCLUDED FROM CITY. If the City of Gunter excludes district
- 7 territory from the city's corporate limits, the district shall
- 8 maintain, improve, operate, and repair any road located in that
- 9 territory in accordance with the ordinances and rules of each
- 10 political subdivision in whose jurisdiction the road is located.
- Sec. 8260.105. DIVISION OF DISTRICT. (a) The district may
- 12 be divided into two new districts only if the district:
- 13 (1) has no outstanding bonded debt; and
- 14 (2) is not imposing ad valorem taxes.
- 15 (b) The division procedure is prescribed by Sections 53.030
- through 53.041, Water Code.
- 17 (c) Any new district created by the division of the district
- 18 has all the powers and duties of the district.
- 19 (d) Any new district created by the division of the district
- 20 may not, at the time the new district is created, contain any land:
- 21 (1) outside the area described by Section 2 of the Act
- 22 creating this chapter; or
- 23 (2) outside the corporate limits of the city of
- 24 Gunter.
- Sec. 8260.106. LIMITATION ON ANNEXATION. (a) The district
- 26 may not add land to the district under Subchapter J, Chapter 49,
- 27 Water Code, if the land is located outside the corporate limits of

- 1 the city of Gunter.
- 2 (b) Section 43.075, Local Government Code, does not apply to
- 3 the district.

- 5 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
- 6 Sec. 8260.151. TAX TO REPAY BONDS. The district may impose
- 7 <u>a tax to pay the principal of or interest on bonds or other</u>
- 8 obligations issued under Section 8260.201.
- 9 [Sections 8260.152-8260.200 reserved for expansion]
- 10 SUBCHAPTER E. BONDS
- 11 Sec. 8260.201. AUTHORITY TO ISSUE BONDS AND OTHER
- OBLIGATIONS. (a) The district may issue bonds or other obligations
- 13 as provided by Chapters 49 and 54, Water Code, to finance the
- 14 construction, maintenance, or operation of a project under Section
- 15 <u>8260.101 or 8260.103.</u>
- 16 (b) The district may not issue bonds or other obligations to
- finance projects authorized by Section 8260.103 unless the issuance
- 18 is approved by a vote of a two-thirds majority of the district
- 19 voters voting at an election held for that purpose.
- 20 (c) Bonds or other obligations issued or incurred to finance
- 21 projects authorized by Section 8260.103 may not exceed one-fourth
- of the assessed value of the real property in the district.
- 23 SECTION 2. The Sangani Ranch Municipal Utility District No.
- 24 3 of Grayson County includes all the territory contained in the

- 9 introduce this Act, setting forth the general substance of this
- 10 Act, has been published as provided by law, and the notice and a
- 11 copy of this Act have been furnished to all persons, agencies,
- officials, or entities to which they are required to be furnished
- under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 14 Government Code.
- 15 (b) The governor, one of the required recipients, has
- 16 submitted the notice and Act to the Texas Commission on
- 17 Environmental Quality.
- 18 (c) The Texas Commission on Environmental Quality has filed
- 19 its recommendations relating to this Act with the governor, the
- 20 lieutenant governor, and the speaker of the house of
- 21 representatives within the required time.
- 22 (d) All requirements of the constitution and laws of this
- 23 state and the rules and procedures of the legislature with respect
- 24 to the notice, introduction, and passage of this Act are fulfilled
- and accomplished.
- SECTION 4. This Act takes effect September 1, 2007.
