5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

11	Sec001. DEFINITIONS. In this chapter
12	(1) "Board" means the board of directors of the
13	<u>district.</u>
14	(2) "Director" means a member of the board.
15	(3) "District" means East Denton County Water Control
16	and Improvement District No. 1.
17	Sec002. NATURE OF DISTRICT. The district is a water
18	control and improvement district in Denton County created under and
19	essential to accomplish the purposes of Section 59, Article XVI
20	Texas Constitution.
21	Sec003. CONFIRMATION ELECTION REQUIRED. If the
22	creation of the district is not confirmed at a confirmation
23	election held under Section025 before September 1, 2011,
24	(1) the district is dissolved September 1, 2011,

1	<pre>except that:</pre>
2	(A) any debts incurred shall be paid;
3	(B) any assets that remain after the payment of debts
4	shall be transferred to Denton County; and
5	(C) the organization of the district shall be
6	maintained until all debts are paid and remaining assets are
7	transferred; and
8	(2) this chapter expires September 1, 2014.
9	Sec004. INITIAL DISTRICT TERRITORY. (a) The
10	district is initially composed of the territory described by
11	Section 2 of the Act creating this chapter.
12	(b) The boundaries and field notes contained in Section 2 of
13	the Act creating this chapter form a closure. A mistake made in the
14	field notes or in copying the field notes in the legislative process
15	<pre>does not affect:</pre>
16	(1) the organization, existence, or validity of the
17	district;
18	(2) the right of the district to impose taxes;
19	(3) the validity of the district's bonds, notes, or
20	indebtedness; or
21	(4) the legality or operation of the district or the
22	board.

25	Sec021. TEMPORARY DIRECTORS. (a) On or after
26	September 1, 2007, a person who owns land in the district may submit
27	a petition to the Texas Commission on Environmental Quality

- 2 five persons name in the petition.
- 3 (b) The commission shall appoint as temporary directors the
- 4 five persons named in the first petition received by the commission
- 5 under Subsection (a).
- 6 (c) If a temporary director fails to qualify for office, the
- 7 commission shall appoint a person to fill the vacancy.
- 8 (d) Temporary directors serve until the earlier of:
- 9 (1) the date directors are elected under Section

- 27 directors elected under Section ____.023 shall draw lots to

- 5 expires September 1, 2014.

- 9 (a) The district is governed by a board of five directors.

- 12 election date in May of each even-numbered year, the appropriate
- 13 number of directors shall be elected.

- 15 SUBCHAPTER C. POWERS AND DUTIES
- Sec. ___.101. WATER CONTROL AND IMPROVEMENT DISTRICT POWERS
- 17 AND DUTIES. The district has the powers and duties provided by the
- 18 general law of this state, including Chapters 49 and 51, Water Code,
- 19 applicable to water control and improvement districts created under
- 20 Section 59, Article XVI, Texas Constitution, including Section
- 21 51.331, Water Code.
- Sec. ____.102. ROAD PROJECTS. (a) To the extent authorized
- 23 by Section 52, Article III, Texas Constitution, the district may
- 24 construct, acquire, improve, maintain, or operate macadamized,
- 25 graveled, or paved roads or improvements in aid of those roads,
- 26 inside the district.
- 27 (b) A road project must meet or exceed all applicable

- 1 construction standards and regulatory ordinances of each
- 2 municipality in whose corporate limits or extraterritorial
- 3 jurisdiction the district is located.
- 4 If the district is located outside the extraterritorial
- 5 jurisdiction of a municipality, a road project must meet all
- 6 applicable construction standards and regulatory ordinances of
- 7 <u>each county in which the district is located.</u>

- 25 Act, has been published as provided by law, and the notice and a
- 26 copy of this Act have been furnished to all persons, agencies,
- officials, or entities to which they are required to be furnished

- 1 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 2 Government Code.
- 3 (b) The governor, one of the required recipients, has
- 4 submitted the notice and Act to the Texas Commission on
- 5 Environmental Quality.
- 6 (c) The Texas Commission on Environmental Quality has filed
- 7 its recommendations relating to this Act with the governor, the
- 8 lieutenant governor, and the speaker of the house of
- 9 representatives within the required time.
- 10 (d) All requirements of the constitution and laws of this
- 11 state and the rules and procedures of the legislature with respect
- 12 to the notice, introduction, and passage of this Act are fulfilled
- 13 and accomplished.
- 14 SECTION 4. This Act takes effect September 1, 2007.
