A BILL TO BE ENTITLED 1 AN ACT 2 relating to the creation of the Southern Travis Special Utility 3 District; providing authority to issue bonds; granting the power of eminent domain. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 6 SECTION 1. Subtitle C, Title 6, Special District Local Laws Code, is amended by adding Chapter 7214 to read as follows: 7 CHAPTER 7214. SOUTHERN TRAVIS SPECIAL UTILITY DISTRICT 8 SUBCHAPTER A. GENERAL PROVISIONS 9 Sec. 7214.001. DEFINITION. In this chapter, "district" 10 11 means the Southern Travis Special Utility District. 12 Sec. 7214.002. NATURE OF DISTRICT. The district is a special utility district in Travis County created under and 13 14 essential to accomplish the purposes of Section 59, Article XVI, Texas Constitution. The district is created to serve a public use 15 16 and benefit. Sec. 7214.003. APPLICABILITY OF OTHER SPECIAL UTILITY 17 18 DISTRICT LAW. Except as otherwise provided by this chapter, Chapters 49 and 65, Water Code, apply to the district. 19 Sec. 7214.004. INIT<u>IAL DISTRICT TERRITORY. (a)</u> 20 The 21 district is initially composed of the territory described by Section 2 of the Act creating this chapter. 22 23 (b) The boundaries and field notes contained in Section 2 of the Act creating this chapter form a closure. 13	Sec. 7214.021. TEMPORARY DIRECTORS. (a) The temporary
14	board of directors of the district is composed of:
15	(1) Marc Knutsen;
16	(2) Bruce Morrison;
17	(3) Loren Smith;
18	(4) Rick Vaughn; and
19	(5) Tom Winkley.
20	(b) Each temporary director shall qualify for office as
21	provided by Section 49.055, Water Code.
22	(c) If a temporary director fails to qualify for office, the
23	temporary directors who have qualified shall appoint a person to
24	fill the vacancy. If at any time there are fewer than four
25	qualified temporary directors, the Texas Commission on
26	Environmental Quality shall appoint the necessary number of

No. 4127 (d) Temporary directors serve until initial directors are 1 2 elected under Section 7214.022. 3 (e) As soon as practicable after all the temporary directors 4 have qualified under Section 49.055, Water Code, the temporary 5 directors shall convene the organizational meeting of the district 6 and elect officers from among the temporary directors. Sec. 7214.022. NO CONFIRMATION ELECTION; INITIAL 7 DIRECTORS' ELECTION. (a) The temporary board of directors is not 8 9 required to hold an election to confirm the creation of the 10 district. (b) The temporary board of directors shall hold an election 11 12 to elect not fewer than five and not more than 11 directors, as determined by the temporary board. 13 (c) The temporary board of directors shall determine the 14 15 method for determining the initial term of each person on the 16 initial board of directors. The terms must be clearly stated on the 17 ballot for the directors' election. (d) Initial directors serve until the first regularly 18 scheduled election of directors under Subchapter C, Chapter 65, 19 Water Code, to be held not earlier than 2012. 20 Sec. 7214.023. EXPIRATION OF SUBCHAPTER. This subchapter 21 expires September 1, 2015. 22 [Sections 7214.024-7214.050 reserved for expansion] 23 SUBCHAPTER B. BOARD OF DIRECTORS 24 Sec. 7214.051. DIRECTORS. (a) The district is governed by 25 a board of not fewer than five and not more than 11 directors. 26 (b) Notwithstanding Section 65.103(b), Water Code, a 27

H.B. No. 4127 director serves a four-year term of office and may serve 1 2 consecutive terms. 3 [Sections 7214.052-7214.100 reserved for expansion] 4 SUBCHAPTER C. POWERS AND DUTIES Sec. 7214.101. GENERAL POWERS. (a) Except as otherwise 5 6 provided by this chapter, the district has all of the rights, powers, privileges, functions, and duties provided by the general 7 law of this state, including Chapters 49 and 65, Water Code, 8 9 applicable to special utility districts created under Section 59, Article XVI, Texas Constitution. 10 (b) The district may: 11 12 (1) purchase, own, hold, lease, and otherwise acquire 13 sources of water supply; (2) build, operate, and maintain facilities for the 14 15 transportation of water; 16 (3) sell water to municipalities and other political 17 subdivisions of this state, private businesses, and individuals; (4) provide for the protection, preservation, and 18 restoration of the purity and sanitary condition of water within 19 the district; and 20 21 (5) purchase, construct, acquire, own, operate, maintain, repair, improve, extend, or establish a municipal solid 22 waste collection and disposal system, including a system for 23 24 recycling, inside or outside the district, and assess proper 25 charges for the use of the system. (c) The district may require the use of a solid waste 26 collection and disposal system described by Subsection (b)(5) as a 27

<u>condition for the receipt of other district services.</u>
 (d) The district may enter into an exclusive contract with a

3 private entity to provide solid waste collection and disposal
4 services to all land and persons inside the district.

5 Sec. 7214.102. EMINENT DOMAIN. The district has all the 6 authority under Chapters 49 and 65, Water Code, of a special utility 7 district to acquire by condemnation any land, easement, or other 8 property located inside or outside the boundaries of the district 9 for any district project or purpose.

Sec. 7214.103. ANNEXATION. The owner of a tract of land that 10 has an area of at least 50 acres and that has been released by 11 12 written agreement from the certificate of public convenience and necessity of a rural water supply corporation may petition the 13 district to be annexed into the district. On receipt of a petition, 14 15 the board may issue an order granting the petition, and the land described by the petition will be included in the district. Land 16 17 annexed under this section is not required to be contiguous to the district. 18

19 SECTION 2. The Southern Travis Special Utility District 20 initially includes all the territory contained in the following 21 area:

THENCE along the West line of said 87.884 acre tract, being along the East ro.w. line of Interstate Hwy 35 South, N 20°25'54" E for a distance of 1499.77 feet to the PLACE OF BEGINNING and containing 215.592 acres of land, more or less.

26 SECTION 3. (a) The legal notice of the intention to 27 introduce this Act, setting forth the general substance of this

Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, Government Code.

6 (b) The governor has submitted the notice and Act to the
7 Texas Commission on Environmental Quality.

8 (c) The Texas Commission on Environmental Quality has filed 9 its recommendations relating to this Act with the governor, 10 lieutenant governor, and speaker of the house of representatives 11 within the required time.

12 (d) The general law relating to consent by political 13 subdivisions to the creation of a conservation and reclamation 14 district and the inclusion of land in the district has been complied 15 with. All requirements of the constitution and laws of this state 16 and the rules and procedures of the legislature with respect to the 17 notice, introduction, and passage of this Act are fulfilled and 18 accomplished.

19 SECTION 4. To the extent of any conflict, this Act prevails 20 over any provision of S.B. No. 1688, S.B. No. 1689, or H.B. No. 21 3719, if those Acts are passed by the 80th Legislature, Regular 22 Session, 2007, and become law.

23 SECTION 5. This Act takes effect immediately if it receives 24 a vote of two-thirds of all the members elected to each house, as 25 provided by Section 39, Article III, Texas Constitution. If this 26 Act does not receive the vote necessary for immediate effect, this 27 Act takes effect September 1, 2007.
