A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to the election of directors of the San Patricio County
- 3 Groundwater Conservation District and to the validation of certain
- 4 acts of the district.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subchapter B, Chapter 8817, Special District
- 7 Local Laws Code, is amended by adding Section 8817.053 to read as
- 8 follows:
- 9 Sec. 8817.053. METHOD OF ELECTING DIRECTORS: JUSTICE OF
- 10 THE PEACE PRECINCTS. (a) The directors of the district shall be
- 11 elected according to the precinct method as provided by this
- 12 section.
- (b) One director shall be elected by the voters of the
- 14 entire district, and one director shall be elected from each
- justice of the peace precinct by the voters of that precinct.
- 16 (c) Except as provided by Subsection (e), to be eligible to
- be a candidate for or to serve as director at large, a person must be
- 18 <u>a registered voter in the district. To be a candidate for or to</u>
- 19 serve as director from a justice of the peace precinct, a person
- 20 <u>must be a registered voter of that precinct.</u>
- 21 (d) A person shall indicate on the application for a place
- 22 on the ballot:
- 23 (1) the precinct that the person seeks to represent;
- 24 or

- 1 (2) that the person seeks to represent the district at
- 2 <u>large.</u>
- 3 (e) When the boundaries of the justice of the peace
- 4 precincts are redrawn after each federal decennial census to
- 5 reflect population changes, a director in office on the effective
- 6 date of the change, or a director elected or appointed before the
- 7 effective date of the change whose term of office begins on or after
- 8 the effective date of the change, shall serve in the precinct to
- 9 which elected or appointed even though the change in boundaries
- 10 places the person's residence outside the precinct for which the
- 11 person was elected or appointed.
- 12 SECTION 2. (a) The following actions of the San Patricio
- 13 County Groundwater Conservation District are validated and
- 14 confirmed in all respects as if the actions had been done as
- 15 authorized by law:
- 16 (1) all acts and proceedings of the district taken
- 17 before the effective date of this Act; and
- 18 (2) the election or appointment of directors or other
- 19 officers of the district who took office before the effective date
- 20 of this Act.
- 21 (b) A governmental act or proceeding of the San Patricio
- 22 County Groundwater Conservation District occurring after an act or
- 23 proceeding validated by this Act may not be held invalid on the
- ground that the prior act or proceeding, in the absence of this Act,
- 25 was invalid.
- 26 (c) This section does not apply to any matter that on the
- 27 effective date of this Act:

- 1 (1) is involved in litigation if the litigation
- 2 ultimately results in the matter being held invalid by a final
- 3 judgment of a court of competent jurisdiction; or
- 4 (2) has been held invalid by a final judgment of a
- 5 court of competent jurisdiction.
- 6 SECTION 3. This Act takes effect immediately if it receives
- 7 a vote of two-thirds of all the members elected to each house, as
- 8 provided by Section 39, Article III, Texas Constitution. If this
- 9 Act does not receive the vote necessary for immediate effect, this
- 10 Act takes effect September 1, 2007.
