5 WHEREAS, Born on August 7, 1936, to Ernest Lee and Mattie 6 Manning Cummings, Bob Cummings served his country as a member of the 7 U.S. Air Force Reserve; he was a graduate of The University of Texas 8 and earned his juris doctorate from Baylor Law School in 1962; and

WHEREAS, This notable Texan had a varied and successful 9 career, including tenures as a sixth grade teacher at Gatesville 10 11 Elementary School, an agent for Cummings Insurance Agency, and an 12 assistant city attorney for the City of Waco; he practiced law privately for 10 years before serving as district attorney and then 13 district judge of the 52nd Judicial District, and in 1991, he 14 accepted responsibilities as a justice of the Tenth Court of 15 Appeals, retiring from the position in 1998; and 16

WHEREAS, Through the years, Justice Cummings gave generously 17 of his time and talents to civic and professional organizations; 18 benefiting from his membership were the Baylor Law Review 19 Association, 52nd Judicial District Bar Association, Waco-McLennan 20 21 County Bar Association, and State Bar of Texas, as well as the 22 Gatesville Lions Club, Gatesville Exchange Club, American Legion 23 Post No. 42, Gatesville Masonic Lodge No. 197, A.F. & A.M., and Waco Scottish Rite and York Rite Bodies; and 24
