

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, First State Bank of Uvalde is marking the milestone
2 of its 100th anniversary; founded in 1907, the bank has withstood
3 the challenges of the Great Depression, the drought of the 1950s,
4 and the Texas banking crisis of the 1980s to play an important role
5 in the economic vitality of South Texas; and

6 WHEREAS, With a proud history that includes John Nance Garner
7 as one of its owners, the bank is now headed by Dolph Briscoe, who
8 has been the majority stockholder since 1960, and Lewis E. Bracy,
9 Jr., chairman; the bank's broad-based expertise and exceptional
10 management team is recognized throughout the banking industry, and
11 its leadership has helped it grow from assets of approximately \$10
12 million to more than \$400 million; and
