HOUSE CONCURRENT RESOLUTION

WHEREAS, In 2007, Firstmark Credit Union is celebrating 75
 years of operation in the San Antonio community as a member-owned,
 locally controlled, not-for-profit financial cooperative; and

WHEREAS, The organization was originally chartered in 1932 as
the San Antonio Teachers Credit Union, making it the oldest
state-chartered credit union in San Antonio; and

WHEREAS, Since opening its first branch on Southwest Military 7 Drive in 1986, the credit union has continued to grow, opening its 8 ninth branch in 2007; today, it is the fourth largest credit union 9 in San Antonio, with more than \$595 million in assets, 89,000 10 11 members, and 256 employees serving those who live, work, worship, 12 or attend school in Bexar County, as well as education-related 13 employees and their families residing in Bexar County and 12 14 surrounding counties; and

WHEREAS, Employees of Firstmark Credit Union have made a 15 positive difference in their community by volunteering with many 16 charitable organizations, including Big Brothers Big Sisters of 17 18 South Texas, Boysville, Inc., SAPD Blue Santa Program, YMCA, San Antonio Youth Centers, Inc., March of Dimes, American Cancer 19 Society, Inc., and several local chambers of commerce and PTAs; in 20 21 addition, their Credit Unions For Kids program has raised \$609,622 22 since 1987 for CHRISTUS Santa Rosa Children's Hospital; and

23 WHEREAS, Firstmark Credit Union benefits greatly from the 24 leadership of president and CEO Leon Ewing, who recently celebrated
