

HOUSE CONCURRENT RESOLUTION

1           WHEREAS, Memories of a life filled with joyful times and  
2 meaningful accomplishments remain to comfort the family and friends  
3 of Robert Kim Brown of Austin, who passed away on February 14, 2007,  
4 at the age of 53; and

5           WHEREAS, Born in Paris on July 6, 1953, four minutes before  
6 his identical twin brother, Robert Brown grew up in a loving family  
7 and graduated in 1972 from Paris High School; he went on to attend  
8 The University of Texas at Austin, where he earned a bachelor's  
9 degree in biology and graduated magna cum laude; and

10           WHEREAS, Mr. Brown began a dedicated career with the Texas  
11 Workers' Compensation Commission while pursuing a second degree at  
12 UT; over the course of his impressive tenure, he rose through the  
13 ranks to become the director of programs and program administration  
14 in the hearings division before retiring in 2004; he soon returned  
15 to his beloved profession as senior proceedings specialist at the  
16 Texas Department of Insurance Division of Workers' Compensation,  
17 which he served until the time of his death; known for his hard work  
18 and commitment to excellence, he was the recipient of numerous  
19 letters of commendation; and

20           WHEREAS, In all his endeavors, Mr. Brown enjoyed the love and  
21 support of his wife, the former Cinda Prosise, with whom he shared  
22 nearly 25 years; the couple were the parents of three children,  
23 Steven, Lindsey, and the late Stacy Kim, and Mr. Brown greatly  
24 cherished his role as father, enthusiastically attending countless

1 Little League, soccer, and football games and band concerts; he was  
2 also an avid Cowboys and Longhorns fan and could often be found  
3 heartily expressing his opinion during games; and

4 WHEREAS, Although his life ended far too soon, Robert Brown  
5 will long be remembered with admiration for his exemplary record of  
6 public service and with fondness for the thoughtfulness and  
7 generosity he demonstrated to friends across the Lone Star State;  
8 now, therefore, be it

9 RESOLVED, That the 80th Legislature of the State of Texas  
10 hereby honor the memory of Robert Kim Brown and extend sincere  
11 sympathy to the members of his family: to his wife, Cinda Brown; to  
12 his children, Steven and Lindsey Brown; to his mother, Robbie  
13 Brown; to his brothers, Rodney Brown and Deryl Brown; to his  
14 sisters, Jane Montgomery and DeeAnn Cummins; and to his other  
15 relatives and many friends; and, be it further

16 RESOLVED, That an official copy of this resolution be  
17 prepared for his family and that when the Texas House of  
18 Representatives and Senate adjourn this day, they do so in memory of  
19 Robert Kim Brown.
