1 WHEREAS, Emma Louise Stengel Bean died on May 16, 2007,
2 leaving her circle of family and friends to cherish their many
3 treasured memories of time spent in her company; and

4 WHEREAS, Born in Mason on July 18, 1913, the former "Dixie"
5 Stengel came from a pioneer ranching family; she graduated from
6 Menard High School in 1930 and attended Texas Woman's University in
7 Denton and The University of Texas at Austin, where she majored in
8 music; and

9 WHEREAS, After returning to Menard, she married Rodgers
10 Maxwell "Jelly" Bean on June 6, 1935; they enjoyed nearly 40 years
11 together, until his death in 1973, and they were blessed with three
12 children; and

13 WHEREAS, A vital woman full of energy, Dixie Bean managed the
14 family's commercial real estate business for 32 years after Mr.
15 Bean's death; in her leisure time, she loved traveling around the
16 world and playing bridge with friends; a gifted musician, she
17 played the piano and organ for more than 70 years at First United
18 Methodist Church and also taught piano; in addition, Mrs. Bean was a
19 member of the Excelsior Study Club and a charter member of the
20 Menard Country Club; and

21 WHEREAS, A devoted wife and caring mother and grandmother,
22 Dixie Bean touched the lives of countless individuals during her 93
23 years, and she will be deeply missed; now, therefore, be it

1 hereby pay tribute to the life of Emma Louise Stengel Bean and offer
2 condolences to the members of her family: to her children, Gwen
