1 WHEREAS, A full and generous life came to a close with the 2 passing of Dean Vincent Grossnickle on May 3, 2007, at the age of 3 91; and

WHEREAS, Born in Kansas on August 22, 1915, Mr. Grossnickle attended Mission High School, where he excelled in academics and on the school's football team, earning the nickname of "Mission Flash" for his skills as a quarterback; he furthered his education at The University of Texas at Austin while working at the campus library to pay his tuition and graduated with highest honors in accounting;

WHEREAS, Mr. Grossnickle began his professional career with the Internal Revenue Service in San Antonio; it was there that he met the love of his life, Mary Louise McAnneny, whom he married in 1941; the couple would eventually be blessed with two children as well as five grandchildren; and

Mr. Grossnickle enlisted in the U.S. Navy and attended Officers
Training School at Harvard University; his tour of duty during
World War II took him to the Aleutian Islands of Alaska, and he
earned the rank of captain; and

21 WHEREAS, After the war, Mr. Grossnickle returned to civilian 22 life and settled in Dallas, where he worked as a C.P.A. for Arthur 23 Anderson and earned a degree from the Southern Methodist University 24 School of Law; his legal career began in the tax department of

- 2 world travel, and he later served as a partner with Peat, Marwick,
- 3 and Mitchell law firm, from which he retired; he later returned to
- 4 work as an attorney for the firm of Raggio & Raggio; and

- 6 Church, Mr. Grossnickle spent his later years in Paris and in
- 7 Dallas, and he and his wife enjoyed boating, fishing, and golf; and
- 8 WHEREAS, Dean Grossnickle will long be remembered for his wit
- 9 and charm, as well as for his honesty and generosity, and he leaves
- 10 behind a legacy that will be forever treasured by those who held him
- 11 dear; now, therefore, be it

- 13 hereby pay tribute to the life of Dean Vincent Grossnickle and
- 14 extend sympathy to the members of his family: to his wife of 65
