1-7 proposing a constitutional amendment providing for the
1-8 continuation of the constitutional appropriation for facilities
1-9 and other capital items at Angelo State University on a change in
1-10 the governance of the university.

1-11 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-12 SECTION 1. Section 17(b), Article VII, Texas Constitution,
1-13 is amended to read as follows:

1-14 (b) The funds appropriated under Subsection (a) of this
1-15 section shall be for the use of the following eligible agencies and
1-16 institutions of higher education (even though their names may be
1-17 changed):

1-18 (1) East Texas State University including East Texas
1-19 State University at Texarkana;

1-20 (2) Lamar University including Lamar University at
1-21 Orange and Lamar University at Port Arthur;

1-22 (3) Midwestern State University;

1-23 (4) University of North Texas;

1-24 (5) The University of Texas--Pan American including
1-25 The University of Texas at Brownsville;

1-26 (6) Stephen F. Austin State University;

1-27 (7) Texas College of Osteopathic Medicine;

1-28 (8) Texas State University System Administration and
1-29 the following component institutions:

1-53 SECTION 2. This proposed constitutional amendment shall be
1-54 submitted to the voters at an election to be held November 6, 2007.
1-55 The ballot shall be printed to permit voting for or against the
1-56 proposition: "The constitutional amendment providing for the
1-57 continuation of the constitutional appropriation for facilities
1-58 and other capital items at Angelo State University on a change in
1-59 the governance of the university."
