

R E S O L U T I O N

1           WHEREAS, The city of Columbus lost an admired civic leader  
2 with the passing of John Alden Hancher on December 30, 2006, at the  
3 age of 90; and

4           WHEREAS, Born to E. Grant and Clara Ladd Hancher in El Campo  
5 on January 5, 1916, Mr. Hancher attended school in the El Campo  
6 Independent School District, received his undergraduate degree  
7 from The University of Texas at Austin, and graduated from The  
8 University of Texas School of Law in 1940, the same year in which he  
9 was admitted to the Texas State Bar; and

10           WHEREAS, Following the outbreak of World War II, he enlisted  
11 in the Royal Canadian Air Force in Winnipeg, Canada, on August 4,  
12 1941, and trained as a pilot; he was sent to England the following  
13 year and served with the RCAF before transferring to the U.S. Army  
14 Eighth Air Force Bomber Command in London in 1943; this brave airman  
15 flew B-17 bombers on missions over France and Germany and  
16 contributed to the Allied victory in Europe; he was discharged from  
17 the service in August 1945, after the war concluded; and

18           WHEREAS, After returning to Texas, Mr. Hancher opened a law  
19 office in Columbus and practiced there from 1945 until shortly  
20 before his death; he also entered public service and was county  
21 judge of Colorado County from 1948 to 1954; a prominent figure in  
22 the legal profession, he was a member of the State Bar of Texas and  
23 the Colorado County Bar Association, serving as its president in  
24 the 1950s; and

1           WHEREAS, A loving husband, father, and grandfather, Mr.  
2 Hancher met and married his first wife, Louise Beattie, while  
3 stationed in England during the war, and their son, Thomas Beattie,  
4 was born in 1946; in 1967, Louise Hancher passed away, and Mr.  
5 Hancher wed Mary Saladino Sparrow in 1968; they were together for 24  
6 years, until Mary's death in 1992; and

7           WHEREAS, Mr. Hancher devoted considerable time to civic  
8 organizations; he served as chairman of the board of the Columbus  
9 Community Hospital and president of the Columbus Rotary Club and  
10 was a member of the Veterans of Foreign Wars Post No. 6113 and the  
11 American Legion, and he served as a veterans service officer for  
12 more than 50 years; he also took great enjoyment in his leisure  
13 activities and was an avid fisherman and hunter and a voracious  
14 reader; and

15           WHEREAS, John Hancher will be fondly remembered for his legal  
16 skill and community leadership and for a distinguished professional  
17 and civic career that touched countless lives; now, therefore, be  
18 it

19           RESOLVED, That the House of Representatives of the 80th Texas  
20 Legislature hereby pay tribute to the life of John Alden Hancher and  
21 extend sincere sympathy to the members of his family: to his son,  
22 Dr. Thomas Beattie Hancher and his wife, Christine; to his  
23 grandchildren, Heather Hancher Thomas and her husband, Ryan, Dr.  
24 Shannon Hancher and her husband, Nicholas Hodges, and Blake  
25 Hancher; to his stepchildren, Judy Peabody and her husband, Jim,
