2 wheelchair basketball team captured its seventh national title on
3 April 1, 2006, defeating the University of Wisconsin-Whitewater
4 Warhawks 53-51 in the championship game of the National
5 Intercollegiate Wheelchair Basketball Conference Tournament held
6 at the University of Illinois; and

7 WHEREAS, Members of the conference since 1989, the Movin'
8 Mavs are the first and only intercollegiate team to have each of its
9 members on full athletic scholarship; since joining the conference,
10 the Mavs have had six players selected as Most Valuable Player,
11 while 16 players have been named to the first-team All-American
12 squad; and

13 WHEREAS, Led by head coach and UTA alumnus Jim Hayes, the
14 Movin' Mavs demonstrated the drive of true champions in their quest
15 for the tournament title; through their hard work and dedication to
16 excellence, these talented student-athletes have furthered the
17 stellar reputation of the UTA wheelchair basketball program, and it
18 is a pleasure to wish them well as they defend their title on their
19 home court at this year's National Intercollegiate Wheelchair
20 Basketball Tournament, which begins on March 3, 2007; now,
