marking its 125th anniversary in 2007, and the school's students, 2 teachers, and administrators and the students' parents are 3 celebrating this important milestone in the institution's history; 4 5 and WHEREAS, This venerable school dates back to 1882, when three 6 nuns from the congregation of the Sisters of the Incarnate Word and 7 Blessed Sacrament came to Hallettsville and opened Incarnate Word 8 Convent, a novitiate and boarding school for girls associated with 9 Sacred Heart Church; the first classes convened on January 6, 1882, 10 11 and from its earliest days, the convent offered courses in music, 12 Latin, Spanish, French, and German at the primary, intermediate, 13 and secondary levels; and 14 WHEREAS, Known by various names throughout its history, including Sacred Heart Academy and Blessed Sacrament and Incarnate 15 Word Convent, Sacred Heart Catholic School has grown tremendously 16 with the passing years; originally housed in a single convent 17 18 building, its facilities today include a band hall, a vocational shop facility, a gymnasium and weight room, a library and media 19 20 center with Internet access, and a computer reading lab; and 21 WHEREAS, The school's educational mandate has also expanded 22 over the decades; male students began attending in 1892, and kindergarten and pre-kindergarten classes were later added; Sacred 23 24 Heart is known for its quality educational and extracurricular

- 2 championships in sports and academics as a member of the Texas
- 3 Association of Private and Parochial Schools; and
- WHEREAS, Today, Sacred Heart is capably led by Principal
- 5 David Smolik and Father John Peters, who, along with a dedicated
- 6 staff of 48 teachers and aides, work to provide academic
- 7 opportunities, leadership training, religious education, and
- 8 extracurricular activities to more than 275 students in grades
- 9 pre-K through 12; and
- 10 WHEREAS, The celebration of this momentous anniversary
- 11 provides an opportunity to reflect on the many generations of
- 12 Texans who have passed through the doors of the Hallettsville
- institution and to applaud the school's sustained efforts to carry
- 14 out its important educational mission; now, therefore, be it
