1 WHEREAS, Family and friends mourned the loss of Val Verde
2 justice of the peace and longtime educator Virgilio S. Luna of Del
3 Rio, who passed away on July 31, 2006; and

4 WHEREAS, Born on October 31, 1942, in Ciudad Acuna, Mexico,
5 Mr. Luna graduated in 1962 from Del Rio High School, where he played
6 on the Wildcat football team that won district, regional, and
7 quarterfinal championships; he was named to the honorable mention
8 squads in his sophomore and junior years and earned a place on the
9 first team all-district squad as a guard in his senior year; and

10 WHEREAS, Mr. Luna, who received a bachelor of science degree
11 and a master of education degree from Sul Ross State University,
12 served 29 years as an educator in San Felipe Del Rio CISD, where he
13 taught at Garfield Elementary School; during his tenure, he was
14 active in numerous professional activities, serving as PTA and PTO
15 officer for several years at his school and as a Texas State
16 Teachers Association delegate in the state convention for many
17 years; and

18 WHEREAS, After retiring from education, Mr. Luna was elected
19 justice of the peace in 1998; he also benefited his community
20 through his civic work on the Police Task Force and the City of Del
21 Rio Civil Service Commission and as a member of the Val Verde County
22 Airport Board and the City of Del Rio Airport Advisory Commission;

24 WHEREAS, The positive influence this distinguished Texan has

1 had on his community is immeasurable, and his spirit will shine
2 brightly in the hearts of those who were fortunate enough to have
3 known him; now, therefore, be it

5 Legislature hereby pay tribute to the life of Virgilio S. Luna and
6 extend sincere sympathy to the members of his family: to his wife,

9 brothers, Frank Luna, Rosauero Luna, Hijinio Luna, and Juan Luna; to

11 and Robert Virgil Luna II; to his brothers-in-law, Joe Meza, Jr.,
