1 WHEREAS, The city of Fort Worth lost an admired community 2 leader with the passing of Frank Wallace on January 15, 2007, at the

WHEREAS, A native of Fort Worth born on January 2, 1921, Frank

5 Wallace received his education at the city's public schools and was

a proud graduate of I. M. Terrell High School; and

7 WHEREAS, Mr. Wallace was a renowned union activist and

8 organizer who first became involved in labor issues in the

mid-1940s, when he worked at a meatpacking plant and became a shop

steward and a union field representative; by the time Mr. Wallace

retired in 1984, he had worked for three international unions; his

service was highlighted by his tenure as assistant director for

District 6 of the United Food and Commercial Workers Union and by

his work as an international representative for the AFL-CIO,

15 serving more than 50 local unions in seven states; the dedication he

16 exhibited in his work was honored with his induction into the Texas

17 Labor Hall of Fame in 1998; and

18 WHEREAS, Frank Wallace was also a prominent figure in the

19 NAACP, serving as a member of its board of directors and as chair of

the Labor and Industry Committee; his lifetime of service to the

21 Fort Worth/Tarrant County branch of the association was honored in

22 2003, when he received the George D. Flemmings Award; and

23 WHEREAS, Other political and civic activities contributed to

Mr. Wallace's reputation as a leader in Fort Worth's African

- 1 American community; he belonged to the Coalition of Black Democrats
- 2 and the Minority Leaders and Citizens Council, and he was a member
- 3 and vice chair of the Greater Fort Worth Martin Luther King, Jr.,
- 4 Holiday Committee; and
- 5 WHEREAS, Well known for his outstanding bass singing voice,
- 6 Mr. Wallace performed with the male chorus at Shiloh Missionary
- 7 Baptist Church in Fort Worth, where he was a lifelong congregant and
- 8 a church trustee; he also dedicated a great deal of time to other
- 9 community organizations, including the Masonic Rainbow Lodge No.
- 10 345, the Commission on Aging, and the A. Philip Randolph Institute,
- 11 and he served as vice president of the I. M. Terrell Alumni
- 12 Association for many years; devoted to preserving the historical
- 13 legacy of Fort Worth's African American community, he was a member
- 14 of the board of directors for both the Tarrant County Black
- 15 Historical and Genealogical Society and the Tarrant County
- 16 Historical Commission; and
- WHEREAS, Whether raising his magnificent voice in song or to
- 18 speak out on important issues, Frank Wallace was an inspiring
- 19 figure who was a passionate advocate for the citizens of North
- 20 Texas, and his contributions will long be remembered; now,
- 21 therefore, be it
- 22 RESOLVED, That the House of Representatives of the 80th Texas
- 23 Legislature hereby pay tribute to the life of Frank Wallace and
- 24 extend deepest sympathy to his family: to his wife, Helen; to his
- 25 son, Anthony; to his daughter-in-law, Paulette; to his
