1 WHEREAS, Memories of a life filled with joyful times and
2 meaningful accomplishments may comfort the family and friends of
3 Clint James Luksa of Caldwell, who passed away on January 24, 2007;
4 and

5 WHEREAS, Mr. Luksa was born on February 16, 1936, to Adolph P.
6 and Fannie Kovar Luksa; he was a graduate of Caldwell High School,
7 where he was active in FFA and received the Lone Star Farmer Award;

9 WHEREAS, A member of the United States Army Reserve, this
10 respected Texan served for 29 years as the constable for Precinct 1;
11 in addition, he was a lifelong rancher and successful businessman,
12 having owned and operated several enterprises, including service
13 stations in Deanville and Caldwell, the Silver Spur-Hitching Post
14 in Deanville, and the Luksa Mobile Home and Land Sales Company; and

15 WHEREAS, Mr. Luksa gave generously of his time and talents to
16 a number of civic organizations; a strong supporter of the Burleson
17 County Youth Livestock Show and Burleson County Fair Association,
18 he was treasurer of the SPJST Cemetery Association and a member of
19 the Burleson County Czech Heritage Museum, the Order of the Sons of
20 Hermann Lodge, R.V.O.S. Lodge No. 7, SPJST Lodge No. 186, and SPJST
21 Lodge No. 7, which he served as president; moreover, he was a valued
22 congregant of Cooks Point Brethren Church and volunteered as an
23 auctioneer for many area benefits; and

24 WHEREAS, Clint Luksa made lasting contributions to his

1 community, and although he will be deeply missed, his memory will
2 live on in the hearts of those whose lives he touched; now,
3 therefore, be it

4 RESOLVED, That the House of Representatives of the 80th Texas
5 Legislature hereby pay tribute to the life of Clint Luksa and extend
6 sincere sympathy to the members of his family: to his wife, Faye
7 Luksa; to his stepsons, Darren and Roger Broesche; to his
8 step-grandson, Garrett Broesche; to his nieces, Crystal Cox, Faye
9 McConnell, and Debbie and Edith Luksa; to his nephew, Douglas
