RESOLUTION

1 WHEREAS, The year 2007 marks the 20th anniversary of the 2 establishment of the Political Asylum Project of Austin; and

WHEREAS, In 1987 many Central Americans fled war and unrest in their home countries and sought safety in the United States; PAPA was founded to help provide legal assistance to those refugees entering Texas; and

WHEREAS, Through the years PAPA has broadened its reach to offer free and low-cost legal services and education to immigrants, refugees, and asylum seekers from 75 countries around the world; while most of its clients still hail from Central America, in recent years PAPA has aided over 1,500 men, women, and children a year from such diverse locales as Afghanistan, Bangladesh, China, the Czech Republic, England, Ethiopia, Germany, India, Iran, Jamaica, Kenya, South Korea, Liberia, Nigeria, the Philippines, Tunisia, Turkey, and Vietnam; and

WHEREAS, PAPA's several programs are tailored to meet the individual needs and concerns of its clients; the Asylum Seeker Assistance Program, the Program Representing Immigrant Survivors of Abuse, and the Family Based Immigration, Adjustment, and Citizenship Program provide legal counsel to immigrants and asylum seekers in particular situations; the Immigrant Victims of Crime Protection Project promotes and enforces the use of the Trafficking and Violence Protection Act of 2000, and the Detention Education and Representation Program conducts know-your-rights presentations

1 to immigrants detained by the Department of Homeland Security; and

WHEREAS, PAPA's excellent website offers links to such resources as the Lutheran Immigration and Refugee Service and the United States citizenship and immigration services; there are links as well to foreign embassies and resources for victims of violence,

and the organization is also active in immigration reform; and

WHEREAS, Having grown from only two employees in 1987 to almost 10 in recent years, the center employs three full-time attorneys; it was recognized in 2002 by the Austin Chronicle with a Best of Austin award for its legal services, and in 2006, PAPA received the Community Service Award from the Hispanic Issues Section of the State Bar of Texas for its leadership and contributions to the Hispanic community; and

WHEREAS, Through its high-quality legal representation and committed advocacy, the Political Asylum Project of Austin has offered hope for a new life to thousands of men, women, and children from all over the globe and made Central Texas a safer place in which to live for immigrants and their families; now, therefore, be it

RESOLVED, That the House of Representatives of the 80th Texas Legislature hereby congratulate the Political Asylum Project of Austin on its 20th anniversary and offer its hard-working and committed staff best wishes for continued success; and, be it further
