1 WHEREAS, Pastor R. L. Simmons, Jr., and his wife, Deborah
2 Simmons, are being honored by the members of Crossroads Cathedral
3 Church in Missouri City on March 16, 2007, during a banquet themed
4 "The Labor of Love Celebration"; and

5 WHEREAS, Since its founding by Pastor and Mrs. Simmons in
6 1997, Crossroads Cathedral has become a vital community resource, a
7 warm, spirit-filled haven where all are encouraged to discover
8 their individual gifts and share them with their fellow
9 congregants; the church supports a number of programs, including
10 ministries devoted to youth, women, men, music, media,
11 transportation, and a food pantry; and

12 WHEREAS, Pastor Simmons attended Texas Tech University and
13 served his country as a member of the United States Army; since
14 2005, he has been enrolled in the College of Biblical Studies in
15 Houston, where he is completing coursework in theology and divinity
16 programs; and

17 WHEREAS, After accepting the call to the ministry as a
18 youngster, Ray Simmons preached his first sermon at the Evangelist
19 Temple Church of God in Christ in Houston and received his
20 minister's license in 1986; a past district expeditor for the
21 Sunnyside District of the Texas South Central Jurisdiction Church
22 of God in Christ, and guest evangelist for a countywide youth
23 crusade in Brazoria, Pastor Simmons was ordained an elder, with
24 highest honors, in the Church of God in Christ, Inc., in 1997; and

1 WHEREAS, Active in community affairs, this esteemed
2 clergyman has been elected to the Alief ISD board of trustees; he is
3 vice president of the Huntington Village Patio Homes Neighborhood
4 Civic Association board, and trustee on the Houston-Galveston Area
5 Council board; in addition, he is liaison pastor for the Briargate
6 Elementary School, adopted by his church, and he received a
7 Community Service Award for outstanding leadership and service to
8 the school, the wider community, and the Greater Houston
9 metropolitan area; and

10 WHEREAS, In all his endeavors, Pastor Simmons enjoys the
11 support of his devoted wife and the couple's two children; Mrs.
12 Simmons has been a tireless partner to her husband in his ministry,
13 graciously sharing her time and talents in behalf of myriad church
14 activities; and

15 WHEREAS, Pastor R. L. and Deborah Simmons are a blessing in
16 the lives of countless Texans, and they truly deserve special
17 recognition for their commitment to their church and community;
18 now, therefore, be it

21 Simmons on their exemplary service to the congregation of
