- 1 WHEREAS, Family and friends across the Lone Star State and
- 2 nationwide are mourning the passing on March 15, 2007, of the
- 3 prominent civic leader and volunteer, Martha Barnes Weisend of
- 4 Dallas; and
- 5 WHEREAS, Born in Ripley, Tennessee, on September 15, 1931,
- 6 Mrs. Weisend was the daughter of John William and Ruby Cunningham
- 7 Barnes; after graduating from Ripley High School, she began working
- 8 as an accountant for the Wesson Oil and Snowdrift Company in
- 9 Memphis, while furthering her education as a business student at
- 10 Memphis State University; and
- 11 WHEREAS, She moved to Dallas in 1958, and on September 5,
- 12 1965, she married Dallas businessman C. Frederick "Fritz" Weisend;
- 13 and
- 14 WHEREAS, Mrs. Weisend was active with the Republican Party
- from an early age; she volunteered for the Eisenhower presidential
- 16 campaigns in 1952 and 1956, and again for the campaign of Barry
- 17 Goldwater in 1964; she learned the art of political participation
- 18 from the ground up, by walking door to door for the candidates and
- 19 causes she believed in; and
- WHEREAS, Her commitment and passion continued to find
- 21 expression in countless political campaigns at the local, state,
- 22 and national levels; in 1978 she was the Texas State Chairman for
- 23 the gubernatorial campaign of Bill Clements, playing an
- 24 instrumental role in electing the first Republican governor in

- 1 Texas in 100 years, and she was Governor Clements' state chairman
- 2 again during his successful reelection campaign; and
- 3 WHEREAS, She continued to participate politically by serving
- 4 as Texas State Chairman for both Reagan-Bush campaigns in the
- 5 1980s, as well as serving as Vice Chair of the Dallas County
- 6 Republican Party and as cochair of the Republican Host Committee
- 7 for the 1984 Republican National Convention in Dallas; in recent
- 8 years she continued her hard work, raising over \$1 million for the
- 9 Bush-Cheney campaigns; and
- 10 WHEREAS, Mrs. Weisend was equally passionate about her
- 11 service to her community; a member of many corporate and civic
- 12 association boards, she was a founder of the Dallas Blue
- 13 Foundation, which provides assistance to the families of Dallas
- 14 police officers who have been killed or disabled in the line of
- 15 duty; as president and executive director of the foundation for
- 16 over 15 years, she devoted her considerable expertise as a
- 17 fundraiser to permanently funding the foundation's endowment,
- 18 helping to raise \$14 million since 1992; and
- 19 WHEREAS, Martha Barnes Weisend will long be remembered by all
- 20 who knew her for her boundless energy, her quiet authority, and her
- 21 tireless political participation, and she leaves a legacy of
- 22 service and achievement that will continue to benefit her community
- 23 for years to come; now, therefore, be it
- 24 RESOLVED, That the House of Representatives of the 80th Texas
- 25 Legislature hereby honor the memory of Martha Barnes Weisend and
- 26 extend sincere condolences to her family: to her daughter, Melissa
- 27 Ann Weisend; to her stepsons, Kerry Weisend and Michael Weisend; to
