WHEREAS, In addition to his work with the city council, Mr. Chambers served on the Zoning Board of Adjustment, the Parks and Recreation Board, and the Planning and Zoning Commission for the City of Bedford; in his leisure time he enjoyed attending local events and was a member of the Mid-Cities Optimist Club, Hurst Masonic Lodge, and the Hurst Amateur Radio Club; and
