- 9 Drywall; two years later, on December 1, 1979, he married Barbara
- 10 Scott, and together they shared many happy times and became the
- 11 parents of four children; and
- 12 WHEREAS, Drawn to public service, Mr. Lester joined the
- 13 Lubbock Fire Department in 1980; during his 26-year tenure, he
- 14 specialized in heavy rescue and served that organization in several
- 15 capacities, earning the rank of lieutenant; and
- WHEREAS, This esteemed public servant was honored in 1985 by
- 17 the Lubbock City Council and the citizens of Lubbock for
- 18 firefighting, rescue, and unselfish acts; in 2005, the community
- 19 named him its Firefighter of the Year and presented him with a
- 20 certificate of merit; and
- 21 WHEREAS, Mr. Lester enjoyed membership in a number of groups,
- 22 including the Lubbock Soccer Association, the Lubbock High School
- 23 Rodeo Association, the National Intercollegiate Rodeo Association,
- 24 the Lubbock Saddle Club, Professional Bull Riders, and FFA; he was

- also active with the Red Bud Lions Club, the Monterey Booster Club,

- 10 he leaves behind memories that will be forever treasured by all
- 11 those who were privileged to know him; now, therefore, be it
