WHEREAS, Following his return to civilian life in 1946, Mr. Carlisle began a career in the insurance business, eventually becoming president of Carlisle Insurance Agency; his years of civic service to his community included tenures on the city council, as a charter member of the Jim Wells County Master Planners Association, and as president of the Alice Chamber of Commerce, which honored him in 1988 with induction into its Hall of Honor; and

WHEREAS, Mr. Carlisle was first elected mayor of Alice in 1959, and he held the office until 1967; throughout his distinguished service, he was instrumental in the development of the city and set a sterling example of leadership that is still resonant today; and
