- 9 Ethics in Business Award from the Metropolitan Lubbock Rotary Club
- 10 in 1990; he has further been honored by the Texas Independent

- 13 with his wife, Mae, who passed away in 2001; their marriage was
- 14 blessed with many happy times and cherished memories, as well as
