RESOLUTION

1 WHEREAS, Greater Mt. Zion Missionary Baptist Church in 2 Houston is celebrating its 112th anniversary on April 22, 2007; and 3 WHEREAS, Based in the Houston Heights neighborhood since its inception, the church was organized in 1895 by the Reverend L. W. 4 5 Williams in the home of Mr. and Mrs. John H. Grant; within three 6 years of its founding, the congregation held its first revival, which was conducted by the prominent Houston minister and civic 7 leader Jack Yates; and 8

9 WHEREAS, The first structure erected by members of the church 10 was a brush arbor; with the passage of time, the congregation bought 11 two lots and constructed a simple building; seven more lots were 12 subsequently purchased, and in 1961 the present sanctuary was 13 erected; since that time, more property has been acquired and many 14 improvements to the physical fabric of the church have continued to 15 be made; and

WHEREAS, Throughout its history, Greater Mt. Zion has been 16 blessed with dynamic spiritual leadership; those who have guided 17 the congregation include Reverend Reed, Reverend Ramsey, and the 18 Reverends G. R. Alford, E. D. Carrington, C. J. Rigmaiden, A. L. 19 Cain, Ralph D. West, Lugene Spurlock, Jr., Julius Glass, and 20 21 Derrick L. Joseph; it was during the pastorate of Reverend 22 Carrington that the name of the congregation was changed from Mt. 23 Zion Baptist to Greater Mt. Zion Missionary Baptist; and

24 WHEREAS, Today, Greater Mt. Zion is ably led by the Reverend

Gaidi Burgess, who was installed as pastor on December 18, 2005; since Reverend Burgess assumed the pulpit of this historic church, its membership has continued to grow and new ministries have been added; the slogan "The Church Where We Love God and Each Other" has been selected by Reverend Burgess as the congregation's present theme; and

7 WHEREAS, Sustained by a common purpose, warm fellowship, and 8 inspired teaching, the members of Greater Mt. Zion Missionary 9 Baptist Church have remained constant in their devotion and witness 10 to their faith, and it is a pleasure to join in recognizing this 11 joyous occasion in the life of their church; now, therefore, be it
