1 WHEREAS, El Paso attorney Mark C. Walker is listed in *The Best*
2 *Lawyers in America* for 2006 in recognition of his outstanding work

18 the Disciplinary Review Committee for the State Bar of Texas;
19 recently selected as a commission member for the Texas Board of
20 Legal Specialization, he is also involved with the American Board
21 of Trial Advocates, Association of Defense Trial Attorneys, Defense
22 Research Institute, and Texas Association of Defense Counsel; and

24 his community; he is a member of the board of the Greater El Paso

1 Chamber of Commerce, chair of the El Paso Museum of Art Advisory
2 Board, and event chair of Kidfish El Paso; a member of the
3 Borderland Mobility Coalition and El Paso Sunturians, he has served
4 as president of El Paso Texas Exes and as a director of the Insights
5 El Paso Science Museum; and

7 dedication, and he may reflect with pride on his accomplished
8 career, as well as this recent achievement; now, therefore, be it
