1 WHEREAS, Phil Diebel, the vice president for finance and 2 business affairs at the University of North Texas, begins a new 3 chapter of his life with his retirement on August 31, 2007, after 26 4 years of outstanding service to the school; and

5 WHEREAS, Following his graduation from The University of 6 Texas at Austin in 1971 with a bachelor's degree in business 7 management, Mr. Diebel worked for the Texas Comptroller of Public 8 Accounts and the Texas Department of Human Services; and

WHEREAS, He became a certified public accountant in 1980 and 9 joined the University of North Texas as its controller the 10 11 following year; promoted to vice president in 1983, Mr. Diebel was 12 named vice chancellor for finance of the UNT System in 2001; as the 13 school's chief financial officer, this accomplished professional 14 has successfully overseen the university's finances during a period of remarkable growth, with enrollment nearly doubling over the 15 course of his tenure; and 16

WHEREAS, Mr. Diebel has also served higher education 17 throughout the State of Texas with his leadership on the boards and 18 committees of several organizations, including the Texas Higher 19 Education Coordinating Board and the Texas Guaranteed Student Loan 20 21 Corporation; he has further distinguished himself as president of 22 the Texas Association of State Senior College and University Business Officers, and he has actively participated in the Texas 23 24 International Education Consortium, the Southern Association of

3 WHEREAS, Mr. Diebel's dedication extends to his community as 4 well, with his membership on the Denton Salvation Army Advisory 5 Board, the Denton Regional Medical Center Advisory Board, and the 6 United Way of Denton County Governing Board; he has likewise been an 7 active supporter of Denton's cultural life, serving on the 8 governing boards of North Texas Public Broadcasting and the Denton 9 Community Theater; and

10 WHEREAS, For more than a quarter-century, Phil Diebel has 11 contributed great skill and commitment to the University of North 12 Texas, and through his myriad endeavors, he has made an invaluable 13 contribution to higher education in the Lone Star State; now, 14 therefore, be it

15 RESOLVED, That the House of Representatives of the 80th Texas 16 Legislature hereby congratulate Phil Diebel on his retirement from 17 the University of North Texas and extend to him best wishes for a 18 very happy and rewarding retirement; and, be it further

19 RESOLVED, That an official copy of this resolution be 20 prepared for Mr. Diebel as an expression of high regard by the Texas 21 House of Representatives.
