- 2 2007 Outstanding Disabled Veteran of the Year by the Disabled

- WHEREAS, Mr. Stanley joined the United States Army in October
- 5 1942; after attending boot camp and AIT training for military
- 6 police at Concho Field in San Angelo, he was reassigned to Kerns,
- 7 Utah, and went on to serve at Camp Stoneman, California, before
- 8 being deployed to the Pacific Theater; and
- 9 WHEREAS, In December 1944, Mr. Stanley was seriously injured
- 10 while loading a B-24 bomber; his wounds required extensive surgery,
- 11 and in 1945 he was honorably discharged from the army with a
- 12 service-connected disability; and
- WHEREAS, Returning home to the Lone Star State, this esteemed
- 14 Texan was fortunate to meet boot maker M. L. Leddy, who offered him
- 15 an apprenticeship; after five years of learning the trade, Mr.
- 16 Stanley opened his own boot store in Bronte, and through the years
- 17 he earned a reputation that reflected the priority he placed on
- 18 superior craftsmanship and quality; and
- WHEREAS, Mr. Stanley has been a valued member of the Disabled
- 20 American Veterans since 1974; he has held a number of leadership
- 21 positions with the Jesse D. Booth Chapter 7 in San Angelo, serving
- 22 as sergeant of arms, adjutant, first vice, commander, and currently
- 23 as a member of the executive committee; moreover, he has
- 24 volunteered countless hours to deliver shoes to individuals in

- 1 need, and his cheerful attitude and sharp wit have done much to lift
- 2 the spirits of the many men and women he has visited; and
- 3 WHEREAS, In all of his endeavors, Mr. Stanley has been
- 4 blessed with the love and unyielding support of his wife of more
- 5 than six decades, Lu Ella Baker Stanley; and
- 6 WHEREAS, To work for the benefit of those who have heeded this
- 7 nation's call to arms is truly a noble cause, and Robert Stanley has
- 8 distinguished himself both as a fine soldier and as a generous and
- 9 committed citizen; now, therefore, be it
- 10 RESOLVED, That the House of Representatives of the 80th Texas
- 11 Legislature hereby congratulate Robert L. Stanley on being named
- 12 the 2007 Outstanding Disabled Veteran of the Year by the Disabled
