2 the Houston Metropolitan Paralegal Association as its 2006
3 Paralegal of the Year; and

4 WHEREAS, A 1990 graduate of Cornell University, Pat Flores
5 has been a paralegal in the litigation section of Locke Liddell &
6 Sapp since 1997; during the course of her career, she has not only
7 rendered exemplary service in her professional capacity but also
8 contributed extensively to the community through her work with
9 local organizations; and

10 WHEREAS, Her outstanding record of volunteerism includes
11 assisting with the legal help line established by the
12 Mexican-American Bar Association for Spanish-speaking callers and
13 working with the Adopt-a-School Program of the Houston Bar
14 Association, through which she tutored and helped with a project to
15 beautify Northwood Middle School; and

16 WHEREAS, Ms. Flores has also volunteered with the American
17 Red Cross as a citizenship instructor teaching U.S. history and
18 government; she serves as an election judge in her precinct and
19 teaches a fifth-grade CCE class at Sacred Heart Co-Cathedral; and

20 WHEREAS, Admired for her civic engagement and effective
21 leadership, Ms. Flores has received appointment to a number of
22 boards, including that of the HMPA, during which time she chaired
23 its community service committee; she currently serves on the board
24 of the Cornell Alumni Association of Greater Houston and chairs

2 WHEREAS, Previous accolades bestowed on Ms. Flores include
3 the Excellence Award of the Hispanic Bar Association for her
4 service to an HBA program for prospective law students, a Volunteer
5 Service Award from the American Red Cross, and the Commitment to
6 Leadership Award from Project Blueprint of the United Way of the
7 Texas Gulf Coast; and

8 WHEREAS, Through her myriad volunteer efforts, Patricia
9 Flores has sought to expand opportunities for others and assist
10 those in need, and her selfless endeavors have enriched her
11 community in immeasurable ways; now, therefore, be it
